**JOINT RESOLUTION RECOGNIZING APRIL 2022 AS  
SEXUAL ASSAULT AWARENESS MONTH**

WHEREAS, sexual violence affects women, children and men of all racial, cultural and economic backgrounds; and

WHEREAS, in addition to the immediate physical and emotional costs, sexual violence may also have associated consequences of post-traumatic stress disorder, substance abuse, depression, eating disorders, homelessness and suicide; and

WHEREAS, sexual violence can be devastating not only for the victim, but also for the family, friends and community of the victim; and

WHEREAS, Maine communities bear the substantial fiscal costs related to sexual violence, such as lost work time and increased health care costs, thereby increasing the need for prevention and awareness; and

WHEREAS, no one person, organization, agency or community can eliminate sexual violence on its own, but we can work together to educate our entire population about how we can all prevent sexual violence and support victims and their communities; and

WHEREAS, sexual harassment, assault and abuse happen in all communities, including online spaces, and there is a need to create online spaces that are built on the foundational values of practicing consent, keeping children safe and supporting survivors; and

WHEREAS, Sexual Assault Awareness Month is a time to draw attention to the prevalence of sexual assault and provides an excellent opportunity for citizens of Maine to learn more about preventing sexual violence; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirtieth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize April 2022 as Sexual Assault Awareness Month and to express our support for and encouragement of all those affected by sexual violence; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Maine Coalition Against Sexual Assault as a token of our respect and support.

Representative **GRAMLICH**: Thank you, Mr. Speaker. Mr. Speaker, Colleagues of the House, I rise today to present this joint resolution recognizing April as Sexual Assault Awareness Month. Observed as an opportunity to promote education and the prevention of sexual violence, Sexual Assault Awareness Month traces its history to the 1970s, when activists first began organizing on a national scale to reduce sexual assault and violence against women. Advocates fought tirelessly to bring a topic once taboo for public discussion out of the shadows and shed light on the widespread problem of sexual assault. I would like to share a few data points which illustrates the importance of recognizing this important topic. In the United States, 21% of women and 2.6% of men have experience rape. However, this still amounts to a significant figure, with over three million men reporting a rape during their lifetime, with men experiencing rape at one-tenth the rate of women. More than half of women who are raped report that their perpetrator was an intimate partner. In fact, Mr. Speaker, rape frequently happens between partners. Child sexual abuse, which is also sexual assault, is a significant but preventable adverse childhood experience and public health problem. Although estimates vary across studies, the data shows that about one in four girls and one in 13 boys experienced child sexual abuse at some point in their childhood. Ninety-one percent of child sexual abuse is perpetrated by someone the child or child's family knows.

Sexual assault has financial costs as well. The estimated lifetime financial loss due to rape is \$122,461 per victim. The total lifetime economic burden of child sexual abuse in the United States was estimated to be at least \$9.3 billion in 2015. This includes medical costs, the loss of productivity, criminal justice costs and other associated losses. However, these economic costs are likely to be an underestimate of the true impact of this problem since sexual assault is often underreported. Having an open conversation about issues like sexual violence can help reduce the shame and stigma felt by survivors and encourage them to seek support and community assistance. We can learn more about how to prevent sexual assault and domestic violence and ways to support survivors by reviewing resources compiled by the Sexual Violence Resource Center. If you or someone you know needs help regarding sexual assault, you can contact the Maine Coalition Against Sexual Assault for free and private support 24 hours a day, seven days a week. Thank you, Mr. Speaker, for the opportunity to raise awareness about this important, sensitive and pervasive issue.

Her own design and professional experience started in Boston but she came back to Camden and, influenced by her grandmother, Margo and working alongside her own mom, Marcy, for 11 years, she took over as the president and is running the store. Fifty years is a long time. Some of us in this chamber haven't even been alive for 50 years. It's truly wonderful when we can celebrate a third-generation family-owned and women-operated business and I just wanted to lift them up. WHEREAS, cystic fibrosis, commonly referred to as "CF," is a genetic disease affecting over 31,000 children and adults in the United States and over 70,000 children and adults worldwide; and

WHEREAS, a defective gene known as CFTR causes the body to produce an abnormally thick, sticky mucus that clogs the lungs, and these secretions produce life-threatening

lung infections and obstruct the pancreas, preventing digestive enzymes from reaching the intestines to help break down and absorb food; and

WHEREAS, more than 10 million Americans are symptomless carriers of the defective CFTR gene; and

WHEREAS, the median predicted age of survival for a person with CF is 50 years; and

WHEREAS, the number of adults with CF has steadily grown, and approximately 700 new cases of CF are diagnosed each year; and

WHEREAS, 57 percent of the CF population is 18 years of age and older, and people with CF have a variety of symptoms attributed to the more than 2,000 variants in the CFTR gene; and

WHEREAS, infant blood screening to detect genetic defects is the most reliable and least costly method to identify persons likely to have CF; and

WHEREAS, early diagnosis of CF permits early treatment and enhances quality of life and longevity, and the treatment of CF depends on the stage of the disease and the organs involved; and

WHEREAS, clearing mucus from the lungs is an important part of the daily CF treatment regimen, and other types of treatments include inhaled antibiotics and pancreatic enzymes, among others; and

WHEREAS, there are 3 world-class treatment centers in this State that specialize in the diagnosis of CF and the care of persons with CF; and

WHEREAS, a critical component of treating patients with CF is access to innovative treatments that can play a crucial role in the lives of patients with CF; and

I don't say this flippantly, I say this very seriously, I actually have been celebrating the last two weeks. Two weeks ago I finally came off the obesity BMI column, so, I'm very happy about that. Often, I have stood up here and I have tried to explain that bills that have come before us from Health and Human Services that the department is already working on. Again, this is something that I believe is a priority for the Health and Human Services Department and the Department of Education. Good nutrition is one of the best gifts you can give your children and yourself. Research shows that children who are well-nourished do better in school, get sick less often and are less prone to behavior problems. The Maine CDC WIC nutrition program is committed to helping families reap these benefits. Every WIC appointment includes nutrition education to help parents and caregivers make the best possible decisions about feeding the next generation of Mainers. The Maine Department of Education oversees several USDA food and nutrition service programs and initiatives that provide healthy food to children. Each of these programs help fight hunger and obesity. These are the programs: afterschool snack service, the breakfast program, child and adult care food program, culinary classroom, farm and sea to school, that's my personal favorite, fresh fruit and vegetable program, the lunch program, summer food program, seamless summer option food distribution program. On top of all of that, the Department of Education Professional Standards Training Database lists more than 500 free or low-cost training opportunities for school nutrition professionals. The obesity levels are plateauing. I looked at a lot of data. And, thankfully for Maine, they are plateauing and hopefully soon we will see that they are going down. This bill spends \$1.4 million on an issue that is already clearly being emphasized as a priority with the Maine CDC and the Department of Education. Thank you.

And that is the portion, for those familiar with the bill, that deal with ownership or control in whole or in part of a public utility by a foreign government, a government corporation, or the subsidiary of a foreign corporation, etcetera. So, what is left with this amendment is simply an act to clarify the net benefit standard for utility reorganizations and that would be the title of the bill if we adopt this amendment. It would simply clarify that because net benefits are what is required of a utility reorganization that the specific verbiage that the PUC needs to follow regarding whether it will result in a rate increase or a loss of control are phrased in the positive. Since we've adopted a net benefit standard, those sections would simply be clarified to be lower rates rather than a rate increase, greater local control rather than a loss of local control and, in addition, the part that adds identifiable long-term as modifiers to the phrase net benefits would also remain in the bill. So, I hope that that helps to remove a concern that evidently existed for some Members of this Body and that we can proceed with that simple clarification to our net benefit standard for utility reorganizations. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Auburn, Representative Libby.

Representative **LIBBY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. It is a very rare day when the Christian Civic League of Maine and the ACLU both object to a bill. Today, the stars have aligned and I find myself in agreement with both entities. Enshrined in our Constitution is the right to peacefully express ourselves in public. This bill seeks to limit that right to free speech and even goes so far as to expand the criminal code to enforce the proposed medical safety zone by creating a new Class E crime. As the ACLU stated in their testimony; as we have done consistently for the past decade, the ACLU of Maine urges policymakers not to expand the criminal code and to reexamine their reliance on the criminal legal system to solve society's problems. At times like this, when people increasingly fear for their safety while seeking health care to which they are constitutionally entitled, we do not take this position lightly. We urge legislators to look at the larger picture of how our reliance on the criminal legal system has created a system of mass incarceration. Every year, approximately 14,000 people cycle through Maine's jails and on any given day, 1,820 people are locked up there. Jails have been a hotspot for COVID-19, endangering the lives of people who are detained there despite not having been convicted of a crime. Criminal records are almost always permanent in Maine and even a Class E on a person's record can keep someone from housing or employment. And the racial disparities are stark. In 2018, black people made up only 1% of Maine's population but were 5% of the people arrested. It's no secret that I believe the practice of abortion is morally repugnant, but this bill doesn't affect a woman's right to procure an abortion. It does, however, impact one's right to free speech and it creates a new Class E crime. Please follow my light and vote against the pending motion.

The **SPEAKER**: The Chair recognizes the Representative from Skowhegan, Representative Poirier.

Representative **POIRIER**: Thank you, Mr. Speaker. I rise today because I cannot support this but maybe for some different reasons than you might think me to rise. I'm not actually opposed to having a buffer zone. I think everybody deserves dignity to receive whatever services they feel they need to have. The reason why I'm opposed is this bill actually mandates the municipality to have the financial burden of paying for the boundaries proposed here. And actually the current ways of having people penalized for harassment or trespass when they are causing issues, per se, in this kind of scenario, are already Class C and D crimes. So, this bill actually lessens the crimes. I don't see that this is a positive effect on what we're trying to do here, to give people dignity. So, I would ask you to follow me and oppose this current motion. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Harpswell, Representative McCreight.

Representative **MC CREIGHT**: Thank you, Mr. Speaker. Mr. Speaker, Women and Men of the House, this bill protects peoples' right of access to health care while also protecting the right of free speech and protest. It will give us the important

tool needed to prevent intentional and knowing obstruction of those seeking care, whether it's reproductive health care or any health care that someone else may not like. This is needed to prevent others from jeopardizing the health of persons attempting to receive health care at their chosen health care facility. By providing the option for a health care facility to have a medical safety zone, patients will be able to enter and exit safely and the facility will be able to operate without intentional interference to delivery of care. Specifically, this bill provides an eight-foot semicircle, marked out from the center of the doorway of a facility, that is off-limits to anyone other than patients, staff, approved volunteers, law enforcement or safety personnel. Protest actions outside of the safety zone are not in any way restricted or prohibited by this bill. The medical safety zone must be clearly marked, probably it would be a painted line or temporary barriers. The zone if adopted would only be in effect during the hours of operation of the facility. In addition to addressing the intentional physical blocking of someone attempting to enter or exit a health care facility, the bill also addresses other specific actions that interfere with access that have happened in Maine. Specifically, these are making noise so loud that a patient and facility staff and providers can't hear each other within the building, activating a device or exposing a substance that releases noxious and offensive odors within the building, making or causing repeated phone calls to a person within the building with the intent of impeding access to a person's or building's telephone lines or that other disrupt persons or building's activities. The bill establishes that a person can be charged with a Class E crime if they intentionally and knowingly block access to a health care facility if the actions continue after an official warning. This is the same level available to law enforcement for trespassing. In Maine, judges have considerable discretion when handing down a sentence. Judges can order one or more of the following sentencing options if someone is charged with a Class E crime; incarceration, suspended or split term of incarceration with administrative release with conditions such as restitution and community service, deferred disposition requiring certain conditions be met prior to that disposition, or fines, fees, restitution, or community service or unconditional discharge. Again, discretion.

I don't think any of us take addition of a crime seriously, I'm sorry, the opposite; we don't take addition of a crime lightly, nor should we intentionally obstruct access to care at a health care facility. We need effective tools to protect that access. Currently, we only have a civil remedy, which has not proven effective. A person is not deterred from simply repeating the same intentional blocking of access after they've been told to stop by current policy and law. We will better be able to protect access and deter intentional interference with access to health care through adoption of this bill. Again, supporting this policy will protect rights to speech, protest and access to health care. Thank you, Mr. Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Auburn, Representative Bickford.

Representative **BICKFORD**: Thank you, Mr. Speaker. May I pose a question through the Chair?

The **SPEAKER**: The Member may proceed.

Representative **BICKFORD**: It's two questions, actually. Health care facilities, are they not private property? And, if they are, can't they as owners of private property enact their own policies that can be enforced?

My other question is; isn't harassment already illegal? Such as disturbing the peace? Thank you.

The SPEAKER: The Representative from Auburn, Representative Bickford, has posed a question through the Chair to anyone who wishes to answer it. The Chair recognizes the Representative from Gardiner, Representative Harnett.

Representative **HARNETT**: Thank you, Mr. Speaker. As to the first question, which I can answer; yes, facilities are generally privately owned but the sidewalks in front of them and the entryways might about public property.

The SPEAKER: The Chair recognizes the Representative from Canaan, Representative Stetkis.

Representative **STETKIS**: Thank you, Mr. Speaker. I'd like to ask a question through the Chair.

The SPEAKER: The Member may proceed.
