### An Act To Promote Industrial Hemp

---

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 7 MRSA §2231**, as enacted by PL 2009, c. 320, §1, is amended to read:

3 **§2231. Industrial hemp**

4 **1. Definition.** As used in this chapter, unless the context otherwise indicates,  
5 "industrial hemp" means any variety of Cannabis sativa L. with a delta-9-  
6 tetrahydrocannabinol concentration that does not exceed 0.3% on a dry weight basis and  
7 that is grown or possessed by a licensed grower in compliance with this chapter.

8 **2. Growing permitted.** Notwithstanding any other provision of law, a person may  
9 plant, grow, harvest, possess, process, sell and buy industrial hemp if that person holds a  
10 license issued pursuant to subsection 4. A person licensed pursuant to subsection 4 may  
11 plant, grow and harvest only hemp that is grown from seeds acquired from an approved  
12 Canadian producer of hemp seeds. A person licensed pursuant to subsection 4 may  
13 acquire hemp seeds directly from a producer in Canada or from a hemp seed distributor  
14 licensed in this State distributing hemp seeds pursuant to subsection 2-A.

15 **2-A. Seed distribution.** The commissioner may issue a license for a hemp seed  
16 distributor if the hemp seeds distributed by the hemp seed distributor are from an  
17 approved Canadian producer of hemp seeds that ensures that the hemp cultivated by a  
18 grower has a concentration of no more than 0.3% delta-9-tetrahydrocannabinol by dry  
19 weight. The commissioner may issue a license under this subsection to a holder of a seed  
20 labeling license pursuant to section 1044-A.

21 **3. Application.** A person desiring to grow industrial hemp for commercial purposes  
22 shall apply to the commissioner for a license on a form prescribed by the commissioner.  
23 The application must include the name and address of the applicant, the legal description  
24 of the land area to be used for the production of industrial hemp and a map, an aerial  
25 photograph or global positioning coordinates sufficient for locating the production fields.  
26 ~~Except for employees of the Maine Agricultural Experiment Station and the University of~~  
27 ~~Maine System involved in research and related activities, an applicant for an initial~~  
28 ~~licensure must submit a set of the applicant's fingerprints, taken by a law enforcement~~  
29 ~~officer, and any other information necessary to complete a statewide and nationwide~~  
30 ~~criminal history record check by the Department of Public Safety, State Bureau of~~  
31 ~~Identification and the Federal Bureau of Investigation. All costs associated with the~~  
32 ~~criminal history record check are the responsibility of the applicant and must be~~  
33 ~~submitted with the fingerprints. Criminal history records provided to the commissioner~~  
34 ~~under this section are confidential. The results of criminal records checks received under~~  
35 ~~this subsection may only be used in determining an applicant's eligibility for licensure. A~~  
36 ~~person with a prior criminal conviction is not eligible for licensure.~~

37 **4. License issued.** Upon review and approval of an application, the commissioner  
38 shall notify the applicant and request that the application fee determined under subsection  
39 7 be submitted. Upon receipt of the appropriate fee ~~and in accordance with subsection 8,~~  
40 the commissioner shall issue a license, which is valid for a period of one year and only  
41 for the site or sites specified in the license.

1           ~~**5. Documentation.** A licensee shall file with the commissioner documentation~~  
2 ~~indicating that the seeds planted were of a type and variety of hemp approved by the~~  
3 ~~commissioner as having a concentration of no more than 0.3% delta 9-~~  
4 ~~tetrahydrocannabinol by dry weight and a copy of any contract to grow industrial hemp.~~  
5 ~~A licensee shall notify the commissioner of the sale or distribution of industrial hemp~~  
6 ~~grown by the licensee and the name of each person to whom the industrial hemp was sold~~  
7 ~~or distributed.~~

8           ~~**6. Rules.** The commissioner shall adopt rules to establish approved varieties of~~  
9 ~~industrial hemp, protocols for testing plant parts during growth for delta 9-~~  
10 ~~tetrahydrocannabinol levels an application fee, a license fee and guidelines for monitoring~~  
11 ~~the growth and harvest of industrial hemp. Rules adopted pursuant to this subsection are~~  
12 ~~major substantive rules as defined in Title 5, chapter 375, subchapter 2-A.~~

13           ~~**7. Fees.** The commissioner shall establish through rulemaking under subsection 6 an~~  
14 ~~application fee, and a license fee and per acre fees for monitoring, sampling and testing~~  
15 ~~that are reasonable and necessary to cover the costs of the department.~~

16 All fees received pursuant to this subsection must be paid to the Treasurer of State and  
17 credited to a separate, nonlapsing account in the department. Money received pursuant to  
18 this subsection must be used for the expenses of administering this chapter.

19           ~~**8. Licensing contingent upon action by Federal Government.** A license may not~~  
20 ~~be issued under this section unless:~~

21           ~~A. The United States Congress excludes industrial hemp from the definition of~~  
22 ~~"marihuana" for the purpose of the Controlled Substances Act, 21 United States~~  
23 ~~Code, Section 802(16); or~~

24           ~~B. The United States Department of Justice, Drug Enforcement Administration takes~~  
25 ~~affirmative steps towards issuing a permit under 21 United States Code, Chapter 13,~~  
26 ~~Subchapter 1, Part C to a person holding a license issued by a state to grow industrial~~  
27 ~~hemp.~~

28 ~~The commissioner shall notify the Revisor of Statutes and the Commissioner of Public~~  
29 ~~Safety when the requirements of either paragraph A or B have been met.~~

30           ~~**Sec. 2. Appropriations and allocations.** The following appropriations and~~

24 **SUMMARY**

25 This bill removes the requirements that an applicant for an initial license to grow  
26 industrial hemp for commercial purposes must submit a set of the applicant's fingerprints  
27 and file with the Commissioner of Agriculture, Conservation and Forestry documentation  
28 indicating that the seeds planted were a type and variety of hemp approved by the  
29 commissioner and also repeals the provision that licensure is contingent upon action by  
30 the Federal Government.

31 The bill requires that any hemp seeds acquired for cultivation of hemp in the State  
32 must come from an approved Canadian producer of hemp seeds. It allows the  
33 Commissioner of Agriculture, Conservation and Forestry to issue licenses for hemp seed  
34 distribution to holders of seed labeling licenses. It also allows hemp growers licensed by  
35 the State to acquire hemp seeds directly from a producer in Canada or from a state-  
36 licensed hemp seed distributor. It requires that application fees and license fees must be  
37 established by major substantive rules. It includes an appropriations and allocations  
38 section.
