An Act To Amend Teacher Evaluation Requirements

1 Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 20-A MRSA §13704, sub-§1, ¶A, as enacted by PL 2011, c. 635, Pt. A, §3, is amended to read: 3 4 A. The department shall provide, by rule, a set of standards of professional practice or a set of criteria for determining acceptable locally determined standards for 5 teachers and a set of standards of professional practice or a set of criteria for 6 7 determining acceptable locally determined standards for principals; Sec. 2. 20-A MRSA §13704, sub-§1, ¶B is enacted to read: 8 9 B. The rules adopted pursuant to paragraph A may include, but may not require, the use of student learning and growth measures or state assessment results as a measure 10 of educator effectiveness; 11 Sec. 3. 20-A MRSA §13704, sub-§2, as enacted by PL 2011, c. 635, Pt. A, §3, is 12 amended to read: 13 14 2. Multiple measures of effectiveness. Multiple measures of educator effectiveness, other than standards of professional practice, including but not limited to 15 the use of student learning and growth data to inform instruction; 16 Sec. 4. 20-A MRSA §13704, sub-§3, ¶A, as amended by PL 2015, c. 3, §1, is 17 further amended to read: 18 A. The rating must be based on standards of professional practice and measures of 19 educator effectiveness. The proportionate weight of the standards and the measures 20 21 is a local decision, but measurements of student learning and growth must be a significant factor in the determination of the rating of an educator. School 22 administrative units shall use state assessment growth data for English language arts, 23 literacy and mathematics as at least one measure of the performance of English 24 language arts and mathematics teachers in tested grades and as a measure for the 25 performance of principals. 26 27 An educator whose summative effectiveness rating indicates ineffectiveness must receive an annual summative effectiveness evaluation and rating until the rating 28 29 improves. 30 An individualized education plan may not be used to measure student growth for the purposes of teacher and principal evaluation, but an individualized education plan 31 may be a source of evidence from which learning objectives and learning targets may 32 33 be developed. Sec. 5. 20-A MRSA §13706, as amended by PL 2015, c. 3, §2, is further amended 34 35 to read: 36 §13706. Rules 37 The department shall adopt rules to implement this chapter, including but not limited to a rule relating to the method of identifying the educator or educators whose 38

effectiveness ratings are affected by the measurement of learning or growth of a particular student. The department shall also adopt rules pertaining to the approval of performance evaluation and professional growth systems pursuant to section 13702. The department shall also adopt rules pertaining to the ongoing monitoring of the implementation and results of district performance evaluation and professional growth systems. Rules adopted pursuant to this section are major substantive rules pursuant to Title 5, chapter 375, subchapter 2-A.

8 Sec. 6. Rulemaking. In accordance with the Maine Revised Statutes, Title 20-A, 9 sections 13704 and 13706, the Department of Education shall amend the department's 10 rule Chapter 180: Performance Evaluation and Professional Growth Systems to 11 implement the provisions of this Act and shall submit the provisionally adopted rule to 12 the Legislature by January 10, 2020.

## SUMMARY

This bill clarifies that the use of student learning and growth data to inform instruction is included as part of the multiple measures of educator effectiveness. The bill also requires the Department of Education to submit a provisionally adopted rule to the Legislature by January 10, 2020.
