1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §3173-G** is enacted to read:

3 **§3173-G. Medicaid coverage for reproductive health care and family planning**  
4 **services**

5 The department shall provide for the delivery of federally approved Medicaid  
6 services to a qualified adult or adolescent when the adult's or adolescent's individual  
7 income is equal to or below 209% of the nonfarm income official poverty line for  
8 reproductive health care and family planning services, including pregnancy prevention,  
9 testing and treatment for sexually transmitted infection or cancer and access to  
10 contraception, in accordance with the federal Patient Protection and Affordable Care Act,  
11 Public Law 111-148, as amended by the federal Health Care and Education  
12 Reconciliation Act of 2010, Public Law 111-152.

13 **Sec. 2. Medicaid state plan amendment.** The Department of Health and  
14 Human Services shall prepare and submit a Medicaid state plan amendment to the United  
15 States Department of Health and Human Services, Centers for Medicare and Medicaid  
16 Services that, effective October 1, 2015, provides Medicaid coverage for reproductive  
17 health care and family planning services for adults and adolescents who have individual  
18 incomes less than or equal to 209% of the nonfarm income official poverty line, as  
19 defined by the federal Department of Health and Human Services and updated annually  
20 in the Federal Register under authority of 42 United States Code, Section 9902(2), and  
21 who are not otherwise eligible for Medicaid.

22 **Sec. 3. Contingent effective date.** That section of this Act that enacts the Maine  
23 Revised Statutes, Title 22, section 3173-G takes effect only if:

24 1. The Commissioner of Health and Human Services receives written approval of the  
25 state plan amendment submitted in accordance with section 2 from the United States  
26 Department of Health and Human Services, Centers for Medicare and Medicaid Services;  
27 and

28 2. The Commissioner of Health and Human Services notifies the Secretary of State,  
29 the Secretary of the Senate, the Clerk of the House of Representatives and the Revisor of  
30 Statutes that written approval of the state plan amendment has been received.

31 **SUMMARY**

32 This bill expands Medicaid coverage for reproductive health care and family planning  
33 services to adults and adolescents who have individual incomes less than or equal to  
34 209% of the nonfarm income official poverty line as defined in accordance with federal  
35 law, which is the same Medicaid coverage level as for pregnant women.
