1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §6671, sub-§3**, as amended by PL 2007, c. 494, §1, is further
3 amended to read:

4 **3. Shellfish conservation ordinance.** The following provisions govern a shellfish
5 conservation ordinance.

6 A. Within any area of the municipality, a shellfish conservation ordinance may:

7 (1) Regulate or prohibit the possession of shellfish;

8 (2) Fix the amount of shellfish that may be taken;

9 (3) Provide for protection from shellfish predators;

10 (4) Authorize the municipal officials to open and close flats under specified
11 conditions; ~~and~~

12 (5) Specify areas of the intertidal zone in which the dragging of mussels may be
13 limited to the degree necessary to support a municipal shellfish conservation
14 program; and

15 (6) In accordance with paragraph D, designate shellfish conservation areas where
16 harvesting any marine organism is prohibited.

17 B. An ordinance must limit the size of soft-shell clams in accordance with article 5.

18 C. Except as provided in section 6621, subsection 3, paragraph C, a program or
19 ordinance may not allow surveying, sampling or harvesting of shellfish in areas
20 closed by regulation of the commissioner.

21 D. A municipality may designate a shellfish conservation area where harvesting any
22 marine organism is prohibited only when the conservation area surrounds protective
23 netting, fencing, traps or other gear placed by the municipality in the intertidal zone
24 to enhance the shellfish resource and provide protection from shellfish predators
25 pursuant to subsection 10-B. A designated conservation area where harvesting any
26 marine organism is prohibited must be clearly marked with signs that identify the
27 municipality that has designated the area and indicate the purpose of the area.

32 (1) For the first offense by a commercial license holder, a fine of not less than

35 than \$500 and not more than \$1,500;

3 (5) For an offense by a person who does not hold a municipal shellfish license, a
4 fine of not less than \$500 and not more than \$1,500; or

5 **SUMMARY**

6 This bill allows a municipality to designate in its municipal shellfish conservation
7 ordinance conservation areas that surround protective netting, fencing, traps or other gear
8 placed by the municipality in the intertidal zone where harvesting any marine organism is
9 prohibited. The designated conservation area must be clearly marked with signs that
10 identify the municipality that designated the area and indicate the purpose of the
11 designated area. Current law imposes certain fines upon municipal shellfish license
12 holders who harvest shellfish from an area closed for conservation purposes. This bill
13 amends that provision to impose certain fines on municipal shellfish license holders and
14 nonlicense holders who harvest any marine organism from an area closed pursuant to a
15 municipal shellfish conservation ordinance.
