2 **Sec. 1. 12 MRSA §10902, sub-§6, ¶E**, as enacted by PL 2003, c. 414, Pt. A, §2
3 and affected by c. 614, §9, is amended to read:

4 E. Buying or selling bear, hunting or trapping bear after having killed ~~one~~ 2 or
5 exceeding the bag limit on bear, in violation of section 11217 ~~or~~ 11351 or 12260;

6 **Sec. 2. 12 MRSA §11251, sub-§1, ¶B**, as enacted by PL 2003, c. 414, Pt. A, §2
7 and affected by c. 614, §9, is amended to read:

8 B. There is an open season on using a dog or dogs in conjunction with bear hunting
9 from the ~~first~~ 2nd Monday preceding September 1st to the 7th day preceding the open
10 firearm season on deer provided in sections 11401 and 11402.

25 after that person has killed or registered one during ~~any~~ an open season under section

36 Washington County and Hancock County that are situated south of Route 9.
