1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 20-A MRSA §4723, as enacted by PL 1983, c. 859, Pt. C. §§5 and 7, is
amended to read:

4 §4723. Health and physical education

5 The secondary course of study shall must include instruction in health, safety and physical education, as prescribed by the commissioner, and physiology and hygiene, with 6 special reference to the effects of alcoholic drinks, stimulants and narcotics upon the 7 The secondary course of study must also include instruction on human system. 8 affirmative consent, communication and decision making regarding sexual activity and 9 10 the effects of alcoholic drinks, stimulants and narcotics on the ability to give affirmative consent, communicate and make appropriate decisions. For purposes of this section, 11 "affirmative consent" means consent to sexual activity that can be revoked at any time 12 and does not include silence, lack of resistance or consent given while intoxicated. 13

14 Sec. 2. 20-A MRSA §6209, sub-§4, as amended by PL 2015, c. 489, §6, is 15 further amended to read:

4. Review cycle. The commissioner shall conduct a review of the content standards 16 and performance indicators by content area on a 5-year cycle beginning in the 2015-2016 17 school year. The review of the content standards and performance indicators for the 18 content area of social studies, including student achievement of proficiency in personal 19 finance, must be included in the commissioner's review during the 2015-2016 school 20 year. Any changes that are recommended must be approved through the same process 21 used for establishment of the system of learning results. Beginning in the 2016-2017 22 school year, the commissioner shall review and make recommendations for objective 23 24 measures that may be used to substantiate school certifications of postsecondary readiness. The review of the content standards and performance indicators for the content 25 area of health, physical education and wellness, including instruction on affirmative 26 consent, communication and decision making regarding sexual activity and the effects of 27 alcoholic drinks, stimulants and narcotics on the ability to give affirmative consent, 28 29 communicate and make appropriate decisions, must be included in the commissioner's review beginning in the 2019-2020 school year. 30

SUMMARY

This bill requires the Commissioner of Education to review the content standards and 32 performance indicators for the content area of health, physical education and wellness, 33 including instruction on affirmative consent, communication and decision making 34 regarding sexual activity and the effects of alcoholic drinks, stimulants and narcotics on 35 the ability to give affirmative consent, communicate and make appropriate decisions, 36 37 beginning in the 2019-2020 school year as part of the commissioner's 5-year review cycle of the content standards and performance indicators required under the system of learning 38 39 results.
