1 **Be it enacted by the People of the State of Maine as follows:**

2 **PART A**

3 **Sec. A-1. 22 MRSA §2426, sub-§2, ¶A**, as enacted by IB 2009, c. 1, §5, is
4 amended to read:

5 A. A government medical assistance program or private health insurer, except as
6 provided in Title 24-A, sections 2717-B, 2829-B and 4320-L, to reimburse a person
7 for costs associated with the medical use of marijuana; or

8 **Sec. A-2. 24 MRSA §2317-B, sub-§6-A** is enacted to read:

9 **6-A. Title 24-A, sections 2717-B, 2829-B and 4320-L.** Coverage for marijuana for
10 medical use, Title 24-A, sections 2717-B, 2829-B and 4320-L;

11 **Sec. A-3. 24-A MRSA §2717-B** is enacted to read:

12 **§2717-B. Coverage for marijuana for medical use**

13 An insurer that provides benefits for accidental injury or disability in this State shall
14 provide coverage for marijuana for medical use for an insured in accordance with this
15 section.

16 **1. Certification required.** An insurer shall provide coverage to an insured who has
17 received certification for the medical use of marijuana from a medical provider under
18 Title 22, section 2423-B.

19 **2. Reimbursement for out-of-pocket costs.** An insurer shall directly reimburse an
20 insured for the documented out-of-pocket costs:

21 A. Associated with obtaining certification from a medical provider authorized under
22 Title 22, chapter 558-C, including any office visits with that medical provider, subject
23 to any applicable copayment, coinsurance, deductible or other cost-sharing
24 requirements under an insured's policy; and

25 B. To purchase and use marijuana for medical use in accordance with the
26 certification from the medical provider under paragraph A.

27 **Sec. A-4. 24-A MRSA §2829-B** is enacted to read:

28 **§2829-B. Coverage for marijuana for medical use**

29 An insurer that provides benefits for accidental injury or disability in this State shall
30 provide coverage for marijuana for medical use for an insured in accordance with this
31 section.

32 **1. Certification required.** An insurer shall provide coverage to an insured who has
33 received certification for the medical use of marijuana from a medical provider under
34 Title 22, section 2423-B.
