2 §1 is amended to read:

3           **Sec. 1. Study of existing infrastructure and future capacity needs west of**  
4 **Route 1 in York and Cumberland counties. Resolved:** That the Department of  
5 Transportation, or “the department,” and the Maine Turnpike Authority, or “the  
6 authority,” shall conduct a study of existing highway infrastructure and future capacity  
7 needs west of Route 1 in York and Cumberland counties, including the greater Gorham  
8 and Sanford areas and the area west of Sanford along the United States Route 202  
9 corridor to the New Hampshire border. The purpose of this study is to develop a series of  
10 recommendations to enhance, expand and preserve highway connections between Route  
11 1 and the Maine Turnpike and communities in western Cumberland County and York  
12 County. In conducting the study, the department and the authority shall review existing  
13 and potential new routes from the Maine Turnpike to municipal centers in western  
14 Cumberland County and York County that, in the determination of the department and  
15 the authority, would, if constructed, significantly decrease congestion on state and local  
16 roads in the area and improve access from communities in western Cumberland County  
17 and York County to the Maine Turnpike. The study must be designed and conducted in a  
18 manner that will allow the results to be used during future state and federal permitting of  
19 any proposal that may proceed to construction, and any potential project must be  
20 compatible with state transportation policy in accordance with Maine's Sensible  
21 Transportation Policy Act and the federal National Environmental Policy Act. In  
22 evaluating and prioritizing strategies for study, the department and the authority shall  
23 consider, at a minimum, the following factors:

24           1. The feasibility of expanding the existing highway infrastructure to accommodate  
25 future traffic and economic demands of the region;

26           2. The role of transit and other alternative modes of transportation in managing the  
27 transportation demand in the region;

28           3. The feasibility and effectiveness of the new proposed transportation infrastructure  
29 strategies to meet the future traffic and economic needs, including:

30           A. The traffic impact of the new infrastructure on the existing road network;

31           B. Environmental impacts;

32           C. Traffic toll revenue projections on any new infrastructure and the effects on toll  
33 revenues on the existing turnpike; and

34           D. Construction and maintenance costs;

35           4. Coordinating with area communities and regional planning agencies to evaluate  
36 land use impacts of all strategies studied, and developing recommendations to  
37 communities for land use controls to protect their community character, economic vitality  
38 and future investments in the transportation system; and

39           5. Any other factors determined relevant by the department and the authority; and be

**SUMMARY**

This bill expands the scope of the study of existing highway infrastructure and future capacity needs west of Route 1 in York and Cumberland counties, including the greater Gorham and Sanford areas, which is being conducted by the Department of Transportation and the Maine Turnpike Authority, to include the area west of Sanford along the United States Route 202 corridor to the New Hampshire border. It also requires the Department of Transportation and the Maine Turnpike Authority to report the results of their study to the Joint Standing Committee on Transportation no later than December 7, 2011 and allows the committee to submit a bill to the Second Regular Session of the 125th Legislature upon its receipt and review of the report.
