1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 28-A MRSA §2051, sub-§5**, as enacted by PL 2003, c. 452, Pt. P, §4 and
3 affected by Pt. X, §2, is amended to read:

4 **5. Exceptions.** A minor is not in violation of ~~subsection 1, paragraph E-1 or F-1 if~~
5 ~~the minor possesses:~~

6 A. ~~Liquor~~ Subsection 1, paragraph E-1 or F-1 if the minor possesses liquor or
7 imitation liquor or equipment described in subsection 1, paragraph F-1 in the scope of
8 the minor's employment;

9 B. ~~Liquor~~ Subsection 1, paragraph E-1 or F-1 if the minor possesses liquor or
10 imitation liquor in a home in the presence of the minor's parent, guardian or
11 custodian, as defined in Title 22, section 4002; or

12 C. ~~Equipment~~ Subsection 1, paragraph E-1 or F-1 if the minor possesses equipment
13 described in subsection 1, paragraph F-1 in the minor's own home under the
14 supervision of the minor's parent, guardian or custodian, as defined in Title 22,
15 section 4002-; or

16 D. Subsection 1, paragraph A, B, C or E-1 if the minor is a member or veteran of the
17 United States Armed Forces or state military forces as described in Title 37-B,
18 section 102 on the premises of a veterans' organization eligible to receive a beano or
19 bingo license under Title 17, section 314.

20 **Sec. 2. 28-A MRSA §2081, sub-§2**, as amended by PL 2003, c. 452, Pt. P, §9
21 and affected by Pt. X, §2, is further amended to read:

22 **2. Exceptions.** This section does not apply to a person who serves liquor or
23 imitation liquor to a minor in a home in the presence of the minor's parent, guardian or
24 custodian, as defined in Title 22, section 4002, or, if the minor is a member or veteran of
25 the United States Armed Forces or state military forces as described in Title 37-B, section
26 102, on the premises of a veterans' organization eligible to receive a beano or bingo
27 license under Title 17, section 314.

28 **SUMMARY**

29 This bill allows a person who is at least 18 years of age but under 21 years of age
30 who is a member or veteran of the United States Armed Forces or state military forces to
31 be served and consume alcohol on the premises of a veterans' organization founded,
32 chartered or organized in the State that is eligible to receive a beano or bingo license from
33 the Chief of the State Police.
