**An Act to Provide Funding for Winter Emergency Energy Relief
and to Finalize the COVID Pandemic Relief Payment Program**

unappropriated surplus of the General Fund to the Maine State Housing Authority, Housing Authority - State, Other Special Revenue Funds account for assistance for households that are not eligible for federal Low Income Home Energy Assistance Program, or LIHEAP, benefits or households eligible for LIHEAP benefits that have already exhausted their energy assistance benefit and Maine State Housing Authority Energy Crisis Intervention Program amount. Households may be eligible for up to \$800 in emergency funds to avert an energy crisis. Before October 31, 2023, any unobligated amounts remaining from this transfer must be transferred to the unappropriated surplus of the General Fund.

Sec. A-3. Transfer from General Fund unappropriated surplus; Emergency Housing Relief Fund. Notwithstanding any provision of law to the contrary, on or before June 30, 2023, the State Controller shall transfer \$21,000,000 from the unappropriated surplus of the General Fund to the Maine State Housing Authority, Emergency Housing Relief Fund Program, Other Special Revenue Funds account to provide funds for short-term emergency housing. The Maine State Housing Authority shall prioritize these funds for use in addressing emergency housing needs occurring between December 1, 2022 and April 30, 2023, for those households that were experiencing homelessness or housing instability in the State prior to December 1, 2022. At the close of fiscal year 2022-23, unobligated amounts remaining from this transfer must be transferred to the unappropriated surplus of the General Fund.

Sec. A-4. Appropriations and allocations. The following appropriations and allocations are made.

23 **Sec. B-1. Winter Energy Relief Payment Program Fund Other Special**
 24 **Revenue Funds account established.** The State Controller shall establish within the
 25 Department of Administrative and Financial Services the nonlapsing Winter Energy Relief
 26 Payment Program Fund Other Special Revenue Funds account, which is funded through a
 27 transfer from the available balance of the unappropriated surplus of the General Fund
 28 pursuant to section 2.

29 **Sec. B-2. Transfer from General Fund unappropriated surplus; Winter**
 30 **Energy Relief Payment Program Fund.** Notwithstanding any provision of law to the
 31 contrary, on or before December 31, 2022, the State Controller shall transfer \$398,000,000
 32 from the unappropriated surplus of the General Fund to the Department of Administrative
 33 and Financial Services, Winter Energy Relief Payment Program Fund Other Special
 34 Revenue Funds account for the purpose of providing payments to help eligible recipients
 35 of the State pay for high winter energy costs and recover from the economic effects of the
 36 pandemic related to coronavirus disease 2019, referred to in this Part as "the COVID-19
 37 pandemic." At the close of fiscal year 2023-24, amounts remaining in the Winter Energy
 38 Relief Payment Program Fund Other Special Revenue Funds account must be transferred
 39 to the unappropriated surplus of the General Fund.

40 **Sec. B-3. Winter Energy Relief Payment Program established.** Because the
 41 State has determined that residents of the State face high winter energy costs and the effects
 42 of the ongoing COVID-19 pandemic and this warrants assistance from the State, the Winter
 43 Energy Relief Payment Program is established within the Department of Administrative
 44 and Financial Services to promote the general welfare by providing a relief payment to

1 eligible Maine recipients to offset some of the expenses that have been incurred, and will
2 be incurred in the winter months of 2022-2023, by those recipients as a result of high winter
3 energy costs and the COVID-19 pandemic, including, without limitation, personal, family
4 and living expenses.

5 **1. Definitions.** As used in this section, unless the context otherwise indicates, the
6 following terms have the following meanings.

7 A. "Assessor" means the State Tax Assessor.

8 B. "Eligible recipient" means an individual who:

9 (1) Filed, by October 31, 2022, a Maine income tax return as a full-year resident
10 of the State for the tax year;

11 (2) Had, and reported to the Department of Administrative and Financial Services,
12 Maine Revenue Services by October 31, 2022 on an income tax return, federal
13 adjusted gross income for the tax year of less than:

14 (a) For individuals filing married joint returns or surviving spouses permitted
15 to file a joint return, \$200,000;

16 (b) For an individual filing as a head of household, \$150,000;

17 (c) For a single individual, \$100,000; or

18 (d) For a married individual filing a separate return, \$100,000; and

19 (3) May not be claimed as a dependent on another taxpayer's return for the tax year.

20 C. "Fund" means the Winter Energy Relief Payment Program Fund Other Special
21 Revenue Funds account established by the State Controller pursuant to section 1.

22 D. "Relief payment" means a relief payment in the amount of \$450.

23 E. "Tax year" means a tax year beginning on or after January 1, 2021 but not later than
24 December 31, 2021.

25 Any other terms used in this section have the same meanings as when used in a comparable
26 context in the Maine Revised Statutes, Title 36, Part 8 relating to Maine income taxes,
27 unless different meanings are clearly required.

28 **2. Winter energy relief payment.** The assessor shall make relief payments in
29 accordance with this subsection.

30 A. The assessor shall identify each eligible recipient.

31 B. Beginning as soon as administratively feasible but not later than March 31, 2023,
32 the assessor shall make a relief payment to each eligible recipient. Funds for the relief
33 payments must come from the fund and, notwithstanding any law to the contrary, are
34 not subject to setoff to debts owed to agencies of the State.

35 C. An individual who has not received a relief payment under paragraph B may provide
36 documentation to the assessor by June 30, 2023 showing that the individual is an
37 eligible recipient. The assessor shall review the documentation, determine if the
38 individual is an eligible recipient and notify the individual of any adverse
39 determination. This determination is final agency action not reviewable pursuant to the
40 Maine Revised Statutes, Title 36, section 151.

41 D. By September 30, 2023, the assessor shall make a relief payment to each eligible
42 recipient determined eligible pursuant to paragraph C. Funds for the relief payments

1 must come from the fund and, notwithstanding any law to the contrary, are not subject
2 to setoff to debts owed to agencies of the State.

3 **Sec. B-4. State income tax subtraction modification.** For tax years beginning
4 on or after January 1, 2023 but not later than December 31, 2023, in determining the taxable
5 income of an individual, within the meaning of the Maine Revised Statutes, Title 36,
6 section 5122, federal adjusted gross income must be reduced by an amount equal to the
7 relief payment received by the taxpayer pursuant to this Part, to the extent the payment is
8 included in federal adjusted gross income for the taxable year.

9 **Sec. B-5. Designation as unclaimed property.** For purposes of the Winter
10 Energy Relief Payment Program, relief payment checks that remain undeposited on March
11 31, 2024 are to be treated as unclaimed property, not subject to the notice and receipt
12 provisions established in the Maine Revised Statutes, Title 33, section 2101 and the one-
13 year dormancy period specified in Title 33, section 2061, as applied to such checks. The
14 Treasurer of State shall use unclaimed property systems and networks to find the proper
15 recipients of such checks as quickly as possible.

16 **Sec. B-6. Transfer between Winter Energy Relief Payment Program Fund
17 Other Special Revenue Funds account and COVID Pandemic Relief Payment
18 Program Fund Other Special Revenue Funds account.** Notwithstanding any
19 provision of law to the contrary, on or before June 30, 2024, the State Controller may
20 transfer the available balance within the Department of Administrative and Financial
21 Services, COVID Pandemic Relief Payment Program Fund Other Special Revenue Funds
22 account to the Department of Administrative and Financial Services, Winter Energy Relief
23 Payment Program Fund Other Special Revenue Funds account. Amounts transferred may
24 be expended based on allotment established by financial order recommended by the State
25 Budget Officer and approved by the Governor.

26 **Sec. B-7. Appropriations and allocations.** The following appropriations and
27 allocations are made.

28 **ADMINISTRATIVE AND FINANCIAL SERVICES, DEPARTMENT OF**
29 **Winter Energy Relief Payment Program N960**

30 Initiative: Provides one-time funding for a disaster relief program that will provide a \$450
31 relief payment to each eligible recipient. The costs of administration, programming,
32 mailing, public outreach and taxpayer assistance must also come from this fund.

40 **Sec. C-1. Transfer between COVID Disaster Relief Payment Fund Other
41 Special Revenue Funds account and COVID Pandemic Relief Payment
42 Program Fund Other Special Revenue Funds account.** Notwithstanding any
43 provision of law to the contrary, on or before June 30, 2023, the State Controller shall

1 transfer \$385,754 from the available balance within the Department of Administrative and
2 Financial Services, COVID Disaster Relief Payment Fund Other Special Revenue Funds
3 account to the Department of Administrative and Financial Services, COVID Pandemic
4 Relief Payment Program Fund Other Special Revenue Funds account in order to support
5 the higher than estimated number of eligible recipients. Funds are available based on lower
6 than estimated COVID disaster relief payments, as authorized in Public Law 2021, chapter
7 398, Part HHHH and expended in fiscal year 2021-22.

8 **Sec. C-2. Transfer between Homestead Property Tax Exemption**
9 **Reimbursement, Other Special Revenue Funds account and COVID Pandemic**
10 **Relief Payment Program Fund Other Special Revenue Funds account.**

11 Notwithstanding any provision of law to the contrary, on or before June 30, 2023, the State
12 Controller shall transfer \$6,674,993 from the available balance within the Department of
13 Administrative and Financial Services, Homestead Property Tax Exemption
14 Reimbursement, Other Special Revenue Funds account to the Department of
15 Administrative and Financial Services, COVID Pandemic Relief Payment Program Fund
16 Other Special Revenue Funds account in order to support the higher than estimated number
17 of eligible recipients. Funds are available based on lower than estimated homestead
18 reimbursements in fiscal year 2021-22 and fiscal year 2022-23.

19 **Sec. C-3. Transfer from General Fund unappropriated surplus; COVID**
20 **Pandemic Relief Payment Program Fund Other Special Revenue Funds**
21 **account.**

22 Notwithstanding any provision of law to the contrary, on or before June 30,
23 2023, the State Controller shall transfer \$4,433,437 from the unappropriated surplus of the
24 General Fund to the Department of Administrative and Financial Services, COVID
25 Pandemic Relief Payment Program Fund Other Special Revenue Funds account to support
the higher than estimated number of eligible recipients.

26 **Sec. C-4. Transfer between COVID Pandemic Relief Payment Program**
27 **Fund Other Special Revenue Funds account and Winter Energy Relief**
28 **Payment Program Fund Other Special Revenue Funds account.**

29 Notwithstanding any provision of law to the contrary, on or before June 30, 2024, the State
30 Controller may transfer the available balance within the Department of Administrative and
31 Financial Services, Winter Energy Relief Payment Program Fund Other Special Revenue
32 Funds account to the Department of Administrative and Financial Services, COVID
33 Pandemic Relief Payment Program Fund Other Special Revenue Funds account. Amounts
34 transferred may be expended based on allotment established by financial order
35 recommended by the State Budget Officer and approved by the Governor.

17 **Sec. E-1. 38 MRSA §603-A, sub-§7-A** is enacted to read:

18 **7-A. Emergency variance.** The commissioner, without hearing, may suspend any of
 19 the sulfur content requirements of subsection 2 if the commissioner finds that the expected
 20 availability of fuel that complies with those requirements is inadequate to meet the needs
 21 of residential, commercial or industrial users in this State and that such expected
 22 unavailability constitutes an immediate threat to public health, safety or the general
 23 welfare. The commissioner shall specify in writing the period during which the suspension
 24 is in effect.

25 **PART F**

26 **Sec. F-1. Suspension of transfers to Maine Budget Stabilization Fund.**

27 Notwithstanding any provision of law to the contrary, the requirement in the Maine Revised
 28 Statutes, Title 5, section 1535 that certain baseline General Fund revenue and other
 29 available budgeted General Fund resources that exceed the General Fund appropriation
 30 limit be transferred to the Maine Budget Stabilization Fund is suspended for the duration
 31 of fiscal year 2022-23.

32 **Emergency clause.** In view of the emergency cited in the preamble, this legislation
 33 takes effect when approved.

34 **SUMMARY**

35 This bill provides relief to certain Maine households to assist them with high costs for
 36 home heating.

37 Part A transfers funds totaling \$71,000,000 from the unappropriated surplus of the
 38 General Fund to the Maine State Housing Authority no later than June 30, 2023. Of this
 39 amount, \$40,000,000 is allocated for heating assistance to households in the State eligible
 40 for the federal Low Income Home Energy Assistance Program, \$10,000,000 is allocated as
 41 emergency funds to households to avert an energy crisis and \$21,000,000 is allocated for

1 emergency housing to prevent people from experiencing homelessness during the 2022-
2 2023 winter months.

3 Part B establishes the Winter Energy Relief Payment Program and transfers funds on
4 a one-time basis totaling \$398,000,000 from the unappropriated surplus of the General
5 Fund to the newly created Winter Energy Relief Payment Program Fund Other Special
6 Revenue Funds account no later than December 31, 2022 to fund the program. The
7 program provides relief payments of \$450 to individuals who filed a Maine income tax
8 return as of October 31, 2022 and who had income less than: \$200,000, if filing as an
9 individual filing a married joint return or a surviving spouse permitted to file a joint return;
10 \$150,000, if filing as a head of household; or \$100,000, if filing as a single individual or as
11 a married individual filing a separate return.

12 The State Tax Assessor is required to identify eligible recipients and make relief
13 payments to those individuals no later than March 31, 2023. A process is specified to allow
14 individuals who are eligible but who have not received a relief payment to document
15 eligibility to the State Tax Assessor. The relief payment is not considered income for
16 Maine income tax purposes.

17 Part C transfers \$4,433,437 from the unappropriated surplus of the General Fund to the
18 COVID Pandemic Relief Payment Program no later than June 30, 2023. Part C also
19 transfers \$385,754 from the COVID Disaster Relief Payment Fund Other Special Revenue
20 Funds account and \$6,674,993 from the Homestead Property Tax Exemption
21 Reimbursement, Other Special Revenue Funds account to the COVID Pandemic Relief
22 Payment Program. Part C provides the COVID Pandemic Relief Payment Program with an
23 Other Special Revenue Funds allocation of \$11,494,184 in fiscal year 2022-23 to complete
24 the \$850 pandemic relief payment to each eligible resident of the State as authorized in
25 Public Law 2021, chapter 635, Part L.

26 Part D includes General Fund deappropriations to the Department of Health and
27 Human Services of \$156,752,586 in fiscal year 2022-23 to adjust funding for the 6.2%
28 increase in the Federal Medical Assistance Percentage based on the extension of the
29 national public health emergency related to the COVID-19 pandemic for the first, 2nd and
30 3rd quarter of fiscal year 2022-23. This adjustment also deallocates \$4,154,555 from the
31 Fund for a Healthy Maine in fiscal year 2022-23. The offsets for these deappropriations
32 and deallocations are Federal Expenditures Fund allocations of \$158,965,759 and Federal
33 Block Grant Fund allocations of \$1,941,382 in fiscal year 2022-23.

34 Part E allows the Commissioner of Environmental Protection to suspend the sulfur
35 content requirements for liquid and solid fossil fuels if the commissioner finds that the
36 expected availability of fuel that complies with those requirements is inadequate to meet
37 the needs of residential, commercial or industrial users in this State and that such expected
38 unavailability constitutes an immediate threat to public health, safety or the general
39 welfare. The commissioner is required to specify in writing the period during which the
40 suspension is in effect.

41 Part F requires the temporary suspension of the provision of law that requires certain
42 General Fund revenue and resources that exceed the General Fund appropriation limit to
43 be transferred to the Maine Budget Stabilization Fund.

Fiscal Detail and Notes

Part A transfers funds totaling \$71.0 million from the unappropriated surplus of the General Fund to the Maine State Housing Authority no later than June 30, 2023. Of this amount, \$50.0 million is allocated for heating assistance to both Home Energy Assistance Program (HEAP) eligible and non-HEAP eligible households in the State and \$21.0 million is allocated for emergency housing and emergency shelters to prevent people from experiencing homelessness during the 2022-2023 winter months.

Part B establishes the Winter Energy Relief Payment Program and transfers funds on a one-time basis totaling \$398.0 million from the unappropriated surplus of the General Fund to the newly created Winter Energy Relief Payment Program, Other Special Revenue Funds account no later than December 31, 2022 to fund the program.

Part C transfers \$4,433,437 from the unappropriated surplus of the General Fund to the COVID Pandemic Relief Payment Program no later than June 30, 2023. Part C also transfers \$385,754 from the COVID Disaster Relief Payment, Other Special Revenue Funds account and \$6,674,993 from the Homestead Property Tax Exemption Reimbursement, Other Special Revenue Funds account to the COVID Pandemic Relief Payment Program. Part C provides the COVID Pandemic Relief Payment Program with an Other Special Revenue Funds allocation of \$11,494,184 in fiscal year 2022-23 to complete the \$850 disaster relief payment to each eligible resident of the State as authorized in Public Law 2021, chapter 635, Part L.

Part D includes General Fund deappropriations to the Department of Health and Human Services of \$156,752,586 in fiscal year 2022-23 to adjust funding for the 6.2% increase in the Federal Medical Assistance Percentage rate based on the extension of the national public health emergency related to the COVID-19 pandemic. This adjustment also deallocates \$4,154,555 from the Fund for a Healthy Maine in fiscal year 2022-23. The offset for these deappropriations and deallocations are Federal Expenditures Fund allocations of \$158,965,759 and Federal Block Grant Fund allocations of \$1,941,382 in fiscal year 2022-23.

Any additional costs to the Department of Environmental Protection and the Office of Treasurer of State as a result of the provisions of this bill are anticipated to be minor and can be absorbed within existing budgeted resources.
