A person who is 70 years of age or older may purchase a senior lifetime license that entitles the holder to all the privileges described in this paragraph for a one-time \$8 fee.

23 24 25 26	B. A nonresident who possesses a 15-day nonresident fishing license may exchange it for an annual nonresident license upon the additional payment of $\$12$, the difference between the fee for the 15-day license and the fee for the annual license, and $\$2$ to the clerk or issuing agent.
27	SUMMARY
28 29 30 31 32 33	This bill corrects an inconsistency in the fishing license laws resulting from recent fee increases. It clarifies the reporting requirements for agents in order to avoid delinquencies with seasonal agents, and it improves the privacy of Department of Inland Fisheries and Wildlife customers. This bill also allows a person who is eligible for a senior lifetime hunting and fishing license to obtain it at any time in the calendar year that person turns 70 years of age and makes it clear it includes all stamps, permits and other
