An Act To Amend the Laws Governing Local Share of Education Costs

(EMERGENCY)

Whereas,** acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and

3 **Whereas,** the proportional share reduction for school administrative units not 4 meeting their required local share of education funding is scheduled to be phased out in 5 fiscal year 2015-16; and

- 6 **Whereas,** this legislation extends the phase-out; and
- 7 **Whereas,** fiscal year 2015-16 begins July 1, 2015, which is likely before the 8 expiration of the 90-day period; and

9 **Whereas,** in the judgment of the Legislature, these facts create an emergency within 10 the meaning of the Constitution of Maine and require the following legislation as 11 immediately necessary for the preservation of the public peace, health and safety; now, 12 therefore,

- 13 Be it enacted by the People of the State of Maine as follows:
- Sec. 1. 20-A MRSA §15690, sub-§1, ¶D, as repealed and replaced by PL 2013,
 c. 171, §1, is amended to read:
- D. In any fiscal year in which the sum of the State's contribution toward the cost of 16 17 the components of essential programs and services, exclusive of federal funds that are provided and accounted for in the cost of the components of essential programs and 18 services, falls below the State's target of 55% of the cost of the components of 19 essential programs and services, the commissioner shall calculate the percentage of 20 21 the State's 55% share that is funded by state appropriations and, notwithstanding any other provision of this paragraph, a school administrative unit may not have the 22 amount of its state subsidy limited or reduced under paragraph C if the school 23 24 administrative unit:
- (1) In fiscal year 2013-14, raises at least the same percentage of its required local
 contribution to the total cost of funding public education from kindergarten to
 grade 12, including state-funded debt service, as the State's contribution toward
 its 55% share of the cost of the components of essential programs and services;
- (2) In fiscal year 2014-15, raises the same percentage of its required local contribution to the total cost of funding public education from kindergarten to grade 12, including state-funded debt service, as the State's contribution toward its 55% share of the cost of the components of essential programs and services plus 33% of the difference between that percentage and 100% of its required local contribution; and
- (3) In fiscal year 2015-16, raises the same percentage of its required local
 contribution to the total cost of funding public education from kindergarten to
 grade 12, including state-funded debt service, as the State's contribution toward
 its 55% share of the cost of the components of essential programs and services
 plus 66% 49.5% of the difference between that percentage and 100% of its
 required local contribution-:

1	(4) In fiscal year 2016-17, raises the same percentage of its required local
2	contribution to the total cost of funding public education from kindergarten to
3	grade 12, including state-funded debt service, as the State's contribution toward
4	its 55% share of the cost of the components of essential programs and services
5	plus 66% of the difference between that percentage and 100% of its required
6	local contribution; and
7	(5) In fiscal year 2017-18, raises the same percentage of its required local
8	contribution to the total cost of funding public education from kindergarten to
9	grade 12, including state-funded debt service, as the State's contribution toward
10	its 55% share of the cost of the components of essential programs and services
11	plus 82.5% of the difference between that percentage and 100% of its required
12	local contribution.
13	This paragraph is repealed June 30, 2016 2018.
14	Emergency clause. In view of the emergency cited in the preamble, this
15	legislation takes effect when approved.
16	SUMMARY
17	This bill extends the remaining phase-out of the proportional share reduction for
18	school administrative units not meeting their required local share of education funding
19	from one more year, ending in fiscal year 2015-16, to 3 more years, ending in fiscal year
20	2017-18.
