1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 5 MRSA §1742, sub-§25**, as amended by PL 2009, c. 1, Pt. CC, §1, is
3 further amended to read:

4 **25. Sites for child care programs.** To review, in cooperation with the Office of
5 Child Care Coordination in the Department of Health and Human Services, feasible sites
6 for child care programs offered primarily as a service to state employees pursuant to Title
7 22, section 8307, subsection 2; ~~and~~

8 **Sec. 2. 5 MRSA §1742, sub-§26**, as amended by PL 2009, c. 1, Pt. CC, §§2 and
9 3, is further amended to read:

10 **26. Rental income.** To credit income from the rental of facilities in Limestone to
11 the Department of Administrative and Financial Services, Bureau of General Services,
12 Other Special Revenue Funds account. These funds must be used for repairs, capital
13 improvements and other costs of managing the facilities operated by the Maine Military
14 Authority in Limestone.

15 Notwithstanding any other provision of law and except when the Governor in the case of
16 an emergency pursuant to Title 37-B, section 742 or 744 needs money for disaster relief
17 the Governor may transfer no more than 10% of the balance of the rental income, the
18 department also may recommend that:

19 A. Part of the rental income collected by the Department of Administrative and
20 Financial Services, Bureau of General Services pursuant to this subsection be
21 transferred to the General Fund as undedicated revenue;

22 B. Part of the rental income collected by the Department of Administrative and
23 Financial Services, Bureau of General Services pursuant to this subsection be
24 transferred to the Department of Defense, Veterans and Emergency Management,
25 Maine National Guard Education Assistance Pilot Program, Other Special Revenue
26 Funds account for tuition assistance;

27 C. Part of the rental income collected by the Department of Administrative and
28 Financial Services, Bureau of General Services pursuant to this subsection be
29 transferred to the Department of Defense, Veterans and Emergency Management,
30 Maine National Guard Education Assistance Pilot Program, Other Special Revenue
31 Funds account for the reimbursement of the purchase of supplemental life insurance
32 as provided for in the provisions of Title 37-B, section 390-B;

33 D. Beginning July 1, 2007, part of the rental income collected by the Department of
34 Administrative and Financial Services, Bureau of General Services pursuant to this
35 subsection be transferred to the Department of Defense, Veterans and Emergency
36 Management for maintenance and repair of National Guard armories in the State; and

37 E. Part of the rental income collected by the Department of Administrative and
38 Financial Services, Bureau of General Services pursuant to this subsection be
39 transferred to the Department of Defense, Veterans and Emergency Management,
40 Disaster Assistance Relief, Other Special Revenue Funds account for disaster
41 assistance-; and
