1 **Be it enacted by the People of the State of Maine as follows:**

2 **PART A**

3 **Sec. A-1. 22-A MRSA §208**, as enacted by PL 2007, c. 539, Pt. N, §47, is
4 amended to read:

5 **§208. Maintenance of one state psychiatric hospital**

6 The commissioner shall maintain 2 campuses of one state ~~mental health institutes~~
7 psychiatric hospital for the mentally ill, one campus at Bangor called the Dorothea Dix
8 Psychiatric Center and the other campus at Augusta called the Riverview Psychiatric
9 Center.

10 **Sec. A-2. 34-B MRSA §1001, sub-§8**, as amended by PL 2007, c. 539, Pt. N,
11 §57, is further amended to read:

12 **8. State institution; state psychiatric hospital.** "State institution" or "state
13 psychiatric hospital" means:

15 B. The state psychiatric hospital campus at the Dorothea Dix Psychiatric Center; or
16 D. Before October 1, 2008, the Elizabeth Levinson Center.

22 health services or an adult who has or had a major mental illness.

23 B. "Family member" means a relative, guardian or household member of an adult
24 consumer.

25 C. ~~"Institute Hospital council"~~ "Hospital council" means ~~an institute~~ the hospital council, ~~at either the~~
26 ~~Riverview Psychiatric Center or the Dorothea Dix Psychiatric Center,~~ at the state
27 psychiatric hospital approved by the commissioner pursuant to subsection 2,
28 paragraph B.

29 D. "Major mental illness" means a diagnosis of mental illness as defined in rules
30 adopted by the department. Rules adopted pursuant to this paragraph are routine
31 technical rules as defined by Title 5, chapter 375, subchapter 2-A.

32 E. "Network" means a community service network established pursuant to section
33 3608.

34 F. "Service provider" or "provider" means a person or organization providing
35 publicly funded mental health services to consumers or family members.

36 **2. Hospital council established.** ~~There are established institute councils, one for the~~
37 ~~Riverview Psychiatric Center and one for the Dorothea Dix Psychiatric Center,~~ is
38 established a hospital council at the state psychiatric hospital to evaluate the delivery of
39 mental health services and advise the department regarding quality assurance and

1 operations and functions of the ~~mental health institute~~ state psychiatric hospital. The
2 ~~councils operate~~ hospital council operates under the authority of the department.

3 A. ~~Each institute~~ The hospital council consists of no more than 25 members, taking
4 into consideration local geographic factors. The membership ~~on each institute~~
5 ~~council~~ consists of consumers, family members, community members, hospital staff
6 and providers. A resident or former resident of the Riverview Psychiatric Center or
7 the Dorothea Dix Psychiatric Center, a family member of a resident or former
8 resident, a community member in the Augusta or Bangor region and a service
9 provider at ~~those institutes~~ the hospital may make recommendations regarding
10 membership on the ~~institute councils~~ hospital council to the commissioner.

11 B. The ~~institute councils~~ hospital council shall adopt bylaws that establish
12 membership, the terms and qualifications of membership and the internal governance
13 and rules. The commissioner shall approve the bylaws of ~~each institute~~ the hospital
14 council ~~prior to designating it as an approved institute council~~.

15 **3. State psychiatric hospital council directors; responsibilities.** The
16 ~~superintendents~~ superintendent of the Riverview Psychiatric Center and the Dorothea Dix
17 Psychiatric Center are the state psychiatric hospital is responsible for the operation of the
18 ~~institute councils~~ hospital council and for dispute resolution ~~within those institute~~
19 ~~councils~~. ~~The superintendents shall receive reports from the institute councils, consider~~
20 ~~the recommendations of the institute councils and report periodically to the commissioner~~
21 ~~on their performance~~.

23 law, the ~~Riverview Psychiatric Center and the Dorothea Dix Psychiatric Center, referred~~

25 department shall provide information to the ~~institute councils adequate to perform their~~
26 ~~duties~~ hospital council, including, but not limited to:

27 A. Input into the annual budgets of the ~~mental health institutes~~ 2 campuses of the
28 state psychiatric hospital;

29 B. Achievement of the goals and objectives of the department as they pertain to the
30 ~~mental health institutes~~ state psychiatric hospital;

31 C. Compliance with all professional accreditation standards applicable to the ~~mental~~
32 ~~health institutes~~ state psychiatric hospital;

33 D. Review, oversight and assessment of services and programs provided to ~~residents~~
34 ~~of the mental health institutes~~ clients of the state psychiatric hospital and their
35 families;

36 E. Review of personnel policies and employment patterns, including staffing
37 requirements and patterns, the use of overtime assignments and training and job
38 development;

39 F. Input into public relations efforts of the department and the ~~mental health~~
40 ~~institutes~~ state psychiatric hospital and community education initiatives; and

41 G. Monitoring building and grounds maintenance and safety and risk management
42 on the campuses of the ~~mental health institutes~~ state psychiatric hospital.

17 shall inform the offender, prior to discharge or conditional release, of the duty to register.
18 If an offender does not serve a period of institutional confinement, the court shall inform
19 the offender at the time of sentencing of the duty to register. The department, county jail,
20 state ~~mental health institute~~ psychiatric hospital or court shall:

21 A. Inform the offender of the duty to register and obtain the information required for
22 the initial registration;

23 A-1. Inform the offender of the requirement to notify the law enforcement agency

20 It is the intent of the Legislature that the principles of the consent decree issued on
21 August 2, 1990 by the Superior Court, Kennebec County, in Civil Action Docket No. 89-
22 88 as they relate to the development of a comprehensive mental health system apply to all
23 persons with severe and prolonged mental illness. The individualized support plan
24 process as contained in the decree in paragraphs 49 through 74, to the extent possible and
25 within available resources, must be applicable to current and future patients of the former
26 Bangor Mental Health Institute and the state psychiatric hospital campus at the Dorothea
27 Dix Psychiatric Center. In addition, patient assessments must be provided to Bangor

4 **SUMMARY**

5 This bill combines the 2 state mental health institutes, now referred to as the state
6 psychiatric hospital, to be licensed and operated as one hospital under state law and
7 federal accreditation standards. The bill clarifies that there is one superintendent for the
8 one hospital, but that 2 campuses continue to be operated at the Riverview Psychiatric
9 Center and at the Dorothea Dix Psychiatric Center. With the establishment of one
10 hospital with 2 campuses, the commissioner has the authority to assign the hospital's
11 employees to work at either campus, depending upon the hospital's need for staffing as it
12 varies from time to time between the 2 campuses.

13 This bill also corrects cross-references.
