An Act To Amend the Laws Regarding Motor Vehicle Fees

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 29-A MRSA §461**, as amended by PL 1999, c. 470, §4, is further amended
3 to read:

4 **§461. Reservation of same number**

5 **1. Plate issue year.** In a year in which new registration plates are issued, the
6 Secretary of State shall reserve until July 1st the same registration number for the
7 succeeding registration year for a person who notifies in writing the Secretary of State
8 prior to May 1st of that person's desire to retain that registration number. The fee for
9 retention of the same registration number is ~~\$15~~ \$25.

10 The Secretary of State may issue a facsimile plate that is valid for a 90-day period during
11 production of a reserved plate. A facsimile plate must be attached to the rear plate
12 bracket.

13 If a person does not have a vehicle to register on May 1st, a registration number may be
14 held for a maximum of 2 registration years by depositing with the Secretary of State ~~\$15~~
15 \$25 for each year; ~~except that the registered owner of an antique vehicle may reserve the~~
16 ~~antique registration assigned to that person for 4 years by depositing the sum of \$15 for~~
17 ~~each registration year. These fees are~~ This fee is not refundable and may not be applied
18 against the registration fee.

19 All numbers other than those reserved must be released and may be issued ~~in rotation~~
20 after July 1st.

21 A person wishing to select a number out of rotation may do so by paying the registration
22 fee and a reserved number fee of ~~\$15~~ \$25.

23 ~~A holder of vanity registration plates must pay the sum of \$15 to reserve those letters or~~
24 ~~combination of letters and numbers, which is credited toward the renewal fee.~~

25 **2. Nonplate issue year.** In other than a plate issue year, when a person fails to
26 reregister and the registration remains expired for 6 consecutive months, the reservation
27 of the same number ceases and the number becomes available for reissuance.

28 For a maximum of 2 registration years, a person may reserve the registration number
29 assigned to that person by depositing with the Secretary of State the sum of ~~\$15~~ \$25 for
30 each year; ~~except that the registered owner of an antique motor vehicle may reserve the~~
31 ~~antique registration assigned to that person for 4 years by depositing with the Secretary of~~
32 ~~State the sum of \$15 for each year.~~ A person wishing to select a number out of rotation
33 may do so by paying the registration fee and a reserved number fee of ~~\$15~~ \$25.

34 **Sec. 2. 29-A MRSA §502, sub-§1**, as amended by PL 2017, c. 67, §3, is further
35 amended to read:

36 **1. Transferring registration.** A person who transfers the ownership or discontinues
37 the use of a registered motor vehicle, trailer or semitrailer and applies for registration of
38 another motor vehicle, trailer or semitrailer in the same registration year may use the
39 same number plates on payment of a transfer fee of \$8, as long as the registration fee is

1 the same as that of the former vehicle. If the fee for the vehicle to be registered is greater
2 than the fee for the vehicle first registered, that person must also pay the difference. ~~If~~
3 ~~application is made for a trailer with a gross weight of 2,000 pounds or less, the transfer~~
4 ~~fee is \$5.~~

5 **Sec. 3. 29-A MRSA §1353**, as amended by PL 2017, c. 229, §24, is repealed and
6 the following enacted in its place:

7 **§1353. Motorcycle rider education fees**

8 **1. Instructor fee.** The motorcycle rider education instructor license fee is \$100 and
9 expires one year from date of issuance. The renewal fee is \$100.

10 **2. School license fee.** The motorcycle rider education school license fee is \$150 and
11 expires December 31st annually. The renewal fee is \$150.

12 **Sec. 4. 29-A MRSA §1354, sub-§5-A, ¶A**, as enacted by PL 1995, c. 505, §15
13 and affected by §22, is amended to read:

14 A. The fee for a driver education school license is ~~\$125~~ \$150.

15 **Sec. 5. 29-A MRSA §1354, sub-§5-A, ¶¶B and C**, as amended by PL 2011, c.
16 556, §15, are further amended to read:

17 B. The fee for an instructor license is ~~\$100~~ \$200.

18 C. A driver education school license expires one year from the date of issuance. The
19 fee for the renewal of a driver education school license is ~~\$125~~ \$150. An instructor
20 license expires 2 years from the date of issuance. The fee for the renewal of an
21 instructor license is ~~\$100~~ \$200.

22 **Sec. 6. 29-A MRSA §1405, sub-§3-A**, as enacted by PL 2017, c. 475, Pt. A, §48
23 and affected by §49, is amended to read:

24 **3-A. Fee.** The fee for a duplicate registration certificate is ~~\$2~~ \$5. The fee for a
25 duplicate learner's permit, duplicate license or duplicate nondriver identification card is
26 \$5. The fee for a duplicate license or duplicate nondriver identification card under
27 section 1260 is \$30. The fee for the expedited issuance of a duplicate license or
28 nondriver identification card, including the expedited issuance of a duplicate license or
29 nondriver identification card under section 1260, is an additional \$10. The reason for the
30 expedited issuance must be provided, and the Secretary of State shall determine if
31 expedited issuance is warranted.

32 **Sec. 7. 29-A MRSA §1406-A, sub-§2, ¶¶A to D**, as enacted by PL 2017, c. 27,
33 §5 and affected by §10, are amended to read:

34 A. The fee for the 4-year noncommercial driver's license is ~~\$21~~ \$20.

35 B. The fee for the 4-year noncommercial driver's license under section 1260 is ~~\$41~~
36 \$40.

37 C. The fee for the 4-year commercial driver's license is ~~\$28~~ \$27.

1 D. The fee for the 4-year commercial driver's license under section 1260 is ~~\$48~~ \$47.

2 **SUMMARY**

3 This bill:

4 1. Increases the one-time fee for an out-of-rotation registration plate and for a
5 reserved registration number from \$15 to \$25, the same as for a vanity registration plate
6 fee;

7 2. Increases the registration transfer fee for a trailer under 2,000 pounds from \$5 to
8 \$8, making the fee the same as for other registration transfers;

9 3. Increases the motorcycle rider education school and instructor license fees to
10 match fees for other business licenses issued by the Department of the Secretary of State,
11 Bureau of Motor Vehicles, such as certain dealer licenses;

12 4. Increases driver education school and instructor license fees to match other
13 business license fees;

14 5. Increases the fee for a duplicate registration certificate from \$2 to \$5; and

15 6. Reduces the driver's license fees for persons 65 years of age and over by \$1 to
16 provide equity in the fees assessed on driver's licenses issued to this demographic.
