**An Act to Enhance Support of Local Nutrition Incentive Programs  
by Modifying the Eligibility Requirements of the Fund to Address  
Food Insecurity and Provide Nutrition Incentives**

1       **Be it enacted by the People of the State of Maine as follows:**

2           **Sec. 1. 7 MRSA §219-B**, as corrected by RR 2021, c. 1, Pt. A, §7, is amended to  
3        read:

4           **§219-B. Fund To Address Food Insecurity and Provide Nutrition Incentives**

5           **1. Fund established.** The Fund To Address Food Insecurity and Provide Nutrition  
6        Incentives, referred to in this section as "the fund," is established in the department to  
7        provide incentives to **federal** food and nutrition assistance program participants for the  
8        purchase of locally grown fruits and vegetables and to support outreach for and  
9        administration of programs that offer nutrition incentives to participants of **federal** food and  
10        nutrition assistance programs. The fund is established to match contributions from private  
11        and public sources of up to \$50,000 annually to further the purposes of this section. The  
12        fund, to be accounted within the department, must be held separate and apart from all other  
13        money, funds and accounts. Eligible investment earnings credited to the assets of the fund  
14        become part of the assets of the fund. Any unexpended balances remaining in the fund at  
15        the end of any fiscal year do not lapse and must be carried forward to the next fiscal year.  
16        For purposes of this section, "local" means within the State.

17           **2. Fund recipients.** An organization based in the State that supports local food  
18        producers, local food production or low-income individuals in receiving food and nutrition  
19        assistance may receive proceeds from the fund upon application with the department. The  
20        department shall prioritize an applicant that has a demonstrated history of incentivizing the  
21        use of **federal** food and nutrition assistance programs to purchase locally grown fruits and  
22        vegetables or that demonstrates the ability to leverage the proceeds to match or receive  
23        additional funds from local, state, federal or private sources. The department shall  
24        periodically post a request for applications for eligible organizations to apply for fund  
25        proceeds.

26           **3. Report; audit.** The department shall require a periodic report from a recipient  
27        under subsection 2 detailing the use of fund proceeds and the **federal** food and nutrition  
28        assistance programs involved and to ensure that the funds are expended appropriately  
29        pursuant to this section. The department may audit a recipient to carry out the purposes of  
30        this subsection.

31           **4. Rules.** The department may adopt routine technical rules as defined in Title 5,  
32        chapter 375, subchapter 2-A to carry out the purposes of the fund, including application  
33        criteria and procedures for recipients, disbursement of funds to recipients and for outreach  
34        and administration purposes and reporting and audit procedures for recipients.

35           **SUMMARY**

36        This bill makes funds from the Fund To Address Food Insecurity and Provide Nutrition  
37        Incentives more readily available to local nutrition incentive programs by removing  
38        language that specifies federal food and nutrition assistance programs.
