17 18	A. Fish for or take quahogs, including mahogany quahogs, from an area closed by regulation pursuant to section 6172; or
19 20	B. Possess, ship, transport or sell <del>quahogs, including</del> mahogany quahogs, taken from an area closed <del>by regulation</del> <u>pursuant to section 6172</u> .
21	2. Washing or holding in closed areas. A person may not:
22 23	A. Wash, hold or keep <u>mahogany</u> quahogs in an area closed <del>by regulation</del> <u>pursuant</u> <u>to section 6172</u> ; or

13 14 15 16 17 18 19	Public Law 2011, chapter 527, which took effect on March 18, 2012, allows the Commissioner of Marine Resources to close contaminated areas to the harvesting of marine organisms through issuing text and map descriptions rather than through emergency rulemaking. Although the intent was to cover all clams, quahogs, oysters and mussels, the new closure process inadvertently omitted mahogany quahogs and mussels. This amendment provides that the new closure process applies to mahogany quahogs and mussels.
