Amend the bill in section 5 in the 2nd line (page 2, line 11 in L.D.) by striking out the following: "May 15, 2012" and inserting the following: 'May 31, 2012'

Amend the bill in section 6 in the 2nd line (page 2, line 18 in L.D.) by striking out the following: "May 15, 2012" and inserting the following: 'May 31, 2012'

Amend the bill in section 7 in the 2nd line (page 2, line 25 in L.D.) by striking out the following: "May 15, 2012" and inserting the following: 'May 31, 2012'

Amend the bill in section 8 in the 2nd line (page 2, line 32 in L.D.) by striking out the following: "May 15, 2012" and inserting the following: 'May 31, 2012'

Amend the bill in section 9 in the 2nd line (page 2, line 39 in L.D.) by striking out the following: "May 15, 2012" and inserting the following: 'May 31, 2012'

Amend the bill in section 10 in the 2nd line (page 3, line 4 in L.D.) by striking out the following: "May 15, 2012" and inserting the following: 'May 31, 2012'

Amend the bill in section 11 in the 2nd line (page 3, line 11 in L.D.) by striking out the following: "May 15, 2012" and inserting the following: 'May 31, 2012'

Amend the bill by striking out all of section 12 and inserting the following:
