This amendment, which is the majority report of the committee, changes the title and 25 renames the program the Maine Community College System Pell Grant Match Program. 26 The amendment establishes the program and provides that a student is eligible for the 27 program if the student is a resident of the State, is eligible for a Federal Pell Grant and 28 maintains a minimum grade point average. The grant award may not exceed 100% of the 29 30 amount of funds provided by the Federal Pell Grant that the student receives for the academic year in which the student applies. The availability of the grant and the amount 31 of the grant are subject to the amount available in the established fund, and the Maine 32 Community College System may adopt rules to implement and administer the program 33 and fund. 34

The amendment also adds an appropriations and allocations section with an appropriation of \$3,600,000.
