19 This amendment replaces the bill, which is a concept draft, and changes the title. It allows the Commissioner of Inland Fisheries and Wildlife to accept monetary donations 20 to support hunting opportunities for disabled veterans. It requires the commissioner to 21 transfer those donations to the Department of Defense, Veterans and Emergency 22 Management, Bureau of Maine Veterans' Services to be deposited into the Hunting 23 Opportunities for Disabled Veterans Fund, a nonlapsing fund to be used for the purpose 24 of making funds available to organizations that provide disabled veterans with hunting 25 opportunities. The fund may also receive any other monetary gifts, donations or other 26 contributions from public or private sources. The amendment also adds an appropriations 27 and allocations section. 28
