1 Council once all appointments have been completed. After appointment of all members, 2 the chair shall call and convene the first meeting of the work group. If 30 days or more 3 after the effective date of this resolve a majority of but not all appointments have been 4 made, the chair may request authority and the Legislative Council may grant authority for 5 the work group to meet and conduct its business.

Sec. 5. Notice of meetings. Resolved: That the Attorney General shall provide 6 notice of the meetings of the work group to the general public and to the following 7 organizations: the Maine Prosecutors Association, the Maine Association of Criminal 8 Defense Lawyers, the Maine Chiefs of Police Association, the Maine Sheriffs' 9 Association, the Maine State Police, the Maine Association of Police, the Maine Criminal 10 Justice Academy, the American Civil Liberties Union of Maine, the Immigrant Resource 11 Center of Maine, the Immigrant Legal Advocacy Project, the Maine Hospital Association, 12 the Maine Coalition to End Domestic Violence, the National Association for the 13 Advancement of Colored People, the National Alliance on Mental Illness - Maine, the 14 Maine Municipal Association, the Maine Coalition Against Sexual Assault and the Maine 15 Commission on Domestic and Sexual Abuse. 16

- 3 Amend the bill by relettering or renumbering any nonconsecutive Part letter or 4 section number to read consecutively.

SUMMARY

This amendment replaces the bill with a resolve establishing the Work Group To 6 Study the Use of Body Cameras by Law Enforcement Officers, consisting of 9 members 7 appointed by the President of the Senate, the Speaker of the House and the Attorney 8 General. The Attorney General or the Attorney General's designee serves as chair. The 9 Attorney General is required to give notice of meetings of the work group to the general 10 public and a broad array of organizations. The work group is required to study the use of 11 body cameras by law enforcement officers, to review current practices in Maine and 12 outside of Maine, to review research on the use of body cameras and to report by March 13 1, 2020 with any recommendations to the Joint Standing Committee on Criminal Justice 14 and Public Safety. 15
