COMMITTEE AMENDMENT “ ” to S.P. 256, L.D. 726, Bill, “An Act To Increase Patient Safety in Maine's Medical Marijuana Program”

Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:

**Sec. 1. 22 MRSA §2422, sub-§1**, as amended by PL 2009, c. 631, §8 and affected by §51, is further amended to read:

**1. Cardholder.** "Cardholder" means a ~~registered~~ qualifying patient, a registered primary caregiver, an employee of a registered primary caregiver or a principal officer, board member or employee of a registered dispensary or a marijuana testing facility who has been issued and possesses a valid registry identification card.

**Sec. 2. 22 MRSA §2422, sub-§4-A**, as enacted by PL 2011, c. 407, Pt. B, §4, is amended to read:

**4-A. Incidental amount of marijuana.** "Incidental amount of marijuana" means an amount of nonflowering marijuana plants ~~and~~ marijuana seeds, stalks and roots; and harvested, dried unprepared marijuana defined by rules adopted by the department.

**Sec. 3. 22 MRSA §2422, sub-§5-C** is enacted to read:

**5-C. Marijuana testing facility.** "Marijuana testing facility" means a public or private laboratory that:

A. Is licensed, certified or otherwise approved by the department in accordance with rules adopted by the department under section 2423-A, subsection 10, paragraph D to analyze contaminants in and the potency and cannabinoid profile of samples; and

B. Is accredited pursuant to standard ISO/IEC 17025 of the International Organization for Standardization by a 3rd-party accrediting body or is certified, registered or accredited by an organization approved by the department.

**Sec. 4. 22 MRSA §2422, sub-§13**, as amended by PL 2009, c. 631, §18 and affected by §51, is further amended to read:

1           **13. Registry identification card.** "Registry identification card" means a document  
2 issued by the department that identifies a person as a ~~registered patient~~, registered  
3 primary caregiver, an employee of a registered primary caregiver or a principal officer,  
4 board member or employee of a dispensary or a marijuana testing facility.

20           I. Provide samples to a marijuana testing facility for testing and research purposes.

21           **Sec. 9. 22 MRSA §2423-A, sub-§2, ¶J,** as amended by PL 2013, c. 588, Pt. D,  
22 §3, is further amended to read:

23           J. Use a pesticide in the cultivation of marijuana if the pesticide is used consistent  
24 with federal labeling requirements, is registered with the Department of Agriculture,  
25 Conservation and Forestry, Board of Pesticides Control pursuant to Title 7, section  
26 607 and is used consistent with best management practices for pest management  
27 approved by the Commissioner of Agriculture, Conservation and Forestry. A  
28 registered primary caregiver may not in the cultivation of marijuana use a pesticide  
29 unless the registered primary caregiver or the registered primary caregiver's employee  
30 is certified in the application of the pesticide pursuant to section 1471-D and any  
31 employee who has direct contact with treated plants has completed safety training  
32 pursuant to 40 Code of Federal Regulations, Section 170.130. An employee of the  
33 registered primary caregiver who is not certified pursuant to section 1471-D and who  
34 is involved in the application of the pesticide or handling of the pesticide or  
35 equipment must first complete safety training described in 40 Code of Federal  
36 Regulations, Section 170.230; ~~and~~

37           **Sec. 10. 22 MRSA §2423-A, sub-§2, ¶K,** as reallocated by RR 2013, c. 1, §40,  
38 is amended to read:

39           K. For the purpose of disposing of excess prepared marijuana, transfer prepared  
40 marijuana to a registered dispensary for reasonable compensation. The transfer of  
41 prepared marijuana by a primary caregiver to one or more dispensaries under this

1 paragraph is limited to a registered primary caregiver. A registered primary caregiver  
2 may not transfer more than 2 pounds of excess prepared marijuana for reasonable  
3 compensation under this paragraph in a calendar year. A primary caregiver who  
4 transfers prepared marijuana pursuant to this paragraph does not by virtue of only that  
5 transfer qualify as a member of a collective;

7 L. If the primary caregiver is a registered primary caregiver, provide samples to a

11 research and development purposes only.

14 A. A patient who elects to cultivate marijuana plants must keep the plants in an  
15 enclosed, locked facility unless the plants are being transported because the patient is  
16 moving or taking the plants to the patient's own property in order to cultivate them.  
17 Access to the cultivation facility is limited to the patient, except that emergency  
18 services personnel, an employee of a marijuana testing facility or a person who needs  
19 to gain access to the cultivation facility in order to perform repairs or maintenance or  
20 to do construction may access the cultivation facility to provide those professional  
21 services while under the direct supervision of the patient.

22 **Sec. 13. 22 MRSA §2423-A, sub-§3, ¶B**, as amended by PL 2013, c. 501, §1, is

24 B. A primary caregiver who has been designated by a patient to cultivate marijuana  
25 for the patient's medical use must keep all plants in an enclosed, locked facility unless  
26 the plants are being transported because the primary caregiver is moving or taking the  
27 plants to the primary caregiver's own property in order to cultivate them. The  
28 primary caregiver shall use a numerical identification system to enable the primary  
29 caregiver to identify marijuana plants cultivated for a patient. Access to the  
30 cultivation facility is limited to the primary caregiver, except that an elected official  
31 invited by the primary caregiver for the purpose of providing education to the elected  
32 official on cultivation by the primary caregiver, emergency services personnel, an  
33 employee of a marijuana testing facility or a person who needs to gain access to the  
34 cultivation facility in order to perform repairs or maintenance or to do construction  
35 may access the cultivation facility to provide those professional services while under  
36 the direct supervision of the primary caregiver.

39 testing facility.

40 A. A marijuana testing facility may receive and possess samples from qualifying  
41 patients, designated primary caregivers and dispensaries to provide testing for the  
42 cannabinoid profile and potency of the samples and for contaminants in the samples.

2 pesticides. For the purposes of this paragraph, "plant regulator" has the same

8 (1) Properly dispose of marijuana residue in compliance with department rules;

9 (2) House and store marijuana in the facility's possession or control during the  
10 process of testing, transport or analysis in a manner to prevent diversion, theft or  
11 loss;

12 (3) Label marijuana being transported to and from the facility with the following  
13 statement: "For Testing Purposes Only";

14 (4) Maintain testing results as part of the facility's business books and records;  
15 and

16 (5) Operate in accordance with rules adopted by the department.

17 D. The department shall adopt routine technical rules as defined in Title 5, chapter  
18 375, subchapter 2-A governing marijuana testing facilities, including but not limited  
19 to:

20 (1) Marijuana testing facility director qualification requirements;

21 (2) Required security for marijuana testing facilities; and

22 (3) Requirements for the licensing, certifying or other approval of marijuana  
23 testing facilities.

24 **11. Immunity.** The immunity provisions in this subsection apply to a marijuana  
25 testing facility's principal officers, board members, agents and employees. Any immunity  
26 provision in this chapter in conflict with this subsection does not apply to a marijuana  
27 testing facility.

28 A. A marijuana testing facility is not subject to prosecution, search, seizure or  
29 penalty in any manner, including but not limited to a civil penalty or disciplinary  
30 action by a business or an occupational or professional licensing board or entity, and  
31 may not be denied any right or privilege solely for acting in accordance with this  
32 chapter.

33 B. A principal officer, board member, agent or employee of a marijuana testing  
34 facility is not subject to arrest, prosecution, search, seizure or penalty in any manner,  
35 including but not limited to a civil penalty or disciplinary action by a business or an  
36 occupational or professional licensing board or entity, and may not be denied any  
37 right or privilege solely for working for or with a marijuana testing facility to test  
38 marijuana provided by a qualifying patient, registered primary caregiver or  
39 dispensary.

1 12. Interest. A principal officer, board member or employee of a registered  
2 dispensary or primary caregiver may not have a financial or other interest in a marijuana  
3 testing facility providing services associated with product labeling for that dispensary or  
4 primary caregiver.

5 **Sec. 15. 22 MRSA §2423-B, sub-§§6 and 7** are enacted to read:

6 6. Certification issued based on debilitating condition. A medical provider may  
7 not condition the issuance of a certification for the medical use of marijuana on any  
8 requirements other than the patient's debilitating medical condition. Nothing in this  
9 section may be construed to prevent a medical provider from exercising professional  
10 judgment in declining to issue a certification for the medical use of marijuana.

11 7. Patient referral disclosure of interest. Prior to providing a referral to a  
12 qualifying patient for goods and services associated with a certification for the medical  
13 use of marijuana to an entity in which the medical provider has a direct or indirect  
14 financial interest, a medical provider shall provide written disclosure to the qualifying  
15 patient regarding any direct or indirect financial interest the medical provider has or may  
16 have in the resulting referral and shall maintain a copy of this disclosure in the qualifying  
17 patient's record.

19 1-A. Legal protection for hospitals. The immunity provisions in this subsection  
20 apply to a hospital licensed under chapter 405 and to principal officers, board members,  
21 agents and employees of the hospital. Any immunity provision in this chapter in conflict  
22 with this subsection does not apply to a hospital. The legal protection for hospitals  
23 applies in accordance with the following.

24 A. If the use of forms of prepared marijuana that are not smoked or vaporized,  
25 including but not limited to edible marijuana and tinctures and salves of marijuana,  
26 by admitted patients who have been certified under section 2423-B occurs in a  
27 hospital, that hospital is not subject to prosecution, search, seizure or penalty in any  
28 manner, including but not limited to a civil penalty or disciplinary action by an  
29 occupational or professional licensing board or entity, and may not be denied any  
30 license, registration, right or privilege solely because the admitted patient lawfully  
31 engages in conduct involving the medical use of marijuana authorized under this  
32 chapter.

33 B. A principal officer, board member or employee of a hospital where the use of  
34 forms of prepared marijuana that are not smoked or vaporized, including but not  
35 limited to edible marijuana and tinctures and salves of marijuana, by admitted  
36 patients who have been certified under section 2423-B occurs is not subject to arrest,  
37 prosecution, search, seizure or penalty in any manner, including but not limited to a  
38 civil penalty or disciplinary action by an occupational or professional licensing board  
39 or entity, and may not be denied any license, registration, right or privilege solely  
40 because the admitted patient lawfully engages in conduct involving the medical use  
41 of marijuana authorized under this chapter.

42 **Sec. 17. 22 MRSA §2423-E, sub-§4,** as enacted by PL 2011, c. 407, Pt. B, §20,  
43 is amended to read:

1           **4. Prohibition on seizure and retention.** Except when necessary for an ongoing  
2 criminal or civil investigation, a law enforcement officer may not seize marijuana that is  
3 in the possession of a qualifying patient, primary caregiver, marijuana testing facility or  
4 registered dispensary as authorized by this chapter. A law enforcement officer in  
5 possession of marijuana in violation of this subsection must return the marijuana within 7  
6 days after receiving a written request for return by the owner of the marijuana.  
7 Notwithstanding the provisions of Title 14, chapter 741, if the law enforcement officer  
8 fails to return marijuana possessed in violation of this subsection within 7 days of  
9 receiving a written request for return of the marijuana under this subsection, the owner of  
10 the marijuana may file a claim in the District Court in the district where the owner lives  
11 or where the law enforcement officer is employed.

2 the marijuana plants are being transported between the dispensary and a location at  
3 which the dispensary cultivates the marijuana plants, as disclosed to the department  
4 in subsection 2, paragraph A, subparagraph (3). The dispensary shall use a numerical  
5 identification system to enable the dispensary to track marijuana plants from  
6 cultivation to sale and to track prepared marijuana obtained pursuant to section  
7 2423-A, subsection 2, paragraph H from acquisition to sale. Access to the cultivation  
8 facility is limited to a cardholder who is a principal officer, board member or

38 laboratory testing on soil and marijuana plant samples specimens and samples portions of  
39 products containing marijuana from registered primary caregivers and registered  
40 dispensaries to determine compliance with this chapter and for evidence purposes.
