COMMITTEE AMENDMENT “ ” to S.P. 467, L.D. 1333, “Resolve, Directing the Department of Health and Human Services To Amend the MaineCare Benefits Manual”

Amend the resolve in section 1 in the last line (page 1, line 6 in L.D.) by striking out the following: "2-A." and inserting the following: '2-A; and be it further'

Amend the resolve by inserting after section 1 the following:

'Sec. 2. Adjustment of reimbursement under the MaineCare program for inpatient substance abuse services. Resolved: That, notwithstanding any other provision of law, the Department of Health and Human Services shall amend the rules for reimbursement under the MaineCare program as necessary for inpatient substance abuse services in distinct inpatient units. Inpatient substance abuse services must be reimbursed based on a case mix index multiplied by the psychiatric discharge rate, resulting in a rate of \$4,898 per discharge. Rules adopted pursuant to this section are routine technical rules as defined by the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A; and be it further

Sec. 3. Appropriations and allocations. Resolved: That the following appropriations and allocations are made.

Initiative: Provides funding to increase the MaineCare rate for inpatient substance abuse services based on a case-mix index multiplied by the psychiatric discharge rate.

25 **SUMMARY**

26 This amendment amends the resolve by adding a new section directing the
27 Department of Health and Human Services to amend the rules for reimbursement under
28 the MaineCare program as necessary for inpatient substance abuse services in distinct
29 inpatient units. It requires that inpatient substance abuse services be reimbursed based on
30 a case mix index multiplied by the psychiatric discharge rate, resulting in a rate of \$4,898
31 per discharge.
