A supervising dentist shall arrange for another dentist or specialist to provide any services needed by a patient of a dental hygiene therapist supervised by that dentist that are beyond the scope of practice of the dental hygiene therapist and that the supervising dentist is unable to provide.
- B. The supervising dentist is responsible for all authorized services and procedures
 performed by the dental hygiene therapist pursuant to a written practice agreement
 executed by the dentist pursuant to section 18377.
- C. Revisions to a written practice agreement must be documented in a new written practice agreement signed by the supervising dentist and the dental hygiene therapist.
- D. A supervising dentist who signs a written practice agreement shall file a copy of

A dental hygiene therapist may practice only under the standing order of the supervising dentist, may provide only care that follows written protocols and may provide only services that the dental hygiene therapist is authorized to provide by the written practice agreement.

This amendment corrects conflicts created by the enactment of Public Law 2015, chapter 429, which repealed and replaced the laws governing dental professionals. This amendment makes the following changes to the provisions of law enacted in chapter 429:

- 1. It changes the term "dental hygiene therapist" to "dental therapist";
- 2. It changes the term "dental hygiene therapy" to "dental therapy";

3. It specifies that an applicant who has successfully completed a dental therapy
 education program that is accredited by either the Board of Dental Practice or the
 American Dental Association Commission on Dental Accreditation or a successor
 organization approved by the board meets the requirements for having completed a dental
 therapy education program;

- 4. It removes the requirements that a dental therapy education program be consistent
 with a specified model curriculum, be consistent with programs in other states and be
 approved by the board;
- 18 5. It requires that an applicant for a dental therapy license engage in at least 2 years
 19 as well as 2,000 hours of supervised clinical practice;
- 6. It limits to 5 the number of dental therapists that a single dentist may supervise at
 one time; and
- 7. It removes the requirement that a dental therapist practice under the directsupervision of a dentist.
