The bill includes a duty with regard to a serious threat of 30 substantial damage to real property, which this amendment deletes. 31 32 This amendment also replaces the immunity language provided in the bill to make clear that there is no monetary liability and that the specific mental health professionals 33 are not subject to a cause of action based on the disclosure of information to a 3rd party in 34 an effort to discharge the duty to warn or protect. 35
