2 This amendment replaces the bill with a resolve to encourage each school administrative unit to adopt a mission statement for every school under its jurisdiction. In 3 developing and adopting a mission statement, school boards are encouraged to solicit 4 5 input from teachers, administrators, parents, students and community members. The amendment directs the Department of Education to provide technical assistance to school 6 7 administrative units in developing mission statements for the schools under their jurisdiction.
