**Emergency preamble.** Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

**Whereas,** outpatient mental health services are an important service for an individual's overall health and well-being; and

Whereas, rates of reimbursement for services create barriers to the abundance of services provided; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

## Be it enacted by the People of the State of Maine as follows:

- Sec. 1. Department of Health and Human Services to increase MaineCare rates. No later than July 1, 2021, the Department of Health and Human Services shall amend its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 65, Behavioral Health Services, Outpatient Therapy-Individual/Family and Outpatient Therapy-Group, to increase reimbursement rates by 25%.
- **Sec. 2. Appropriations and allocations.** The following appropriations and allocations are made.

 Initiative: Provides funding for the Department of Health and Human Services to amend its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 65, Behavioral Health Services, Outpatient Therapy-Individual/Family and Outpatient Therapy-Group, to increase reimbursement rates by 25%.
