A fund, grant, gift or service of the State or its departments, agencies or instrumentalities otherwise available to water utilities <u>water-related entities</u> may not be made conditional on a water utility's <u>water-related entity's</u> membership in a regional water council.

 statement of financial activities to the member utilities water-related entities. The report
 must be filed with the Public Utilities Commission and the drinking water program of the
 Department of Health and Human Services.'

33 SUMMARY

This amendment strikes and replaces the bill. It defines "water-related entity" as a water utility or a municipal or quasi-municipal entity owning, controlling, operating or managing sewer, sanitary or storm water works. It allows for a water-related entity to be a member of a regional water council and requires that one of the members of a regional water council be a water utility. It requires that a regional water council provide a statement of its financial activities to the member water-related entities and requires that
