7	This amendment makes the following changes to the bill:
8 9	1. It strikes the generator exception in the bill and replaces it with an exception for electrical work on aboveground electric lines of one kilovolt or more;
10 11	2. It removes the references to "generator" in the exception for contractors in the bill; and
12 13	3. It repeals the definition of "public service corporation" since it is no longer used in the Maine Revised Statutes, Title 32.
