### An Act To Revise the Laws on Tournament Games

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 17 MRSA §1836, first ¶**, as enacted by PL 2009, c. 487, Pt. A, §2, is  
3 amended to read:

4 The Chief of the State Police may issue a license ~~to conduct a tournament game as~~  
5 ~~provided in~~ under this section to an organization eligible to conduct beano games under  
6 chapter 13-A and games of chance under this chapter to conduct up to 5 tournament  
7 games per month. For purposes of this section, "tournament game" means a game of  
8 chance played using a deck of cards with rules similar to poker or other card games. ~~The~~  
9 ~~Chief of the State Police may not issue a tournament game license to an organization~~  
10 ~~more than once per month.~~

11 **Sec. 2. 17 MRSA §1836, sub-§3**, as enacted by PL 2009, c. 487, Pt. A, §2, is  
12 repealed.

13 **Sec. 3. 17 MRSA §1836, sub-§3-A** is enacted to read:

14 **3-A. License.** The fee for a tournament game license is \$100 per tournament game,  
15 \$300 per month or \$1,200 per year.

16 **Sec. 4. 17 MRSA §1836, sub-§4**, as enacted by PL 2009, c. 487, Pt. A, §2, is  
17 amended to read:

18 **4. Tournament.** The organization licensed to conduct a tournament game under this  
19 section shall display the rules of the tournament game and the license issued. The  
20 maximum number of players allowed is 100 unless the tournament game is held on  
21 premises owned by the licensee, in which case the maximum number of players allowed  
22 is 300. Winners are determined by a process of elimination. The use of currency is  
23 prohibited as part of tournament game play. The maximum entry fee to play in the  
24 tournament game is \$100, except the organization may add to the player entry fee to  
25 defray the cost of the license fee, as long as the total additional amount collected from all  
26 players does not exceed \$200 the cost of the license fee. Only one entry fee is permitted  
27 per person. A tournament game must be completed within 48 hours. Other games of  
28 chance on the premises are prohibited during a tournament game, except for lucky seven  
29 or similar sealed tickets and 50/50 raffles with a prize value up to \$1,000. This section  
30 does not prohibit a licensee from conducting one winner-take-all hand per tournament  
31 game with a bet limit of \$5.

32 **Sec. 5. 17 MRSA §1836, sub-§6**, as enacted by PL 2009, c. 487, Pt. A, §2, is  
33 amended to read:

34 **6. Cost of administration; surplus.** The Chief of the State Police may retain, from  
35 license fees collected in accordance with subsection ~~3~~ 3-A, only an amount necessary to  
36 defray the costs of administering this section. All fees collected in excess of the amount  
37 necessary to defray the costs of administration must be allocated as follows:

38 A. Forty percent to the Fractionation Development Center; and
