1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 1 MRSA §1015, sub-§3, ¶B, as amended by PL 2009, c. 286, §1, is
 further amended to read:

4 B. The Governor, a member of the Legislature or any constitutional officer or the 5 staff or agent of the Governor, a member of the Legislature or any constitutional officer may not intentionally solicit or accept a contribution from a lobbyist, lobbyist 6 7 associate or employer during any period of time in which the Legislature is convened 8 before final adjournment, except for a qualifying contribution as defined under Title 21 A, section 1122, subsection 7. A lobbyist, lobbyist associate or employer may not 9 10 intentionally give, offer or promise a contribution, other than a qualifying contribution, to the Governor, a member of the Legislature or any constitutional 11 officer or the staff or agent of the Governor, a member of the Legislature or any 12 constitutional officer during any time in which the Legislature is convened before 13 14 final adjournment. These prohibitions apply to contributions directly and indirectly solicited or accepted by, or given, offered and promised to a political action 15 committee, ballot question committee or party committee of which the Governor, a 16 17 member of the Legislature, a constitutional officer or the staff or agent of these 18 officials is a treasurer, officer or primary fund-raiser or decision maker.

- **1. Declaration of intent.** A participating candidate must file a declaration of intent to seek certification as a Maine Clean Election Act candidate and to comply with the requirements of this chapter. The declaration of intent must be filed with the commission prior to or during the qualifying period, except as provided in subsection 11, according to forms and procedures developed by the commission by April 1st of the election year.

1 2 3	Qualifying contributions collected more than 5 business days before the declaration of intent has been filed will not be counted toward the eligibility requirement in subsection 3.

11	A. Two hundred thousand dollars for a gubernatorial candidate;
12	B. One thousand five hundred dollars for a candidate for the State Senate; or

26	A. Signed and filed a declaration of intent to participate in this Act;
27	B. Submitted the appropriate number of valid qualifying contributions;
28 29	C. Qualified as a candidate by petition or other means no later than 5 business days after the end of the qualifying period;
30 31	C-1. As a gubernatorial candidate, collected at least \$40,000 in seed money contributions from registered voters in the State;
32 33	D. Not accepted contributions, except for seed money contributions, and otherwise complied with seed money restrictions;
34 35	D-1. Not run for the same office as a nonparticipating candidate in a primary election in the same election year;

Otherwise met the requirements for participation in this Act. 9 The executive director shall certify a candidate complying with the requirements of this 10 section as a Maine Clean Election Act candidate as soon as possible after final submittal 11 of qualifying contributions and other supporting documents required under subsection 4 but no later than within 3 business days for legislative candidates and 5 business days for 12 gubernatorial candidates. The executive director may take additional time if further 13 14 investigation is necessary to verify compliance with this Act as long as the commission notifies the candidate regarding the anticipated schedule for conclusion of the 15 investigation. A candidate or other interested person may appeal the decision of the 16 executive director to the members of the commission in accordance with subsection 14. 17 18 A certified candidate must comply with all requirements of this Act after certification and 19 throughout the primary and general election periods. After certification, a candidate must limit the candidate's campaign expenditures and obligations, including 26 27 outstanding obligations, to the revenues distributed to the candidate from the fund and 28 may not accept any contributions unless specifically authorized by the commission. 29 Candidates may also accept and spend interest earned on fund revenues in campaign bank 30 accounts. All revenues distributed to a certified candidate from the fund must be used for 31 campaign-related purposes. The candidate, the treasurer, the candidate's committee authorized pursuant to section 1013-A, subsection 1 or any agent of the candidate and 32 33 committee may not use these revenues for any but campaign-related purposes. 2 The commission shall adopt rules to ensure effective administration of this chapter. 3 These rules must include but must not be are not limited to procedures for obtaining qualifying contributions, certification as a Maine Clean Election Act candidate, 4 5 circumstances involving special elections, vacancies, recounts, withdrawals or replacements, collection of revenues for the fund, distribution of fund revenue to certified 6 7 candidates, return of unspent fund disbursements, disposition of equipment purchased 8 with clean election funds and compliance with the Maine Clean Election Act. Rules of 9 the commission required by this section are major substantive rules as defined in Title 5, 10 chapter 375, subchapter H-A 2-A.

SUMMARY

12 This bill removes the contribution limits placed on a person who wishes to contribute directly to the campaign of a candidate for the Legislature, Governor or other state or 13 local offices. It also amends the Maine Clean Election Act by eliminating the 14 requirement that participants must collect \$5 qualifying contributions. In order to qualify 15 16 for distributions from the Maine Clean Election Fund, a candidate need only be certified as a candidate under the process governed by the Secretary of State and by filing a 17 declaration of intent by April 1st of the election year. Under this bill, a participating 18 19 candidate under the Maine Clean Election Act is not prohibited from accepting 20 contributions from outside sources. The bill also provides that there are not distinctions 21 made between enrolled and unenrolled candidates under the Maine Clean Election Act.
