6 Sec. 9. Transition. If a detective in the employment of the Office of the Attorney 7 General on July 1, 2020 elects to participate in the 1998 Special Plan of the Maine Public 8 Employees Retirement System, as provided in the Maine Revised Statutes, Title 5, 9 section 17851-A, subsection 1, that detective must make that election not later than 180 10 days after the effective date of this Act.

- 11 SUMMARY
- This bill allows detectives in the Office of the Attorney General to elect to participate in the 1998 Special Plan of the Maine Public Employees Retirement System. Under that plan, a person may retire at 55 years of age with 10 years of creditable service or may retire before 55 years of age with 25 years of creditable service and at a reduced benefit.
