6 7	2. It clarifies that the work of the commission does not prevent the Chief Justice and other judicial staff from making recommendations regarding judicial compensation; and
8 9	3. It removes from the duties of the commission making recommendations for compensation of the Attorney General, Secretary of State, Treasurer of State and State
