 caregiver retail stores, registered dispensaries, marijuana testing facilities and
 manufacturing facilities that are operating in the municipality prior to the effective date of
 this section; or

3. Municipal authorization needed. Authorize registered caregiver retail stores, registered dispensaries, marijuana testing facilities and manufacturing facilities that are not operating on the effective date of this section to operate in the municipality unless the municipal legislative body, as defined in Title 30-A, section 2001, subsection 9, has voted to adopt or amend an ordinance or approve a warrant article allowing registered caregiver retail stores, registered dispensaries, marijuana testing facilities or manufacturing facilities, as applicable, to operate within the municipality.'

SUMMARY

19 This amendment adds an emergency preamble and emergency clause to the bill. It provides that a registered caregiver may operate one retail store to sell harvested 20 marijuana to qualifying patients. It provides that a municipality may not prohibit 21 22 registered caregiver retail stores, registered dispensaries, marijuana testing facilities and 23 manufacturing facilities that are operating in the municipality prior to the effective date of 24 this legislation and that a municipality may not authorize registered caregiver retail 25 stores, registered dispensaries, marijuana testing facilities and manufacturing facilities 26 that are not operating on the effective date of this legislation to operate in the municipality unless the municipal legislative body has voted to adopt or amend an 27 ordinance or approve a warrant article allowing registered caregiver retail stores, 28 29 registered dispensaries, marijuana testing facilities or manufacturing facilities to operate 30 within the municipality.
