By January 15, 2023, the commissioner shall report to the joint standing 10 committee of the Legislature having jurisdiction over inland fisheries and wildlife matters the findings and recommendations of the stakeholder group, including any recommended 11 legislation, if needed. After receiving the report, the committee may report out a bill 12 13 relating to boater safety and education to the 131st Legislature in 2023.'

This amendment replaces the bill. The amendment does the following.

18 1. Beginning January 1, 2024, it requires a person born on or after January 1, 1999 to be 16 years of age or older and to have completed a boater safety and education course to 19 20 supervise a person under 12 years of age who operates on inland waters of the State a 21 motorboat propelled by machinery capable of producing more than 10 horsepower.

- 22 2. Beginning January 1, 2024, it requires a person born on or after January 1, 1999 to be 12 years of age or older and to have completed a mandatory boater safety and education 23 24 course to operate on inland waters of the State a motorboat capable of producing more than 25 25 horsepower.
- 26 3. Beginning January 1, 2024, it requires a person born on or after January 1, 1999 to be 16 years of age or older and to have completed a boater safety and education course to 27 operate a personal watercraft on inland waters of the State. 28

4. It requires the Commissioner of Inland Fisheries and Wildlife to convene a 29 30 stakeholder group on boater safety and education. The commissioner is required to provide 31 a report to the Legislature by January 15, 2023 on the findings of the stakeholder group. 32 After receiving the report, the joint standing committee of the Legislature having 33 jurisdiction over inland fisheries and wildlife matters has authority to report out a bill 34 relating to boater safety and education to the 131st Legislature in 2023.
