SUMMARY 1 2 This amendment authorizes a student enrolled in a dental assisting program to 3 practice under the supervision of the student's instructors without first obtaining a license from the Board of Dental Practice. The amendment also removes an unnecessary 4 5 definition and clarifies that the crime of unlawful practice applies whenever a person employs an unlicensed person to provide services for which a license is required by the 6 Dental Practice Act. 7 8 The bill eliminates the charitable dentist license and clinical dentist educator license 9 categories.
