## SUMMARY

10 This bill lifts the moratorium on the issuance of new elver fishing licenses and increases the total number of licenses available to 600. New licenses are geographically 11 distributed and issued by a lottery system overseen by the Commissioner of Marine 12 Resources. The bill also increases the cost of licenses; increases the number of allowable 13 elver fyke nets for residents to 3; increases the fines for elver gear molestation, failure to 14 pay elver gear fees and fishing without a license to up to \$5,000; changes the open season 15 to April 1st to June 20th; and allows elver fishing 7 days per week during the open 16 17 season.
