SUMMARY

2 This amendment, which is the majority report of the committee, clarifies the bill by adding references to the chapters of the Maine Revised Statutes, Title 22 through which 3 benefits are provided under the MaineCare program, Temporary Assistance for Needy 4 5 Families, TANF, program, Additional Support for People in Retraining and Employment-Temporary Assistance for Needy Families program and the statewide food supplement 6 7 program. The amendment also specifies that information disclosed by the Office of the Attorney General for the purposes of the annual report from the Department of Health 8 and Human Services on investigations and prosecutions of false claims made under the 9 10 MaineCare, TANF and food supplement programs on the status of cases must conform to the law on intelligence and investigative record information and may not compromise the 11 12 investigation or prosecution of a case. The amendment also specifies that the requirements of the bill must be accomplished within the existing resources of the 13 14 department.
