announcements and tickets are available for purchase only from a designated public
 benefit corporation.

B. A law enforcement agency or association may make general public solicitations
for donations through public announcements or paid advertisements as long as all

Solicitations may not be sent directly to potential donors by mail or any other direct
means.

8 **Emergency clause.** In view of the emergency cited in the preamble, this 9 legislation takes effect when approved.'

SUMMARY

11 This amendment replaces the bill, which was a concept draft. Current law allows a law enforcement agency or association to solicit property from the general public for the 12 benefit of a law enforcement officer, or an immediate family member of a law 13 enforcement officer, suffering from a catastrophic illness. This amendment also allows a 14 law enforcement agency or association to solicit property from a law enforcement officer, 15 a law enforcement agency or a law enforcement association for the benefit of a law 16 17 enforcement officer, or an immediate family member of a law enforcement officer, suffering from a catastrophic illness. This amendment also adds an emergency preamble 18 19 and emergency clause.
