28	B. "Employer" has the same meaning as in section 1043, subsection 9.
29	C. "Employee" means a person engaged in employment.
30 31	2. Earned paid leave. An employer that employs more than 10 employees in the usual and regular course of business for more than 120 days in any calendar year shall

permit each employee to earn paid leave based on the employee's base pay as provided in 1 2 this section. 3 **3.** Accrual. An employee is entitled to earn one hour of paid leave from a single employer for every 40 hours worked, up to 40 hours in one year of employment. Accrual 4 of leave begins at the start of employment, but the employer is not required to permit use 5 of the leave before the employee has been employed by that employer for 120 days 6 during a one-year period. 7 8 4. Rate. An employee while taking earned leave must be paid at least the same base 9 rate of pay that the employee received immediately prior to taking earned leave and must receive the same benefits as those provided under established policies of the employer 10 pertaining to other types of paid leave. 11 12 5. Notice. Absent an emergency, illness or other sudden necessity for taking earned leave, an employee shall give reasonable notice to the employee's supervisor of the 13 14 employee's intent to use earned leave. Use of leave must be scheduled to prevent undue hardship on the employer as reasonably determined by the employer. 15 6. Benefits. The taking of earned leave under this section may not result in the loss 16 of any employee benefits accrued before the date on which the leave commenced and 17 may not affect the employee's right to health insurance benefits on the same terms and 18 conditions as applicable to similarly situated employees. Nothing is this section prevents 19 an employer from providing a benefit greater than that provided by this section. 20 7. Enforcement. The bureau has the exclusive authority pursuant to section 42 to 21 22 enforce this section. 23 8. Penalties. Penalties for violations of this section are the same as those provided 24 in section 53. 9. Rules. The Department of Labor shall adopt rules to implement and enforce the 25 provisions of this section, including rules regarding the receipt, investigation and 26 prosecution of complaints brought under this section. Rules adopted pursuant to this 27 subsection are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A. 28 29 **10.** Exception. This section does not apply to an employee covered by a collective bargaining agreement during the period between January 1, 2021 and the expiration of the 30 31 agreement. 12. Reporting. Beginning January 1, 2022, and annually thereafter, the Department 32 of Labor shall submit a report to the joint standing committee of the Legislature having 33 34 jurisdiction over labor matters on progress made in the State to comply with this section. 35 Sec. 4. Effective date. This Act takes effect January 1, 2021.' 1. It requires an employer, except in a seasonal industry, that employs more than 10 employees for more than 120 days in any calendar year to permit each employee to earn 2 paid leave based on the employee's base pay; 3

2. It specifies that an employee is entitled to earn one hour of paid leave from a single employer for every 40 hours worked, up to 40 hours in one year of employment, with accrual of leave beginning at the start of employment;

3. It requires an employee to work for 120 days before an employer is required to 7 8 permit use of accrued earned paid leave;

9 4. It requires an employer to pay an employee taking earned leave at least the same base rate of pay that employee received immediately prior to taking earned leave and 10 provide the same benefits as those provided under established policies of the employer 11 pertaining to other types of paid leave; 12

5. It requires an employee, absent an emergency, illness or other sudden necessity for 13 taking earned leave, to give reasonable notice to the employee's supervisor of the 14 employee's intent to use leave; 15

6. It specifies that an employee taking earned leave maintains any employee benefits 16 17 accrued before the date on which the leave commenced and the leave may not affect the employee's right to health insurance benefits on the same terms and conditions as 18 applicable to similarly situated employees; 19

20 7. It provides the Department of Labor, Bureau of Labor Standards the exclusive authority to enforce the law and requires the Department of Labor to adopt routine 21 technical rules to implement and enforce the law; 22

8. It allows for the imposition of penalties currently established in the Maine Revised 23 24 Statutes, Title 26, section 53;

9. It requires the Department of Labor to adopt routine technical rules to implement 25 and enforce provisions regarding earned paid leave; 26

10. It specifies that earned paid leave does not apply to an employee covered by a 27 collective bargaining agreement during the period between January 1, 2021 and the 28 expiration of the collective bargaining agreement; and 29

11. It requires the Department of Labor, beginning January 1, 2022 and annually 30 thereafter, to report progress to the joint standing committee of the Legislature having 31 jurisdiction over labor matters. 32
