COMMITTEE AMENDMENT “ ” to S.P. 317, L.D. 1084, Bill, “An Act To Amend Certain Provisions of Maine Fish and Wildlife Laws”

Amend the bill by inserting after the title and before the enacting clause the following:

Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the Department of Inland Fisheries and Wildlife has recently conducted a moose survey that indicates the State's moose population has been increasing and could sustain additional hunting opportunities; and

Whereas, the lottery drawing for the 2011 moose permits takes place in June and the authorization to issue more moose permits needs to take effect before the drawing; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'

Amend the bill by striking out all of section 2 and inserting the following:

Sec. 2. 12 MRSA §10052-A is enacted to read:

§10052-A. Division of Engineering

The Division of Engineering is established within the Department of Inland Fisheries and Wildlife. The division is equal in organizational level and status with other major organizational units within the department or its successors. The division is administered by a director who is immediately responsible to the deputy commissioner. The director possesses full authority and responsibility for administering all the powers and duties of the division, subject to the direction of the commissioner and except as otherwise provided by statute. The responsibilities of the division include the design, maintenance

1 and repair of department-owned facilities, including the preparation of a capital
2 improvement plan to be printed in the budget document.

3 **Sec. 3. 12 MRSA §10155, sub-§1**, as enacted by PL 2003, c. 414, Pt. A, §2 and
4 affected by c. 614, §9, is amended to read:

5 **1. Membership.** Members of the board must be residents of the State. The board
6 consists of the following ~~5~~ 4 members:

7 A. Two employees of the department, appointed by the commissioner one of whom
8 may be a retired employee who has experience in taxidermy;

9 B. ~~Two~~ One licensed ~~taxidermists~~ taxidermist with expertise in the art of taxidermy,
10 appointed by the Governor; and

11 C. One member of the general public with no affiliation to the art of taxidermy,
12 appointed by the Governor.'

13 Amend the bill in section 3 in subsection 1 in the 3rd line (page 1, line 31 in L.D.) by
14 inserting after the following: "currency" the following: 'used in violation of this Part'

15 Amend the bill in section 6 in paragraph B in subparagraph (2) in the blocked
16 paragraph in the last line (page 2, line 38 in L.D.) by inserting after the following: "stand"
17 the following: 'For purposes of this subparagraph, "observation stand" does not include
18 a portable blind utilized at ground level that remains in the physical possession of the
19 hunter'

20 Amend the bill in section 7 in subsection 11 in the 4th line (page 3, line 7 in L.D.) by
21 striking out the following: "or could result" and inserting the following: 'in a serious
22 injury or'

23 Amend the bill in section 11 by striking out all of paragraph D (page 3, lines 30 to 36
24 in L.D.) and inserting the following:

25 'D. For a resident 70 years of age or older. ~~A~~ For a person who holds a valid senior
26 lifetime license under this section upon turning at any time during the calendar year
27 that person turns 70 years of age may obtain at no cost, that lifetime license includes
28 all hunting permits and licenses authorized in this Part and may renew at no cost a
29 guide license under section 12853. A person who is 70 years of age or older may
30 purchase a senior lifetime license that entitles the holder to all the privileges
31 described in this paragraph for a one-time \$8 fee.'

32 Amend the bill in section 12 by striking out all of subsection 5 and inserting the
33 following:

34 **'5. Hunting license revocation or suspension for endangerment or harm to**
35 **another.** The commissioner may bring a complaint in the District Court seeking to
36 revoke or suspend the current hunting license or the privilege to obtain a hunting license
37 of any person whom the commissioner reasonably believes to have killed, wounded or
38 recklessly endangered the safety of another human being while hunting in this State or
39 another jurisdiction. The District Court shall revoke or suspend the person's license or
40 privilege for a period of at least 5 years if the court finds that the person, while hunting,
41 has killed, wounded or recklessly endangered the safety of another human being and the
42 public safety will be endangered by the person's retention of that license or privilege. For

1 the purpose of this subsection, "recklessly" has the same meaning as that set out in Title
2 17-A, section 35, subsection 3.

3 A. A person whose hunting license has been revoked or suspended or whose right
4 to hunt or the right to obtain a hunting license has been denied under this subsection,
5 may, after the expiration of one year from the date of the revocation or suspension,
6 petition the commissioner for restoration of the person's privilege to procure such a
7 license.

8 B. The commissioner, after hearing, may restore the petitioner's privilege if the
9 commissioner determines that the public safety will not be endangered by restoring
10 that privilege.

11 C. If the commissioner disallows the petition and thereby refuses to grant the
12 restoration of the privilege, the petitioner may appeal to the commissioner's advisory
13 council, which, after hearing on the petition, may allow it and restore the privilege.'

14 Amend the bill by striking out all of section 20 and inserting the following:

15 '**Sec. 20. 12 MRSA §11701-A** is enacted to read:

16 **§11701-A. Hunting hours for wild turkey**

17 Notwithstanding the provision in section 11701 regarding legal hunting times for
18 wild turkey, a person may hunt for wild turkey between sunrise and sunset. This section
19 is repealed March 5, 2014.'

20 Amend the bill in section 23 in §12159 in subsection 2 in the 2nd line (page 7, line 5
21 in L.D.) by striking out the following: "resale" and inserting the following: 'resale sale'

22 Amend the bill by striking out all of section 24 and inserting the following:

23 '**Sec. 24. 12 MRSA §12161** is enacted to read:

24 **§12161. Taking of certain nonmarine invertebrates from the wild for commercial**
25 **purposes**

26 **1. Prohibition; penalties.** Except as provided in this section, a person may not take
27 and possess certain nonmarine invertebrates, specifically freshwater mussels, butterflies,
28 moths, dragonflies or beetles, from the wild for export, sale or commercial purposes.

29 A. A person who violates this subsection commits a civil violation for which a fine
30 of not less than \$100 nor more than \$500 may be adjudged.

31 B. A person who violates this subsection after having been adjudicated as having
32 committed 3 or more civil violations under this Part within the previous 5-year period
33 commits a Class E crime.

34 **2. Commercial nonmarine invertebrate permit.** Persons harvesting freshwater
35 mussels, butterflies, moths, dragonflies or beetles for export, sale or commercial purposes
36 are required to obtain a permit from the commissioner.

37 **3. Rules.** The commissioner may by rule:

38 A. Require reporting of commercial harvest activities, including at a minimum dates,
39 locations and numbers collected by species;

- 1 B. Establish daily and season possession limits;
- 2 C. Establish a fee schedule to implement a permit system under this section; and
- 3 D. Require humane harvest, confinement and disposal methods.

4 Rules adopted pursuant to this subsection are routine technical rules as defined in Title 5,
5 chapter 375, subchapter 2-A.'

6 Amend the bill in section 25 in subsection 3 by striking out all of the first paragraph
7 (page 8, lines 5 to 7 in L.D.) and inserting the following:

8 '**3. Nonresident trapping beaver.** A nonresident may not trap beaver in this State
9 unless that nonresident's state or province of residency allows Maine residents to trap
10 beaver in that state or province.'

11 Amend the bill by inserting after section 25 the following:

12 '**Sec. 26. 12 MRSA §12260, sub-§3, ¶B,** as enacted by PL 2003, c. 414, Pt. A,
13 §2 and affected by c. 614, §9, is amended to read:

14 B. A person may not set a bear trap other than a cable trap, ~~unless it conforms to the~~
15 ~~following specifications or a cage-type trap as authorized by the commissioner.~~

16 ~~(1) The trap must be enclosed by at least 2 strands of wire, one strand 2 feet from~~
17 ~~the ground and one strand 4 feet from the ground.~~

18 ~~(2) The wire must be securely held in position.~~

19 ~~(3) The wire must be not less than 5 yards nor more than 10 yards at any point~~
20 ~~from the enclosed trap.~~

21 ~~(4) The trap enclosure must be marked by substantial signs with the words~~
22 ~~"BEAR TRAP" in letters not less than 3 inches in height.~~

23 ~~(5) The signs must be spaced around each enclosure at intervals of not more than~~
24 ~~20 feet.~~

25 ~~(6) Each sign must be securely fastened to the top strand of wire.~~

26 **Sec. 27. 12 MRSA §12457, sub-§1,** as amended by PL 2009, c. 550, §8, is
27 further amended to read:

28 **1. Closed waters.** Except as the commissioner may by rule provide and as provided
29 in subsection 2, the following waters are closed to fishing:

30 A. The area within 150 feet of any operational fishway, except:

31 (1) At the following places, the fishway and the area within 75 feet of any part of
32 the fishway are closed to fishing at all times:

33 (a) Grand Falls Powerhouse Dam on the St. Croix River in Baileyville; and

34 (b) Woodland Dam on the St. Croix River in Baileyville;

35 (2) At the following places, the area within the fishway and within 75 feet of the
36 downstream mouth of the fishway is closed to fishing at all times:

1 (a) East Grand Lake Dam in Forest City Township, T9 R4 NBPP, except
2 that fishing upstream from the dam at the top of the fishway is lawful;

3 (2-A) At the following places, the area within 75 feet of the mouth of the
4 fishway is closed to fishing at all times:

5 (a) Spednic Lake Dam in Vanceboro;

6 (3) At the so-called ice control dam on the Narraguagus River in the Town of
7 Cherryfield, the area within 100 feet of the dam must be closed to fishing at all
8 times;

9 (4) At East Outlet Dam in Sapling Township, T1R7, in Somerset County and in
10 Big Moose Township, T2R6, in Piscataquis County at the outlet of Moosehead
11 Lake, the fishway and the area within 50 feet of any part of the fishway must be
12 closed to fishing at all times; and

13 (5) There is no fishing in or from the fishway at the Sheepscot Lake Dam in the
14 Town of Palermo in Waldo County, Chain of Ponds Dam in Chain of Ponds
15 Township in Franklin County ~~or~~, Long Pond Dam in Seven Ponds Township in
16 Franklin County, Beaver Pond Dam in Seven Ponds Township in Franklin
17 County and Little Island Pond Dam in Seven Ponds Township in Franklin
18 County;

19 B. All waters within 200 feet of any fish hatchery or rearing station; and

20 C. The property owned by the Unity Utilities District located on Route 139 and
21 Prairie Road in the municipality of Unity in Waldo County.

22 For purposes of this subsection, "operational" means a fishway capable of fish passage
23 whether or not it is allowing the passage of fish at any given time.'

26 **9-A. Record inspection.** Records retained as required in this section must be open
27 for inspection by the commissioner or the commissioner's agent.'
