1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 21-A MRSA §334**, as amended by PL 2009, c. 253, §16, is further
3 amended to read:

4 **§334. Qualification of candidate for primary nomination**

5 A candidate for nomination by primary election must file a primary petition and
6 consent under sections 335 and 336. ~~The~~ A candidate for federal or county office must
7 be enrolled, on or before March 15th, in the party named in the petition, and a candidate
8 must be eligible to file a petition as a candidate for nomination by primary election under
9 section 144, subsection 3. The registrar in the candidate's municipality of residence must
10 certify to that fact on a form designed by the Secretary of State.

11 **Sec. 2. 21-A MRSA §335, sub-§§1 to 3**, as enacted by PL 1985, c. 161, §6, are
12 amended to read:

13 **1. Content.** A primary petition must contain the name of only one candidate, ~~his~~ the
14 candidate's place of residence, his the candidate's party, the name of the party from which
15 the nomination is sought, the office sought and electoral division. A primary petition
16 may contain as many separate papers as necessary and may contain the candidate's
17 consent required by section 336.

18 A. When 2 United States Senators or 2 county commissioners are to be nominated,
19 the primary petition must contain the term of office sought by the candidate.

20 **2. By whom signed.** A primary petition may be signed only by voters of the
21 electoral division ~~which~~ that is to make the nomination and who are enrolled in the party
22 ~~named in the petition~~ from which the nomination is sought. Other signatures are void.

23 **3. How signed.** The voter must personally sign ~~his~~ the voter's name in such a
24 manner as to satisfy the registrar of ~~his~~ the voter's municipality that ~~he~~ the voter is a
25 registered voter and enrolled in the party ~~named on the petition~~ from which the
26 nomination is sought. Either the voter or the circulator of the petition must print the
27 voter's name.

28 **Sec. 3. 21-A MRSA §335, sub-§7, ¶A**, as amended by PL 2009, c. 253, §17, is
29 further amended to read:

30 A. The circulator of a primary petition shall verify by oath or affirmation before a
31 notary public or other person authorized by law to administer oaths or affirmations
32 that the circulator personally witnessed all of the signatures to the petition and that to
33 the best of the circulator's knowledge and belief each signature is the signature of the
34 person whose name it purports to be; each signature authorized under section 153-A
35 was made by the authorized signer in the presence and at the direction of the voter;
36 and each person is enrolled in the party ~~named in the petition~~ from which the
37 nomination is sought and is a resident of the electoral division named in the petition.

38 **Sec. 4. 21-A MRSA §341** is enacted to read:
