14 15 16 17	This amendment replaces the bill, which creates a new crime of verbally soliciting a child to commit a prohibited sexual act. This amendment repeals the current law that makes it a crime to solicit a child by use of a computer and provides that a person may not solicit a child by any means for the purpose of engaging in a prohibited sexual act.
