### An Act To Amend the Maine Life and Health Insurance Guaranty Association Act

#### 1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 24-A MRSA §4386, sub-§1, as enacted by PL 1981, c. 347, is amended to read:

4 1. Insolvency; assets disbursed. Within 120 days of after a final determination of insolvency of a company by a court of competent jurisdiction of this State, the receiver 5 shall make application to the court for approval of a proposal to disburse assets out of the 6 company's marshaled assets, from time to time as those assets become available, to the 7 8 Maine Insurance Guaranty Association, to the Maine Life and Health Insurance Guaranty Association and to any similar organization in another state. The Maine Insurance 9 10 Guaranty Association, the Maine Life and Health Insurance Guaranty Association and any similar organizations in other states shall be are referred to, collectively, as the 11 associations. 12

In determining the application of the provisions of this subsection in a situation in which a person could be covered by the association of more than one state, whether as an owner, payee, beneficiary, enrollee or assignee, this chapter must be construed in conjunction with other state laws to result in coverage by only one association.

"Owner" with respect to a policy or contract and "policyholder," "policy owner" and "contract owner" mean the person who is identified as the legal owner under the terms of the policy or contract or who is otherwise vested with legal title to the policy or contract through a valid assignment completed in accordance with the terms of the policy or contract and properly recorded as the owner on the books of the insurer. "Owner," "policyholder," "contract owner" and "policy owner" do not include persons with a mere beneficial interest in a policy or contract.

Any person receiving benefits under this chapter is deemed 25 to have assigned that person's rights under, and any causes of action against any person 26 27 for losses arising under, resulting from or otherwise relating to, the covered policy or 28 contract to the association to the extent of the benefits received because of this chapter 29 whether the benefits are payments of or on account of contractual obligations, 30 continuation of coverage or provision of substitute or alternative coverages. 31 association may require an assignment to it of these rights and cause of action by any 32 payee, policy or contract owner, beneficiary, insured, enrollee or annuitant as a condition precedent to the receipt of any rights or benefits conferred by this chapter upon that 33 34 person. The association is subrogated to these rights against the assets of any impaired or 35 insolvent insurer.

The subrogation rights of the association under this subsection must have the same priority against the assets of the impaired or insolvent insurer as that possessed by the person entitled to receive benefits under this chapter.

In addition, the association has all common law rights of subrogation and any other equitable or legal remedy that would have been available to the impaired or insolvent insurer or owner, beneficiary, insured, enrollee or payee of a policy or contract with respect to the policy or contract, including without limitation, in the case of a structured settlement annuity, any rights of the owner, beneficiary or payee of the annuity, to the extent of benefits received pursuant to this chapter, against a person originally or by

- succession responsible for the losses arising from the personal injury relating to the annuity or payment therefor, excepting any such person responsible solely by reason of serving as an assignee in respect of a qualified assignment under Section 130 of the federal Internal Revenue Code.

#### SUMMARY

23 This bill amends the Maine Life and Health Insurance Guaranty Association Act to 24 incorporate changes adopted by the National Association of Insurance Commissioners in 25 its 2017 amendments to its Life and Health Insurance Guaranty Association Model Act. Under the bill, for insolvencies and impairments occurring on and after July 1, 2018, 26 27 health maintenance organizations are made members of the association and assessments 28 arising out of long-term care insurance business, which are currently allocated entirely to 29 the health insurance account, are divided equally between the life and health insurance 30 The bill also makes various conforming amendments and technical industries. corrections to the Maine Life and Health Insurance Guaranty Association Act and the 31 32 Insurance Rehabilitation and Liquidation Law.

The bill allows an insurer that is a member of the Maine Life and Health Insurance Guaranty Association and is not subject to premium taxation to take the tax credit for certain assessments of the association against its income tax liability to this State. An insurer that is a member of the association and is exempt from both premium taxation and income taxation in this State may recoup these assessments by a surcharge on its premiums in an amount reasonably calculated to recoup these assessments over a reasonable period of time, as approved by the Superintendent of Insurance.
