**THE PRESIDENT**: Because the Senate is extraordinarily efficient and because I wanted to get all our bills referred to committee and down to the other Body so that we could move things along, I turned the schedule on its head. As you know, the Senate President rarely gets to speak to you on the record officially. Perhaps if you are lucky I won't come down off the rostrum any time during the session either. I did want to speak with you for just a few moments today as we close our business. I've done it in reverse order so that we could get our business done. One, welcome back and I am genuinely glad to see all of you. I think that the work we did together, and I do mean together, has paved the way for us to get through yet another difficult session. The relationships that we built, the personal relationships as well as the professional relationships, will serve us well.

Just \$438 million to go. Is that correct Senator Diamond and Senator Rosen? We can do it. Against all odds, last session we achieve a budget that was balanced with the two parties working together. We're going to do it again. We did this with principled partisanship. One of my favorite writers is E.J. Dionne. That's the way he describes true partisanship. It is principle because neither side has all the answers. If we challenge one another respectfully, professionally, we can get to the right answer because we have the common goals of shared sacrifice, dedication to efficiencies, and commitment to investing to Maine's future.

While we struggle to fund oil purchases for those shivering without us, we invest in dreams. Nothing less in the form of new energy sources such as wind and corridors to make transmission possible, wood pellets, and electric grids strong enough for tomorrow's needs. We will not shrink from those investments. We cannot.

While we see the state support for education being trimmed, we take pride in award winning innovative programs such as expeditionary learning at the King Middle School in Portland where two of my grandchildren are being well prepared for tomorrow's needs. A documentary was just made of that school to be shown around the nation to demonstrate best practices. Nothing happened in the school except good leadership and commitment from community and families. A lesson to be learned right here in our own backyard. We take pride in the entrepreneurial training programs at the University of Maine at Orono and in the research and development efforts that have led to composites and biotech breakthroughs. We take pride and we must support those dedicated teachers and professors who have so ably lifted our children's spirits and their horizons. Let me compliment the Community Colleges. Just last week they announced their own foundation. We laud efforts to find private partners to help our public efforts but we also have to support the backbone of this essential system.

Let me compliment also our State employees. Former Governor Angus King said he spent eight years trying the find that little man in the basement shoveling money into the furnace. He never did. Our State employees feel the hot breath of frustration and they are the ones making everything we want to do work. They process our tax returns without which we would have no revenue. They spent the last week searching for a missing teenager in my Senate district in China. They do this without fanfare or glory. They do it because they are dedicated. They protect children from abusive homes. They protect the elderly from exploitation. They issue our drivers licenses. They clean the corridors that you walked in to get here today. We're going to respectfully try to recognize the quality of these services and to reward those who dedicate themselves to public service.

What are the minimum things we have to do? We have to balance the budget and we will. We have to avoid the temptation to take out our frustrations on any unpopular group. We have to watch the federal healthcare legislation to see how it's going to help Maine people. We must be mindful of those suffering from mental illness, of our elderly in need of shelter and care, and our children who may be suffering from abuse, hunger, or neglect. We must preserve and enhance opportunities for job creation and protection whether through good incentives, partnerships, or the tax code.

When we, as a Senate, work together to address Maine's problems we will come out of this global recession stronger than when we went in but things will not look the same. If we honor and protect our core Maine values we will preserve the special Maine we all love and we will create opportunities for our children and grandchildren. Getting through hard times with a sense of community is the Maine way. We can do no less. We are strong. We are compassionate. We are tough. We are Maine.

Let's get to work. I couldn't be prouder to be working with all of you, both parties, leaders from both sides, and all of you from the committees of policy jurisdiction. Thank you for being here today and thank you for still having a smile on your faces. When things get tough just go out and have a cup of coffee together. Senator Hastings and I can show you how best to do that. That's an inside joke that we had this morning getting on the elevator. At any rate, welcome back and we do indeed have a tough session ahead but that is why we were sent here. As my husband, the old Marine, says, 'When the going gets tough the tough get going.' That's what we are going to do. Senator RAYE: Thank you, Madame President. I just wanted to rise very briefly to compliment you. Madame President, on your opening remarks for this, the second session, and just to take a moment to acknowledge what it is that we face as we begin this session. We know that it is going to be a difficult and challenging session. We know that the members of the Appropriations Committee have already been engaged in the hard work of setting the path for the decisions that will be made in the coming weeks. I do agree that in the last session we saw a positive tone of, as the President said, principled partisanship which bridged itself into a healthy bi-partisanship. I do hope that this spirit can remain intact and will help to guide us through the weeks ahead of this, the second session. As we look ahead to the difficult budget decisions, we know that we have a blueprint from the Chief Executive and it is our responsibility to consider it very carefully and to go through it to see where we can make improvements to it and hopefully reach a consensus that will honor the spirit of that budget with respect especially to not imposing an increased burden on the taxpayers of Maine. We are going to be in a position where we are going to have to make tough commonsense decisions and establish priorities just as Maine people do every day around their kitchen tables as they struggle to deal with the economy. Together I think we can look forward to a productive session. It's good to be back and to see all of you and look forward to working with everybody in the chamber, on both sides of the aisle, and to work together to make the right decisions for the people of Maine. Thank you, Madame President.
