**JOINT RESOLUTION
RECOGNIZING THE 81ST ANNIVERSARY OF THE
ATTACK ON PEARL HARBOR**

WHEREAS, on December 7, 1941, without warning and minutes before 8 a.m., aircraft of the Imperial Japanese Navy and Air Force attacked United States military installations at Pearl Harbor and elsewhere on the island of Oahu, Hawaii; and

WHEREAS, the bulk of the attack at Pearl Harbor lasted for approximately 5 hours, during which 2,403 members of the United States Armed Forces were killed or mortally wounded, 1,247 members of the Armed Forces were wounded and 57 civilians lost their lives; and

WHEREAS, President Franklin Delano Roosevelt declared the day of the attack on Pearl Harbor "a date which will live in infamy," and the people of the United States became united in remembrance of the fallen and committed to defending the United States against all aggressors; and

WHEREAS, the following day, on December 8, 1941, Congress declared war against Japan and 3 days later against Germany, thus beginning the United States' involvement in a global conflict that would define a generation; and

WHEREAS, after nearly 4 years of warfare, on September 2, 1945, after victory on the European front, World War II ended with the Japanese surrendering aboard the USS Missouri; and

WHEREAS, on August 23, 1994, Congress enacted Public Law 103-308, which designated December 7th of each year as National Pearl Harbor Remembrance Day and requests the President to issue each year a proclamation calling on the people of the United States to observe National Pearl Harbor Remembrance Day with appropriate ceremonies and activities; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the 81st anniversary of the attack on Pearl Harbor and the lasting significance of National Pearl Harbor Remembrance Day and to honor both those who survived the attack and all those who paid the ultimate sacrifice and gave their lives in defense of freedom and liberty during World War II.

Now, if any of you are like me, I didn't understand half of what they did but I am just totally impressed that they not only understood it but were able to do it. Reflecting on this experience Evan said, 'The challenges helped me learn how to work as a team and made me want to research more about real-life problems and solar power.' As a new generation of code experts, computer scientists, and robot designers, the lessons learned from this competition go far beyond robotics. Teamwork is a lifelong endeavor at school, with your family and friends, in the

community, at work that will benefit you and your peers. Learning more about real-life problems will help you become aware, compassionate, and responsible citizens who can make a difference in the world and you've already started doing that. As I close, I'd like to say congratulations to the Electronic Mustangs: Joshua, Evan, Hudson, Aryanna, Adele, Beryl, Andrew, Audio, and Charlotte, and the Mustangs' coaches, Holly and Robyn. I'm honored to present you with the Legislative Sentiment today for winning the Robot Design award at the Maine State LEGO League Championship. Thank you, Mr. President.

WHEREAS, Friday, January 27, 2023 is International Holocaust Remembrance Day and marks the 78th anniversary of the liberation of the Auschwitz concentration camp; and
WHEREAS, the year 2023 also marks the 80th anniversary of the Warsaw Ghetto Uprising; and
WHEREAS, the Legislature recommits itself to combating the global rise in antisemitism; and
WHEREAS, 34 member countries of the International Holocaust Remembrance Alliance, of which the United States is a member, have adopted a legally nonbinding working definition of antisemitism; and
WHEREAS, the working definition reads as follows:
"Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities"; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize International Holocaust Remembrance Day and the working definition of antisemitism.

Senator **ROTUNDO:** Thank you, Mr. President. Mr. President and colleagues of the Senate, I rise today to recognize that January 27th is the International Holocaust Remembrance Day, an annual day of reflection. camp in 1945. JOINT RESOLUTION - Memorializing Allen Laird Miller, of Arrowsic. After teaching English at the International College in Beirut, Lebanon, Mr. Miller settled in Brunswick in 1971 and taught English at West Harpswell School. He then founded and ran the Young People's Theater in 1972 and a few years later the Summer Theater Project. He also studied mime at Celebration Barn in South Paris and created and performed as Clown Al. In 1986, his theaters, now called The Theater Project, found a permanent home in Brunswick. He taught classes in acting, storytelling, playwriting and directing and conducted workshops for teachers. He also taught in prisons, retirement centers and schools from Aroostook County to Michigan to Palestine and worked with organizations, including Spindleworks and The Telling Room, to reach differently abled people, recently settled refugees and children and adults from historically clashing cultures. Mr. Miller will be long remembered and sadly missed by his family and friends and all those whose lives he touched;

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI:** Thank you, Mr. President. Women and men of the Senate, I rise to honor the life and memory of Al Miller, my friend and neighbor. I have known Al for decades. I knew him first as a teacher. Sometime in the mid 70's he came to Chewonki as a visiting teacher, where I was in residence. My sister, herself a student at Chewonki's Maine Reach program, was learning about environmental education. She and Al and a group of kids went out onto the salt marsh to see what they could find. Back indoors, Al offered a theatrical interpretation of what they had seen and coached the students to play along, some acting as sea grass, tall and waving, others as mud oozing and sticky, and still others imagined they were the clams, burbling in the mud, opening and closing their shells. For my sister, an aspiring teacher, that experience was an eye opener about the use of creativity and imagination in engaging learners in science.

Al was a clown as well as a teacher. His license plate spelled out LAUGH and he was known to don a red clown's nose at seemingly random moments. Even without the red nose, Al's smile and good humor were infectious and bound to brighten anyone's day. As neighbors, we would meet at the mailboxes, on walks down our rural road, or at the local farmer's market. Not surprisingly, we developed many friends in common and we kept in touch through our various comings and goings over the years. Al's warmth and genuine interest always came through, whether we'd just seen each other the day before or not for the past many months. When Al moved to Arrowsic, he was instantly a treasured member of our community.

Around Christmas time parents and community members would gather at our small town hall and watch in amazement as Al and our children told the story of the Red Mitten, the magical Red Mitten, or the monster of Sewall Pond, using little else but their imaginations. My youngest son, who took part in these shows, recalls the gusto and enthusiasm that Al brought to their rehearsals saying, 'If I weren't so shy he could have made an actor out of me.' I recall any number of informal dinners at Al's house just down the road with other neighbors or visiting international friends from Al's numerous trips abroad. Sometimes local musicians, the likes of Brad Terry, would perform for us before dinner or after dinner we'd assemble in the other room and read excerpts from a book or a play that Al was interested in. Al was always a generous and gracious host.

And that wasn't all. Al was an actor, director, stage manager, and producer of plays from Shakespeare to Beckett, as well as several local playwrights. Al's journey to the world of theater was a circuitous one, as many such journeys are, but as I understand the story, it was while teaching overseas in Lebanon that Al first tasted theater and the magic and fun of dramatic performance. His teaching morphed after that and he began using the tools of imagination, play, and creativity to spark learning. He established the Young Peoples Theater, a traveling troupe of acting students and, ultimately, the Theater Project in Brunswick, where it still has a home. As a devoted audience member, I remember looking forward to each season and, being a repertory group, we got to know the actors well over the years, including many of the young people who started out in theater classes and then took on more challenging roles. Most evenings, as the director or perhaps a character in the play, Al would come out before the performance and welcome us to the theater, thank the community for its support, and encourage all of us to enjoy the production. I don't ever remember being disappointed in the caliber of the production and, in fact, was always amazed at the troupes' ability to turn a

relatively small space into so many different worlds so convincingly. The magic of make believe worked under Al's guidance. My parents were lifelong theater buffs, so when they moved to the area they would often accompany us to productions at the Theater Project and they got to know Al and the rest of the gang as well. Both my sons benefitted from participating in theater and, while I never had the desire or, frankly, the talent to take center stage, I often worked backstage and had a few walk-on parts early in my career.

All of this is to explain why, when my parent's 50th wedding anniversary rolled around, my siblings and I decided that in lieu of a big bash, which we knew our parents would not be crazy about, we decided to establish a scholarship fund in their name at the Theater Project so more young people could find themselves through the magic of theater. To fund it, and this was before the GOFUND ME era, we turned to the extensive list of friends and colleagues my parents had cultivated over the years and asked them to contribute, and they did. In honoring my parents, the Vitelli Scholarship Fund paid tribute to the contributions of Al Miller and the community of actors, clowns, and teachers that he has inspired. He made all of our lives more enjoyable and, simply, more fun. He is sorely missed. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Daughtry.

Senator **DAUGHTRY:** Thank you, Mr. President. Women and men of the Senate, I also rise to honor the extraordinary life of Al Miller. Some people leave an indelible mark on your lives and, for me, that was Al Miller. Without him I don't know what my life or, frankly, where I live would look like today. Some of my earliest memories are of Al and my first as being roughly about mouse-sized along with many other kids, being crouched in our imagined animal form, as all around us Al spun the completely magical story of the Mitten. He was an incredible storyteller, and my Apple watch is trying to get in on the play too. He was an incredible storyteller and we're always transfixed and absolutely transported by his work. Some of my first experiences watching theater were at the Theater Project. I still vividly remember barely being able to see over the front seat in front of me, probably crouched next to either my parents or Lars or Charlene Rydell. I remember the thrill of getting to see Al come out on stage. The thrill was completely matched by all of the children being asked to come onto stage to join him. Being on stage, whether as a mouse or as part of the machine in one of his many theater games, always felt safe and felt like home. He was like the Pied Piper of theater and of children. He could get even the meekest children out of their shell, not that even at that age I was particularly meek or shy, but I watched him work some magic with many of my friends.

From an early age, I was hooked and quickly became a member of the Young Peoples Theater as soon as I was old enough. Al's theater troupe was not your usual acting experience. It wasn't about just merely memorizing lines and making sure you could find your cues on the stage. It was about becoming comfortable in your own skin. It was about being able to envelop and become the characters. It was teaching you to speak and, most importantly, to listen and work well with others. He was bit on improv. He taught you to be quick on your feet, listen, and make due with whatever cue was thrown at you and, frankly, it was probably one of the most important lessons of my life. It was also theater in the round, which I think is a great, you

know, analogy for all of our lives. You never know if something's going to be in front or behind or wherever it's going to be, but you have to make sure that you're able to find your way through.

Later, in my teenage years, the Theater Project was even more important. I think we can all agree that being a teenager is rough, even in the best of times. Often we, as adults, discount teens or dismiss their experiences or stories and that was never the case with Al. He lifted our voices up and he helped us see the value and worthiness in all of our struggles, no matter how small they may seem. I can remember speaking with him on all sorts of matters and him encouraging, while also challenging, me to be the best version of myself.

Yearly, he held an improv-based play called Voices in the Mirror where he would challenge all of us to write our own skits and our plays based on our own experiences. As the good Senator from Sagadahoc said, Al would introduce every show and he would introduce our teenage play with the same (unintelligible) as Shakespeare. I spent every summer I could in the Theater Project and I know we all like to joke that Maine is a small world but I was one of the children that was the beneficiary of the exact scholarship that the good Senator from Sagadahoc mentioned. I kind of wonder, and feel like we need to go back through some photos to see if she was at any of my productions. More than anything else that I took as a child, whether it was piano lessons, dance, or music, everything I learned in the Theater Project from Al serves me the most every day.

Finally, in my final 'it's a small world,' when I was at the Theater Project I liked to sit in front of the theater and draw and I would often sketch a certain house that was across the street and I can remember talking to Al quite a few times, as I probably drew the building for about the fourth or fifth time, about what it would be like to live in that house. Fast forward to seven years ago and the house came up on the market. When I bid on it I told them about my love of the Theater Project and showed them a few of my drawings. It's now my home. Every single morning I get to open my blinds in my bedroom and look out and there's the Theater Project. No matter what chaotic, imaginary chaos, that's going on in our lives, no matter what intense vote is coming before us in this Senate, I open those blinds, I see the Theater Project, and I remember all of Al's lessons, whether it's remembering to stand up, to enunciate, to make sure that you are projecting your voice. But, honestly, the lesson that I take with me every day, and I will be forever grateful for, is to laugh, and I think if there's one thing that Al would want us to take with us is to bring that joy and that laughter into all of our hearts. He'll be greatly missed and thanks for letting me share the story.
