**JOINT RESOLUTION  
RECOGNIZING FEBRUARY 2023 AS  
BROWNTAIL MOTH AWARENESS MONTH**

WHEREAS, browntail moth populations in Maine have been in an outbreak phase since 2015, and the browntail moth is not a pest that can be eradicated; and

WHEREAS, most areas of Maine, especially settled areas that have significant host tree populations, including oak, apple, crabapple, pear, birch and cherry trees, are at risk; and

WHEREAS, long-lasting tree defoliation caused by browntail moth caterpillars is a major concern, and browntail moth caterpillars shed microscopic, toxic hairs that can cause a person to have trouble breathing or suffer skin irritation similar to poison ivy; and

WHEREAS, state agencies are committed to coordinating within State Government, with local communities and directly with citizens to respond to the problems posed by browntail moth populations; and

WHEREAS, winter is the best time to clip and destroy browntail moth webs that are safely within reach or to hire licensed arborists or licensed pesticide applicators to reduce populations that are out of reach; and

WHEREAS, comprehensive browntail moth information and tools collected by state agencies and the University of Maine, including research, infestation tracking and the answers to frequently asked questions and other educational resources, can be obtained by dialing 211 or visiting 211maine.org; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize February 2023 as Browntail Moth Awareness Month and encourage the citizens of the State to learn about browntail moths by dialing 211 or visiting 211maine.org.

**JOINT RESOLUTION  
TO RECOGNIZE THE LIVES AND ACCOMPLISHMENTS OF  
BLACK MAINE CITIZENS REUBEN RUBY, GEORGE  
THOMPSON RUBY, MARY DALY DICKSON AND  
LOIS ANN DICKSON RICE  
DURING BLACK HISTORY MONTH**

WHEREAS, Maine's Black history and the story of Maine's Black citizens and their accomplishments and contributions are barely remembered today; and

WHEREAS, Reuben Ruby, a Black man, was born in Gray in 1798; and

WHEREAS, Mr. Ruby was the first person in the State to have a taxi, then known as a "hack," and one of his riders was William Lloyd Garrison, who was given a tour of Portland by Mr. Ruby before the Boston abolitionist joined Portland's Black leaders at Mr. Ruby's home for dinner; and

WHEREAS, in the place where Mr. Ruby's hack stand was located, on the corner of Temple Street and Federal Street, there is placed, as part of the Portland Freedom Trail, a stone monument recognizing the business; and

WHEREAS, Mr. Ruby was only 29 years of age when he became an agent for Freedom's Journal, the first Black-owned newspaper in the country. In October 1834, he was the only Black person among those representing the City of Portland at the forming of the Maine Anti-Slavery Society in Augusta; and

WHEREAS, Mr. Ruby was one of 2 Black persons sent to represent Maine at the Fifth Annual Convention for the Improvement of the Free People of Color, held in Philadelphia in 1835. The convention elected Mr. Ruby as its president; and

WHEREAS, Mr. Ruby was elected a vice-president of the American Moral Reform Society, a national group led by James Forten, a Black abolitionist from Philadelphia. In 1840, Mr. Ruby was elected president of the Manhattan Anti-Slavery Society in New York City; and

WHEREAS, Reuben Ruby's son, George Thompson Ruby, was the first Black graduate of Portland High School; and

WHEREAS, George Thompson Ruby was elected to the Texas state Senate during Reconstruction and was a delegate to the 1868 Republican National Convention in Chicago and the party's convention in Philadelphia 4 years later; and

WHEREAS, Lois Ann Dickson Rice, a Black woman, was born in Portland and went on to become valedictorian at Portland High School in 1950 and class president of Radcliffe College in 1954. She became national vice president of the College Board

and is considered "the Mother of the Pell Grant," a federal financial aid program that benefits millions of students each year; and

WHEREAS, in 1950, her mother, Mary Daly Dickson, was named Maine Mother of the Year, becoming the first Black woman to gain that honor; and

WHEREAS, Lois Ann Dickson Rice's legacy of achievement continues in her daughter Susan Rice, who was United States Ambassador to the United Nations and then National Security Advisor in the administration of President Barack Obama and has been tapped to run the Domestic Policy Council under President Joe Biden; and

WHEREAS, Maine's Black citizens have a long history of accomplishments that should be remembered and celebrated; and

WHEREAS, from the Revolutionary War through the abolitionist movement, to marches from Selma to Montgomery and across America today, and in this State, African Americans in Maine have remained devoted to the proposition that all of us are created equal, even when their own rights were denied; and

WHEREAS, the month of February is officially celebrated as Black History Month, which dates back to 1926 when Dr. Carter G. Woodson set aside a special period of time in February to recognize the heritage and achievements of African Americans; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to honor during Black History Month the contributions of African Americans in Maine's and the nation's history and encourage all people in the State to learn more about the past and to better understand the experiences that have shaped the State and the nation.

**READ and ORDERED PLACED ON FILE.**

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Mr. President. I wish to rise briefly to speak to the qualifications of Justice Douglas for appointment to the Maine Supreme Judicial Court. Justice Douglas' path to the bench speak of a life of dedication, hard work, and compassion. As a teenager, Justice Douglas worked in the tobacco fields in Connecticut and in a paper mill. He started to consider a legal career due to his work in the mental health field. His work in Superior Court is noteworthy for his participation in and championing the Treatment and Recover courts. He identified this work as a top priority for himself and for the state of Maine. He has also served a leadership role in the transition of the court operations in York County to the soon to be opened York Judicial Center. Those who spoke in favor of Justice

Douglas' elevation to the Supreme Judicial Court said that his noteworthy for his work ethic, one person observing that late in the day on sunny Saturdays in the summer Justice Douglas' car was the only car in the parking lot of the courthouse and he was there doing his work on behalf of the people of Maine. He was universally recognized to be thoughtful, reasonable, welcoming and calm, and to have a courtroom that demonstrated fairness to everyone in the room. Those who testified stated that he takes on the toughest challenges with a calm demeanor and that although he's elevation to the Supreme Court would be a loss for York County, it would be a win for the people of Maine. He is a wonderful candidate and I urge my colleagues to support his advancement to the Maine Supreme Judicial Court. It will be truly a win for our state. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you very much, Mr. President. Ladies and gentlemen of the Senate, I, too, rise today in support of the nominee. I've had two different occasions to converse with Justice Douglas, both in my office and in front of our caucus earlier this morning, and appreciate his flexibility with scheduling to come in and do that today given the pace at which this came out of committee and how quickly we've had to turn things around here to get this through today. I would echo the remarks of the Senator from Cumberland. I was impressed by the Justice's demeanor. I think he brings the right intangible qualities to the court and I also appreciated his judicial philosophy as he articulated that to my colleagues and I this morning and think that he'll be a welcome addition to the court and look forward to seeing the good things he's going to do on behalf of the people of the state of Maine. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Bailey.

Senator **BAILEY:** Thank you, Mr. President. Mr. President, men and women of the Senate, I want to just rise and echo the comments of the good Senators from Cumberland and Aroostook. I find Justice Douglas to be fair, competent, respectful, intelligent. I have practiced in front of him for, I don't know, a couple of decades now and I've always been impressed with both the knowledge - his knowledge of the law, his courtroom demeanor, the way he treated everyone fairly and respectful, and I would just say, having known and practiced in front of him for all those decades, the one thing I never knew about Justice Douglas, and I think this is true for all of our Judges in the state of Maine, is I know nothing about his politics and I know nothing about the other Judges in the state of Maine that I go before and that's because this state has a long tradition of confirming Judges based on their qualifications. Are they competent? Are they qualified? Do they have judicial temperament? That is the benchmark. I will tell you that serving on the Judiciary Committee, both in the House and now serving there again in the Senate, I have voted to confirm Judges appointed by Governors who were Republicans, who were Democrats, who were Independents, and that is always the criteria that I have used: are they competent, are they qualified, and do they have a judicial temperament, and Justice Douglas meets that criteria in spades. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE:** Thank you, Mr. President. Men and women of the Senate, I also have had the opportunity to get to know Justice Douglas very well. I first knew him when I was Senate President and he was legal counsel for Governor King, and I'm sure the good Senator from Oxford, Senator Bennett, remembers that time, and I will say we had a few tussles, we had a few disagreements. We always ended up fair and polite to each other and respectful of each other. And then I got to know him when he was first appointed to the District Court. Practicing in York County, and at the time I became D.A. I dealt a lot with him and a lot with the Justices - Judges in the District Court. And I have to tell you the District Court is one of the most time-consuming courts out there. The Judges who serve there really do a tremendous amount of work and I know Justice Douglas was reluctant to leave the District Court because he felt there was so much there and so many important things to be accomplished in the District Court that were very important in average people's lives, but he filled the vacuum when he came up to the Superior Court in York County. We lost two long-standing, great Justices to retirement: Justice Brennan and Justice Fritzsche, and there was a big vacuum in the Superior Court and he came up and filled that. And I practiced before him as a private attorney, as District Attorney. I've seen his work on family law issues, other issues, things he's been involved with that have become law here regarding the Parentage Act and different issues before us. He is one eminently qualified to be on the Supreme Court and I hope you will join me in supporting his nomination.

Senator **ROTUNDO:** Thank you, Mr. President. Colleagues of the Senate, I rise speak in favor of L.D. 206, the Supplemental Budget that's before this Body, having earned unanimous bipartisan support in the Legislature's Appropriations and Financial Affairs Committee. My colleagues and I in Appropriations worked hard to craft a Supplemental Budget that reflects the testimony we heard from the public, the recommendations we received from the Joint Standing Committees, and the needs of the state. The result is a common-sense Supplemental Budget that contains no new programs. Instead it insures that the State will meet its obligations to Maine people and pay its bills through the end of the fiscal year. It also insures that Maine abides by its constitutional mandate for a balanced budget. None of this would have been possible without the input of those in this Chamber and we are grateful to you for taking the time to participate in the public hearing and work session process. I also want to thank my colleagues on the Appropriations Committee, in particular the Senator from Cumberland, Senator Duson, and the Senator from Oxford, Senator Bennett, for their thoughtful and conscientious work on this budget. I appreciate having wonderful partners in both Chambers to work with. I look forward to continued collaborative work as we undertake the biennial budget. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. First, let me say I respect very much the bipartisan effort that's gone into crafting this Supplemental Budget. That said, I will be voting no today and I just wanted to very briefly register as to why. In the Supplemental Budget we are appropriating millions more to systems that currently have in place a discriminatory COVID-19 vaccination mandate against healthcare workers and students and I cannot, in good conscience, vote to appropriate millions

more to those systems while that mandate is in place. So, I will be voting no today. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Mr. President. Fellow members of the Senate, first of all I'd like to thank the Senator from Androscoggin, Senator Rotundo, for her gracious words and her excellent leadership, inclusive leadership of the Appropriations Committee. It's not an easy job and I'm grateful that our Committee has such a leader on it. I would just say that, you know, budgets like this are a compromise. There are things in it that I like a lot. There are things in it I don't particularly care for. But we do have to pass this budget. It's important to have optimum functioning of this government for the rest of this fiscal year. You know, this budget is - it doesn't spend a lot of money. Most of the money that we had, as we all recall, was spent in L.D. 3, which was the actual Supplemental Budget passed this year. But this budget takes care of a lot of important functions. There are some reclassifications that are well overdue, some three years old that came out of labor disputes that we need to honor. Some reorganizations of state government and some funding of some needed systems, including legal services for the indigent which, as we all know, has been underfunded and has been a Constitutional obligation for this Legislature for far too long. So, I encourage passage of this and even if you may not like aspects of it I'm sure that you will all be better off for putting this behind us and moving on to the biennial budget which we're already having hearings on and it's always good to see the progress on that happening so rapidly as well. So, thank you, Mr. President.

This being an Emergency Measure and having received the affirmative vote of 23 Members of the Senate, with 6 Senators having voted in the negative, and 23 being less than two-thirds of the entire elected Membership of the Senate, **FAILED ENACTMENT**, in **NON-CONCURRENCE**.
