**THE PRESIDENT:** The Chair would recognize the Senator from Cumberland, Senator Pierce.

Senator **PIERCE:** Thank you, Madam President, Men and Women of the Senate. As we continue our celebration of Women's History Month, I am honored to highlight some of Maine's first female legislators. I take you back to 1927. There is no Cross Building, most people are arriving into Maine via horse or by boat. The Kennebec is in full flow, and here we are. Dora Pinkham, a Republican from the County, and Katherine Allen, a Republican from Hampden, were the first two women who served in the Maine Senate. You'll see on your desk that I handed out the picture of that year, with both of those people included. We also had a number of women in the House. Mabelle Chaney, Maude Clark Gay, Blanche Folsom, Gail Laughlin, and they were also serving in the House at the same time.

Today, I'll focus on Dora Pinkham. Her life and legacy are especially meaningful to me because Dora was the first woman to serve in the Maine House in 1923 and then came over to the Senate. And I am a part of the first all-female Senate Democratic leadership team, alongside Leader Duson and President Daughtry.

Pinkham was born in New Limerick, Maine, in 1891, and grew up in Fort Kent, the crown of Maine. After earning her bachelor's at Mount Holyoke College and a master's from Columbia University, she worked in the Department of Labor in Washington DC before returning to Maine to teach at Madawaska Training School for Teacher Education. She also worked as a bookkeeper for the local Fort Kent Bank and served as a special agent to the United States Children's Bureau. Three years after women were granted the right to vote, Pinkham ran to represent her committee in the Maine House, having built an impressive career. Pinkham knocked off two-term incumbent to represent parts of Fort Kent and Wallagrass in the House. At only 31, Pinkham's election made her the first-ever woman to serve in the Maine Legislature. She was only one of nine women who ran in 1922 to win her seat. From 1922 to 1924, Pinkham served on the Joint Committee on Public Health, the Maine Publicity Committee, the Joint Committee on Education, and several other ad hoc committees. Pinkham wanted Maine to help create health clinics, health education, midwife training to benefit the health of women and children. I find this especially moving as it demonstrates women's health issues have always been discussed at the State House for over a hundred years, and I am proud to carry on that conversation.

In 1926, she was elected to the Maine Senate, serving as one of three Senators from Aroostook County in 1930. She and Katherine Allen were the first women to serve in the Maine Senate. Senator Pinkham served on the Joint Standing Committee on Education, Public Health, State Prisons, and Interior Waters. She sponsored bills supporting Maine's highway and bridges - proud to have taken that vote today as well - funding for education, and health facilities, teachers' pensions and support of veterans and their dependents. So many of these issues Pinkham was fighting for are the subject of bills before our committees today. I'm inspired by her hard work and determined to continue to fight for these values.

After retiring from the Senate, Pinkham served as a Special Secretary to Maine Governor William Tudor Gardiner, a member of the State Advisory Council on Health and Welfare, an

American Red Cross volunteer, and president of Fort Kent's first Business and Professional Women's Club.

Pinkham leaves behind a legacy of commitment to the improvement of the lives of all Mainers and a promise to protect the welfare of women and children. She was often the only woman in the room, but was adamant that her voice would be heard loud and clear. On behalf of the Mainers she represented, may Dora's legacy be remembered, and her voice carried through these halls for generations to come.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Reny.

Senator **RENY:** Thank you, Madam President. Happy Women's History Month. Today, I rise in honor of Margaret Chase Smith. So, the exceptional Maine woman from Skowhegan who had a successful 24-year Senate career and was the first woman to serve in both Houses of Congress. So, she's a Mainer to be proud of for many reasons, but I personally am most impressed by her bravery and leadership in a dark time of U.S. history. I hope you all learned in school, as I did, about McCarthyism, often referred to as the Red Scare. At this time in history, the late 1940s and then 50s, there was an intense fear of communism and the Soviet Union in the United States. And the most notable examples of McCarthyism include the investigations of alleged communists that were conducted by Senator McCarthy, Joe McCarthy, and the hearings conducted by the House Un-American Activities Committee.

So, the primary targets for persecution were government employees, figures in the entertainment industry, academics, left-wing politicians, and labor union activists, typically. Suspicions were often seen as convictions by the people, despite inconclusive and questionable evidence, and the level of threat posed by a person's real or supposed communist associations and beliefs was often exaggerated. So, this ended up being a time of suffering for many. Many people lost their jobs and had careers destroyed as a result of crackdowns on suspected communists and some were outright imprisoned. Most of these reprisals were initiated by trial verdicts that later were overturned and laws that were later struck down as unconstitutional. However, a lot of damage had already been done. But in the midst of this time of fear and distrust, Margaret Chase Smith was in office and her choices remind me of a conversation I've had countless times with students, which is how much more difficult it is to stand up or to push back on your friends and your classmates than it is to stand up or push back against enemies or outcasts. And that is part of what made Margaret Chase Smith, I think, so remarkable.

I highly recommend reading Margaret Chase Smith's full speech when she did her Declaration of Conscience on June 1st in 1950. It's a little spicy, goes at both major parties kind of hard. I'm going to leave out the spicier parts today and just read a couple pieces.

From her speech: "As an American, I am shocked at the way Republicans and Democrats alike are playing directly into the communist design of confuse, divide, and conquer. As an American, I do not want a democratic administration whitewash or coverup any more than I want a Republican smear or witch hunt." And the final piece of that declaration, which was signed onto by I think six other Republicans in the Senate, is that "it's high time we stop thinking politically as Republicans and Democrats about

elections and start thinking patriotically as Americans, about national security based on individual freedom, and it's high time we all stopped being tools and victims of totalitarian techniques, techniques that, if continued here unchecked, will surely end what we have come to cherish as the American way of life." Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Bernard.

Senator **BERNARD:** Thank you very much, Madam President, and Ladies and Gentlemen of the Senate. I want to keep a good thing rolling here. It's my privilege to take a moment during Women's History Month to recognize someone who more recently put Maine on the map with her fearless, unorthodox, and selfless decisions.

Linda Greenlaw was born in 1960 in Connecticut. She was raised in Topsham and her family summered in Isle au Haut. She took a job as a cook and a deckhand on a swordfishing boat to pay her way through college - Colby College. After graduation with a major in English and government, her parents were shocked that she planned to go back to commercial fishing for her life's work. The truth is, she fell in love with swordfishing when she was just a child, and knew by the age of 19 that she would spend her life on the sea. It would've been nice for her parents to know that at the time. But as it turns out, none of her education was wasted. Perhaps she knew she would be sharing her exciting life through the written word. She has authored nine books, many that landed on the New York Times Bestseller list.

We have plenty of reasons to admire Linda Greenlaw. Taking the tack less traveled, if you will, her choice, loaded with risks, in search of those powerful fighting fish. Despite being told by various people that she was wasting her education, that swordfishing is no place for a woman, indeed, she is one of only a few who have taken on that challenge. Greenlaw was the first female swordfishing boat skipper on the American east coast and is recognized as one of the best captains on the entire east coast, bar none.

She was featured on the Discovery Channel on an episode called Swords: Life on the Line, and on the program Deadliest Catch. Linda was captain of the Hannah Boden and the last person to speak with the captain of the companion boat, the Andrea Gail. That vessel was tragically lost at sea in October of 1991 during perhaps the most powerful northeaster new England has ever experienced. In that event, many of you know, that spawned a book and a movie, The Perfect Storm. Linda provided expert and technical information for the movie, and her character was featured in the film.

But there's another reason to admire Linda Greenlaw. She likely saved the life of a troubled 15-year-old girl. The young girl was being abused by a man on Ilse au Haut, who everyone believed was her uncle. When the truth of the girl's situation came to light, the residents of the island nominated Linda to be her legal guardian. A new family was formed, which eventually led to a new book called Lifesaving Lessons: Notes from an Accidental Mother. By the way, that man is now in federal prison.

Greenlaw was the winner of the American Library Association's Alex Award in 2000, the United States Maritime Literature Award in 2003, and the New England Book Award for Nonfiction in 2004. During Women's History Month, I'm very proud to say Maine and the bold coast is home to an inspiration, Linda Greenlaw.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO:** Thank you, Madam President. Madam President, Ladies and Gentlemen of the Senate, I rise to introduce LD 609, the continuing services budget. This budget simply makes sure that the State of Maine is responsibly funded in the coming biennium and represents part one of the biennial budget.

The part two budget, which is yet to be negotiated, would include new initiatives and potentially address policy changes. This budget before you consists of baseline funding to keep the lights on beyond the current fiscal year. It provides the stability and reliability that Maine people deserve from their state government. It includes the supplemental items to close the MaineCare gap for this fiscal year and provides \$2 million for spruce budworm remediation. And it accepts some of the items that were included during the supplemental negotiations, cost-of-living increases for direct care workers and training for Maine's General Assistance administrators. It also funds the State's share of K-12 education at 55% for both years of the biennium so that school districts will know what to expect as they put together their budgets for the coming year. And while MaineCare is already funded in the baseline for the two years of the biennium, it also provides funds that were requested to fill the MaineCare gap for fiscal years '25 and '26.

This bill does not include any tax increases or any of the proposed cuts in the Governor's proposal. It contains only one new position. This is simply a continuing services budget that guarantees that the State will be able to continue to provide the services it currently provides at the current funding level. The baseline funding ensures that state-run entities like our state parks, the Bureau of Motor Vehicles, and courthouses stay open, that state employees continue to get paid, and that basic functions of state government will go on uninterrupted as of July 1st.

Passing this bill provides a measure of certainty to our communities against much upheaval and uncertainty at the federal level. We do not know what's coming down the road from Washington, but we do know that changes are coming in the way states will be funded. This baseline budget reassures Mainers that their state government will not shut down over political disagreements and demonstrates their representatives are committed to acting in a responsible and productive way.

The end of March is the deadline for enacting the continuing services budget that would be in place by July 1st. This has driven the timeline for this budget and it's why it is before us today. All of the items in the budget have received a public hearing. It is also in balance as required by the Maine Constitution. According to the nonpartisan Office of Fiscal and Program Review, this budget leaves us with over \$127 million in the General Fund.

During the part two budget process, we will grapple with reductions in federal funding, flattening state revenues, and healthcare costs. We will carefully consider how to meet these challenges, and it is my hope that we will do so in a way that makes our constituents proud and allays any concerns that our budget is out of control due to runaway spending. It is the part

two budget that we will take up new initiatives. Passing this continuing services budget today allows us to debate any discretionary spending in part two without pressure. We can even go back and make changes to the baseline budget if we decide to do so.

We have been down this road before. In the past two Legislatures, we have produced a continuing services budget, followed by a part two budget, that came out of the Appropriations Committee with strong bipartisan support. Those part two budgets received unanimous or near-unanimous bipartisan support in the Appropriations Committee. I would remind my colleagues that two years ago, we were so determined in Appropriations to get a two-thirds budget that we didn't adjourn until July. I invite my colleagues on Appropriations to work together again in the best interests of all of our constituents. I believe that dispensing with the continuing services budget will enable us to do our work on the part two budget without the threat of political disagreements derailing the process.

In May, we will receive a report from the Revenue Forecasting Commission detailing the state's financial outlook. In the meantime, we will keep an eye out for changes in federal funding. The Appropriations Committee will also begin the process in the coming weeks of voting on items from the Governor's proposal, with a goal of starting to craft the part two budget.

It is not going to be easy, and the choices we will face will most likely be painful, but the work will be made considerably easier with a knowledge that funding the basics of state government does not wait for the part two budgets. I have listened to those who want structural changes to MaineCare, and I am open to ideas in how to do so. I also know that major changes to our healthcare system will most likely be coming from the federal government. I look forward to a robust debate in the coming months on this subject.

When I first served on the Appropriations Committee, my current legislative aide was two years old. Truly. I have negotiated many budgets as a member of the majority party here in the State House and as a member of the minority party, and it was always with a goal of getting unanimous support in committee and a supermajority on the third floor. I have a good track record when it comes to negotiating two-thirds budgets, and my commitment to a supermajority budget in the 132nd session remains very strong. I do believe that the most responsible course of action for us to take at this point is to pass a continuing services budget. Our communities and the people we represent deserve this certainty in the uncertain times in which we live. Please join me in supporting this bill, and we will then move on to the part two budget. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you, Madam President, Ladies and Gentlemen of the Senate. I rise in probably what is probably obvious opposition to the pending motion.

This majority budget, which is as my colleague from Androscoggin County pointed out is now the third of those during the tenure of this Democrat regime since 2019 when the trifecta first occurred. And I think beyond even the policy elements here, which I'll get into in a minute, there is a very concerning dynamic at play here. And it's truly just about power at any -- at any cost. And that's really where I think we find ourselves now, looking at the third - I mean, once, sure, you could call it a fluke, twice is

highly problematic, but at this point, majority budgets are the new normal, brought on by complete Democrat control. This didn't happen when Republicans took complete control in 2010. They did not pass a majority biennial budget. And I think it's really unfortunate because what we have -- where we find ourselves heading, I think, is in a complete devolution of this branch of government. It is one that really could be the strongest in the State of Maine. I believe in the Legislative Branch, it's the closest one to the people, and yet, my colleagues have no problem at all silencing almost half of the people through these extraconstitutional moves. The protections were put in place specifically to avoid this, so that compromise and working together had to happen. Seriously had to happen. Unfortunately, by doing this, I think the only -- I heard a lot -- the word commitment used a lot. The only commitment that's being made tonight by the majority party is to completely ignore the minority. Again. For now the third biennial. It's unfortunate, I think, because I truly believe in this branch, I don't think we should be relegating ourselves to this approach. We could be, I think, the strongest, instead, we're just casting away our power to others. We don't look at the baseline, we don't review that, the Executive Branch just gets what they want, more spending -- I don't even like referring to these as budgets. Budgets invoke some semblance of fiscal constraint and sanity; what we have are spending documents each year. We have no review of so-called current services to figure out what was the point of spending money on something in the first place, did we accomplish that goal, if not, why, if yes, how. Are we doing the right things? We don't do that. In Appropriations, we look at this is baseline and then we add to it, baseline and then we add to it, baseline and then we add to it. That's what we do here. We spend, we spend, we spend, and we don't look -- we don't look backwards at all to even figure out if we got where we were hoping to get to, if we even knew that at the time. And this is just a continuation of that. So, you know, it's -- it's with a heavy heart that we find ourselves here entirely predictably. I think we knew this as soon as -- on election night, we knew what we were in for on our side of the aisle. It's unfortunate, but I think it's just a function of what's happened. And maybe we will continue down this road until and unless the political dynamics change. I think that's probably become pretty evident.

Now, to talk about the policy of this, I mean, it's -- it's -- to say it's inaccurate that this is a, quote, "continuing services document", is an understatement. It's not that. There certainly are policy decisions that are being made throughout this document. I'm looking at a lot of choices that were made in particularly the second year of the biennial that are completely ignored. And that's how we get to meeting this constitutional obligation which my colleague pointed out that the budget must balance. Well, sure, it's a two-year budget and if you just don't fund a bunch of things in the second year, yeah, you can get it to balance, but it's not legitimate. And if those same folks who were screaming last week about the need to be really careful and MaineCare and prioritize that policy and that program, well, you're now about to vote for something that guts it in the second year. I find that a little bit hypocritical.

So, if we're going to have a conversation tonight about where we're heading over the next two years, I want everybody to acknowledge some things, right, and vote accordingly - you all will, anyway, I think the fix is in on this thing, like I said, it has been for a while - but to message and brand this in such a way that it is a continuing services budget is false, and I hope that the

folks that are listening tonight, particularly those in the media, are picking up on this. All this is is a way to avoid working with the Republicans. Call a spade a spade, just say you don't want to work with us. It's fine, that's your choice, but let's be transparent about it. Faking the satisfaction of the Constitution in two ways - one, by claiming that it's balanced when it's not, unless you want to tell everybody on MaineCare you get one year of MaineCare and then after that, no, we're not going to address that. Okay, fine, go ahead and do that. Or secondly, saying that we pass the biennial budget in order to then adjourn, because that is also a constitutional obligation that we are forced to meet in the first session of the biennial. We're not doing really that, either. So, I guess pick one, is my charge to you all in the majority, just pick -- pick what you're going to do, that we're going to really pass a one-year budget, make sure we don't have to listen to the Republicans for the next part of the Legislature, do our own thing, and figure it out later and spend more of the peoples' money later. Go ahead. But don't say that we're -- everything's fine and this is satisfactory, you know, to the average person that's out there. It's not. We're leaving a lot of work on the table here. We're leaving a lot of programs on the table here that people are going to think are safe and they're not. And that was, in fact, our chief concern during the so-called supplemental that we just went through, is that we're not addressing the root of these problems; out of control costs, out of control spending. We still haven't done that. We still haven't done that in this document. In fact, it's been so neglected that we're not even bothering to try in the second year to address these problems. That's what you folks are putting forward tonight. That's what's in front of us. You know, I'm looking at it right now with numerous programs in the second year unfunded.

So, pick a side, you know, make a call, but let's use correct verbiage here. Call it a majority budget, because that's what it is, and explain to people why you're doing what you're doing. And if it's because you don't want to work with us, fine, go ahead, say that. But don't say it's because we need to pass something here to give folks comfort. I think what's uncomfortable for them is that we are heading toward such financial catastrophe, particularly as it relates with MaineCare, with no plan, and that problem is going to get worse and we will be right back here within the year, addressing the same problems. Just acknowledge that you don't want to address it, because that's what you're doing with this. That's what you're doing with this. I know the fix is in, I know how to count, it is what it is, but I would just appreciate like a little bit of transparency as it relates to what is being said about this document, because it is a far, far cry from reality. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Tipping.

Senator **TIPPING:** Thank you, Madam President. I would echo the comments that there is a lot of work to do in part two of the budget, and I hope that all Members engage in that process in good faith. Tonight, however, I rise to speak to an element of the budget that's actually before us, part of the proposal that's important in my community and across rural Maine.

Since our vote last Thursday and the failure of the supplemental budget, I've been meeting with healthcare providers all over my district. The day after the vote, I sat down with the leadership at Penobscot Valley Hospital in Lincoln. Like all critical access hospitals, their MaineCare prospective interim payments were cut by 30% starting last week. Their payment from the State went

from \$85,000 to \$59,000, a \$26,000 a week cut every week until we finally decide to pay our bills. Now, some hospitals may be able to deal with that kind of cut, but PVH is a 25-bed hospital serving a poor, elderly, and rural population. They also recently went through a bankruptcy and so they find it difficult to access credit to bridge the gap. They're looking hard at the services they provide and they're getting quotes from lenders that want 30% interest. They aren't alone. Over the weekend, we learned that the Houlton Regional Hospital is in a similar spot. Their chief financial officer reports that, quote, "if reduced payments continue for just one more week, this may cause HRH to run out of operational funds. This would likely lead us to limit services and staffing without sufficient notice. Once those services and staff are lost, our chances of restoring them would be minimal or even nonexistent." I would imagine many of Maine's critical access hospitals serving people in rural areas that might otherwise have to drive for an hour or more to find an emergency room are also in a similar spot. Calais Regional Hospital also recently went through bankruptcy, and we know how close to the line all of our hospitals are.

Last week, we saw the closure of a hospital in Waterville and on Monday, the Maine Hospital Association reported that several critical access hospitals are considering service cuts or closure because of this curtailment. I urge every Member of this Body to vote for this continuing services budget. A two-thirds vote today will get the money to our rural hospitals before any more damage is done. Even majority passage will mean that they know the money is coming and can borrow against that certainty. Saving the money, keeping doctors and nurses on staff, and almost certainly saving peoples' lives. I believe healthcare, especially access to care for poor people and those in rural Maine, is the most important issue before the Body this term. When we consider the life, liberty, and happiness of Mainers, preserving their lives comes first. We must reject the attempts to cut care, cut Medicaid eligibility, cut direct care worker wages, cut care for the elderly, and cut payments to hospitals no matter where those proposals are coming from.

Now, some of my colleagues have said that they didn't know when Medicaid payments would begin being curtailed or they didn't see anything in the supplemental that was important for their district. I hope that now we all know and hope we now all see. This budget pays our bills, it funds our hospitals, and it protects Maine people. We should pass it as quickly as possible. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Thank you, Madam President, and good evening, Ladies and Gentlemen of the Senate. I stand before you today with a very troubled heart. Yet again, half of Maine's people have been disenfranchised. They've been ignored, they've been tossed in a trash heap on the side of the road. In my 15 years under this dome, serving the Maine people, I'd like to think that I'd seen everything. And yet, the majority party somehow finds some way to surprise me even again.

Madam President, facts matter, and this is madness. No, this has been happening every March, so let's call it the March Majority Madness. And let me tell you some facts, Madam President. I posed a question to this Body last Tuesday when I asked my colleagues from the majority party whether they would push through a majority budget. Well, Madam President, I was met

with silence. We were met again with a stone-cold silence on Thursday, when a good senator from Androscoggin posed the very same question to this Body. Now, it's abundantly clear why nobody from leadership of this majority party chose to answer our question. Madam President, facts matter, and this is March Majority Madness.

Here's another fact, majority leadership and their member of the Appropriation Committee have been working secretly behind closed doors to craft this partisan budget before we had even finished debating the last budget. In fact, the planning for it began on March 5th, a full week before we even took the first vote on this supplemental. Madam President, facts matter. And yes, we are in March Majority Madness.

Here's another fact, while my Democrat colleagues claim this bill is a slimmed down continued service budget, that is simply not true. A budget that includes new initiatives is not a baseline budget. This is, in fact, the biennial budget that has over \$11.3 billion in spending that will have to be paid for by the Maine taxpayers. The next budget will simply be a supplemental change package put out by the Governor. That means that both budgets are owned by the majority. As the old adage goes, you reap what you sow. Those, Madam President, are the facts. And we are, in fact, living in the March Majority Madness.

Here are some more facts, Madam President. Like the previous budget bill that was brought before this Body, this budget does nothing to address MaineCare's serious shortfalls. It does nothing to address our General Assistance crisis. It continues funding the Office of New Mainers while it ignores the funding for our old Mainers in our veterans homes, in our nursing homes. That, Madam President, is a fact, and further proof of the March Majority Madness.

Let's talk about the facts about MaineCare. \$33 million raided from the MaineCare Stabilization Fund, \$117 million in the supplemental, \$122 million in the new budget, and the federal match of a billion dollars or more, we have a billion-dollar federal-state problem with no solution. Well, Madam President, facts matter, and that's certainly March Majority Madness.

Here's another fact. This budget still leaves MaineCare with a \$122 million shortfall for fiscal year '27. How are we even going to fund that if we have a negative revenue forecast in May? That is why budgets should never be done this early. We spend more time cleaning up aisle five in the State House than we actually do governing. Madam President, facts matter, and we need to get out of this insanity of March Majority Madness.

The fact of the matter is, I thought we left all this madness behind in the last Legislature. But the monkey business by the majority continues on. In March Majority Madness, to surprise the Appropriations Committee six days ago on Friday afternoon that this budget was going to be voted on. It's March Majority Madness and the budget was not posted until yesterday. It's March Majority Madness that we were given only hours to submit floor amendments. It's March Majority Madness that this whole process was pre-planned to exclude Republicans entirely. It's March Madness that the Democrats refuse to recognize that we cannot continue on this path of reckless spending. We simply don't have the revenue for the budget to continue growing at this rate. It's March Majority Madness that it's slimmed down, the budget still contains over \$11.3 billion in expenditures and they're still looking to spend \$300 million more. That is because, Madam President, the history as written here today in this Chamber will only show that Maine's people are truly living in the age of March Majority Madness, and that should be shameful for all of us in this

building. Thank you very much.

**THE PRESIDENT:** The Chair would recognize the Senator from Cumberland, Senator Pierce.

Senator **PIERCE:** Thank you, Madam President, Colleagues of the Senate. This continuing service budget ensures that the towns we represent have the financial security they deserve and that the members of our communities will continue to see their roads plowed, trash collected, and school buses running. I served on my local town council from 2008 to 2014, during the great recession. We had to balance our books, keep services in schools going, and be very mindful of our property taxes. It was difficult, but we managed to get it done and keep our promises to our constituents. Those decisions at that town level are typically being made right now during February and March. So, now is the time for the State to deliver certainty and predictability to our communities. In order to do so, we must keep our commitments to the State's 55% share of K-12 education and 5% revenue sharing. This continuing service budget does just that. For those of us who have served on a town council or a city council, and many of us have in this room, we know what schoolboards and municipalities go through as they think about passing responsible budgets in the year ahead. A continuing service budget helps schoolboards and towns and cities craft their budgets secure with the knowledge of what funding they will receive from the State. Today, we have the opportunity to honor our commitments by funding the essential services local governments deliver to Mainers every day. This is a responsible, no-frills type of budget. It's about paying our bills, keeping on the lights, and keeping promises to our communities. In this budget, no new services or initiatives have been added. Rather, we are making sure critical services can operate. As the Good Senator from Androscoggin outlined, this step allows the Legislature to get to work on the part two budget that embodies the priorities of Maine people in 2025. It gives us space and time to debate those priorities. I'm committed to that process and have done that work in the past. Madam President, I urge this Body to do the right thing for Maine and for Mainers. I ask you and all my fellow Senators to support this continuing services budget. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY:** Thank you very much, Madam Chair. Back in 2019, the Governor issued a very prideful press release taking credit for the MaineCare expansion that was to come. And I just remember holding my breath because I just really felt at the time that people didn't really understand the system that we were about to take on. And I want to just explain that the system that we are in now is what's causing closures and bankruptcies of providers. And we don't have a lot of time to do something about that. I do appreciate the Senator from Androscoggin who says, you know, we can look at some policy changes down the road. Thank you for that offer, I intend to take you up on that, but I know as a member of the Joint Standing Committee on Education and Cultural Affairs that the new initiatives that we're talking about there are being completely swallowed up by the welfare state. And everyone on the committee, not Republicans, everyone on the committee is looking at bills and saying oh, this bill's not going

to get funded. Even if it's like a very important idea. So, the system that expands the enrollees, the MaineCare enrollees from 290,000 or so to 405,000, more Mainers get treatment from hospitals and other providers at a loss to those providers. So, as you -- this is the model. As you expand the model, as you expand the people getting those services, you're at the MaineCare Medicaid rate of reimbursement. So, the problem gets worse and worse and worse as you conduct the expansion. And, you know, most of you know, I work in Waterville and, you know, do a lot of work for the mid-Maine Chamber on their policy committee and I mean, everybody showed up at Northern Light and they knew it was coming for a long time. It's not something that -- a hole that we can plug now, they knew it was coming, and it was coming because of just what I'm talking about, the system. You got the MaineCare reimbursement rate, but then you also have systemic slow payments to hospitals, so now they're owed millions. And you know they're owed millions, they came and they've told you that, I'm sure they've told you that. So, I wish that we had that same emergency feeling that I was given when I walked in here for the first time in the 131st and, you know, let's -- let's do something about home heating. This is a serious emergency; we're talking about hospital care. We need to take care of it now. You know, this may not be the day we're going to take care of it, but it needs to be addressed right now. The other thing, you know, I've been kind of wondering all along how are -- in year two of the biennial budget, how are we going to be able to project the losses that -- not losses, but the costs that are going to get racked up as a result of the system that I just described. And so far, I guess, thank God it's blank we're going to have to fill something in here. And it's not just going to be expenditures that's going to be able to solve the problem, you have to look at the cost side. There's a cost side and a revenue side to every single picture, and we've got to look at the cost side, and we've got to do it in the most humane way possible, the most humane way possible. You know, I've been thinking about, you know, what can I compare this to in my lifetime, and I've been here six different terms, and I couldn't think of anything in my lifetime. The only thing I could think about is going back to 1912 and thinking about the Titanic, you know, it's kind of like bailing out the Titanic with a bucket but there's no base in the bucket, so nothing's really happening. We've got to put a base in the bucket, we've got to be able to -- we do have to -- the wrong word, but we've got to be able to bail out the MaineCare system. We have to do something about GA because as I explained to you last week, my rural district is getting nothing out of these GA proposals at all, it's just really brutal. It's tough on my district. I did give a speech this Monday night in Cornish, and I asked them what their GA budget was, and it was \$2,000, and you know how much that takes care of. So, boy, do we have a lot of pending problems here. I'm concerned about the way I'm seeing the process roll out and I do -- I ask you to join me in voting against this motion, but I also ask you to join me in trying to solve especially the MaineCare problem because we can't leave this Legislature without doing that. And it's a much larger number than I think we can all imagine as we sit here. Thank you, Madam President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE**: Thank you, Madam President, Men and Women of the Senate. Down in DC, they are passing a majority budget. I have not heard a single person in this Chamber get up and decry how nearly a majority of Americans are being disenfranchised because of that. They're passing a majority budget. That's what they do. In New Hampshire, they're doing it, in Maryland, they're doing it, in Michigan, they're doing it, in Wyoming, Texas, Oklahoma, every other single state in this country is doing this that way, and the federal government. In fact, in municipalities, they're doing it by a majority vote. That's how they pass their budget. When you go to town meetings, they don't ask for a two-thirds vote in order to pass a budget, they get a majority vote. That's how democracies do it. And I have to disagree with my good friend from Aroostook, Senator Stewart. It was never intended by the Maine people that our budgets be passed by a two-thirds vote. The Maine people never decided that. It was a fluke of our Constitution where in 1914 that amendment was passed that requires bills unless they're passed by a two-thirds vote to have 90 days to go into effect for a peoples' veto, and then later, many decades later, the State at the request of municipal governments, changed its fiscal year from October to July, taking away that 90-day period. And nobody thought that was a problem. Legislature after Legislature after Legislature passed a majority budget like this or a supermajority budget of continuing funding and then went on to debate part two of the budget of where to decrease and where to increase things. That was done by every Legislature. And I know, I was in many of them, all the way up to the 1990s, when a governor was reelected who said everything was fine with our budget and the day after his election, he announced a \$2 billion shortfall in the budget and everything went crazy here in Augusta. And 13 members of this Body found a way to have 13 out of 186 elected legislators, 13 stopped state government in its tracks and they locked out thousands of Maine State employees who were camped out across the street, they shut down liquor stores, they shut down our state parks, they shut down everything except emergency measures in the state government. That was the tyranny of the minority. In fact, you could call it July Minority Madness.

Once that political nuclear bomb was exploded in this Capitol, we have never been the same since, and we have tried to do things to keep things running here in Maine. So, we have had to improvise a procedural solution to do everything -- the things that every other state and the federal government does in this country in order to protect Maine people from July Minority Madness. And it's worked fairly well, we've been able to do it sometimes, sometimes we haven't, it's gone on until 2017, we saw it again. It was let out of the bag again. Fifty-one members over in the House forced the shutdown of state government after July 1st, under the LePage Administration, and we went into another shutdown mode. Because we stopped using those measures to protect Maine people.

This is what this is all about. It's about protecting Maine people from July Minority Madness. It's talking about protecting Maine people from a small group of people shutting down state government. That's not what Maine people want. If you want to talk about disenfranchisement, you talk about a group of one-third of one of this Body ignoring what everybody else wants. That is disenfranchisement of the Maine people.

Now, I'm happy to join with you in doing what responsible Legislatures have done in the past, what responsible statemen

and statewomen have done in the past and pass a continuing resolution by a two-thirds vote and then negotiate with you on the second part. And I said I'm more than willing to do that to see if we can get to two-thirds and to see if we can't get an agreement. I guarantee you they're not going to do that in Washington. They're going to ignore a near majority of Americans who elected Democrats to Congress and not negotiate with them, but I'm willing to do it here. But the first thing we have to do is to protect Maine people, and that's what we're doing here today. Thank you, Madam President.

**THE PRESIDENT**: The Chair recognizes the Senator from Sagadahoc, Senator Tepler.

Senator **TEPLER**: Thank you, Mr. Speaker. Madam Speaker and ladies and gentlemen of this Chamber, I am new in this Chamber, but I spent eight years in the Other Body and four years as House Chair of Health Coverage, Insurance, and Financial Services. And I remember when our hospitals were begging us to expand MaineCare because charity care was an excessive burden on their budgets. If we cut the MaineCare population, we will be right back there. It will not save our hospitals; it will simply send them under faster.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madam President, Fellow Members of the Senate. I was moved to rise by - as I often am - by my friend and seatmate, former President of the Senate, the Senator from York, Senator Lawrence. My problem with this budget isn't that it is a majority budget. In fact, I think we think about these things in partisan terms far too much. I object to this budget because it represents a dramatic failure of the Legislature to do its job.

We haven't organized ourselves to even consider this budget properly. In fact, a very small -- very small percentage of this 407-page budget, 11.some-odd billion dollars, an eight-page fiscal note, never even had a public hearing. Think about that. Here it is the middle of March, this budget is before us, and we have organized ourselves not to even be able to have the time to have a public hearing on the vast majority of the spending this represents. And this is at a time when we all know that we -- the gravy train is over, the feds are shutting off the pipe, that we're going to have to make some tough choices here. And this last two and a half months should have been an opportunity to do that.

The people of Maine who are affected by our budgets have a right to speak on the billions of dollars that is spent for services and for the programs and all the agencies. They have a right to be heard on that. They haven't had a chance to speak at all on the lion's share of this budget. Questions are -- are these programs and agencies serving the modern needs of the people of Maine? Are these billions of dollars well spent? What do the people of Maine actually think about the efficacy of these billions of dollars they're spending? We haven't heard from them. That is my problem with this budget. It is profoundly sad and a dereliction of duty for us to, at this time of fiscal crisis, to be without a public hearing, spending billions of dollars of taxpayers' money.

And now, I have a measure that is working its way through this Legislature somewhere to take a new look at this, and it will come up and we'll be talking about that, and it's really a resolve to

actually study this problem that the Senator from York, Senator Lawrence, talked about, which is the majority party has the burden of governing. I get that, and I get the fact that there's a need to pass a budget, and whoever the minority is, they want to preserve the optionality of objecting to that. And our current calendar of legislative work fails both ends because it tells the majority that they have to rush in order to pass a budget and it tells the minority that they either get accused of shutting down state government or they have to go along with what the majority says. This isn't a good conversation to have. This is a failure of ourselves, this institution, to organize ourselves so that we can actually consider the needs of the people of Maine, hear from the people of Maine, take their views into consideration, spend their money wisely, in benefit of the people in need across the state. So, for those reasons, Madam President, I sadly have to vote against this budget because we need to do better, we must do better, this institution deserves better, and the people of Maine deserve better. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator **BALDACC**: Thank you, Madam President. I just want to hit a couple of points. One is I'm very disappointed with the harsh and negative rhetoric that I've heard from certain quarters tonight. The fact of the matter is, I'm concerned, you know, where our Republican friends have been the last couple of months. I feel like some of them have been sleepwalking through this budget process. I feel like they -- I understand you can object, but at some point, a decision has to be made, priorities have to be set, people have to be paid, services have to be provided. This isn't -- this can't be an interminable discussion. And the last two months, we've spent an interminable amount of time trying to work out a compromise. We agreed to what a certain house GOP member, leader, said was the most significant welfare reform in over a decade, which was the housing limitations. We agreed to have an outside audit of the MaineCare program. And that was for a supplemental budget that didn't raise taxes, that just paid bills, and the money came out of an existing surplus. So, it's -- at some point, people have to make decisions.

I got calls every day, I got letters every day from parents of disabled children, from senior citizens, from people that work at the hospitals in Bangor or from medical providers, wondering what was going to happen to their child, their job, their family. We can talk all we want, we can, you know, think that we're trying to solve some great constitutional crisis, it's only a crisis that we -- that certain Members have manufactured, and we are here tonight to prevent a crisis to get -- to make sure things get paid, things get done, and this state moves forward. That's what we're here for and that's what I got elected for and I think most of us did.

So, in terms of this budget, the actual facts of this budget, this budget is a big win for my district and for the vast majority of districts here. And my focus was going to be on the local part of this, but I had to -- I really had to comment on the direction. Because I don't believe in wasting peoples' time. I believe in using time effectively and not just making points but getting things done. For Bangor and Hermon, revenue sharing, which is already more than doubled over the last four years, will rise an additional \$1.25 million. Money that is critical to fund police, fire, schools, infrastructure, and economic development projects. The

Town of Hermon will see further increases in revenue sharing of more than 10%, bringing their total to \$810,000 per year. Public schools in Bangor and Hermon will also greatly benefit. Combined, Bangor and Hermon serve over 6,000 students. The aid to education - that I had my notes here someplace - and Bangor public schools receive an additional \$2 million, bringing the total aid to education for Bangor to \$28.2 million, and to the town of Hermon will get an additional \$400,000, bringing the total to Hermon schools to \$9.2 million a year.

I often -- I served four terms on the Bangor city council, I served twice as mayor, and I often told people during LePage Administration, aid to education for Bangor went from \$17 million and at the end of the LePage Administration, it was still \$17 million. Okay? And in that time, costs and everything grew. They shifted more of the burden in terms of teacher retirement, public schools onto the municipalities. We had to deal with that firsthand. We had to lay off people, we had to trim, obviously, but the bottom line is we did that for eight years. What we're trying to do is not burden our local communities with these tough decisions.

My district, there's a total of \$3.9 billion per year in MaineCare spending. Per year in MaineCare spending or funding in this budget. A third of that is state money, the other two-thirds are federal matching dollars. My district has more than 5,000 healthcare sector jobs. Hospitals will be paid, nursing homes will get paid, healthcare providers will get paid. I can't say enough about how important it is to pass this budget. I think it will benefit the State of Maine. But the fact is that a certain point, and we have invested in bipartisan cooperation, but at some point, you reach a point, you have to make a decision and you have to protect your constituents and your taxpayers, the people of this state, and that is what we are doing tonight.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Ingwersen.

Senator **INGWERSEN**: Thank you, Madam President. Madam President, I'm going to narrowly talk about a part of this budget that I've been concerned about since January, since we got here, and that's MaineCare. Through the supplemental budget, through several weeks of work and negotiation, it was for me learning about what is this state health plan that so many people depend on and so many providers depend on. And I've learned a lot and I've got a lot more to learn.

So, MaineCare is a critical safety net. Talk about ongoing necessity funding. That's what we have. That's what's going to be in this budget. It's a critical safety net for low-income Mainers, many of them working Mainers. For children, for the elderly, for the disabled, it's health insurance coverage for low-income Mainers and enables access, it improves overall health and wellbeing while supporting our economy. That's some of what I've discovered.

And I want to respond a little bit to my neighbor here and fellow Senator from Cumberland who mentioned that the expansion population is a problem. It's a good thing that we did. And it wasn't done by just the Governor. In 2017, Maine had the opportunity, like all states, under the Affordable Care Act, to expand MaineCare. We took that opportunity, like states did, but first we held a referendum and 60% of Mainers came out and said yes, we want to do this.

So, what is this expansion population? These are working adults. These are low-income adults who have to meet 138% or less of

the federal poverty level. That's \$21,000 a year for a single adult, or \$29,000 a year for a two-family of adults. At \$21,000 a year, these are not bums, these are working Mainers. I'm sorry to use the words bums, but this is what I get from some constituents, that these are just lazy people living off the state. These are our working Mainers. Who are these people? Well, that's another thing I've learned, studying MaineCare and listening in my committee about who these working Mainers are. They are our childcare workers, they are our direct care workers, they are our ed techs, our preschool workers, they are workers who are advocates for sexual assault services, who have been losing 37% of their workforce last year because of low pay. So, here we are, in this Body, willing -- perfectly willing to depend on them to look after our children, to look after our parents, to look after our grandparents in nursing homes, who are perfectly willing to accept that we can't do anything about the minimum wage they get, but we don't want to give them basic healthcare, we don't think they should be part of this expansion population. Who would we remove from those roles? I certainly wouldn't remove the low-income working Mainers in my community who depend on quality healthcare. Healthcare that allows them to get up the next morning and go to work for us, to support our children, to support our grandparents, to support our families so that we can get and hold jobs that may be a little bit high-paying, a little bit more pay. And remember, this is healthcare, this expansion healthcare that's paid 90% by the federal government. Yes, that may be in trouble, and we hope it isn't, but this has been a program that's been agreed upon by the federal government, that has rules we have to adhere to. We can't make a hasty decision to go ahead and drop people from those roles. This is an emergency. These are our neighbors. 45% of our neighbors in northern counties such as Washington, 40% in Arostook and Piscataquis County. These are our neighbors, our families, our kids, our disabled, our elderly. This is our lifeblood, and we are here tonight to support them. And I hope you will, too. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Talbot Ross.

Senator **TALBOT ROSS:** Thank you, Madam President. You know, I am also new to this Chamber, and I can honestly say that I have appreciated all of the comments from both sides of the aisle that have been made this evening -- well, except for saying that I and my colleagues have somehow faked interest in transparency, but I had to rise to make it clear that if we do not pass this budget - and that's the collective we - Maine people lose. That's all of Maine people, not just the people in my district or yours, Madam President, that's all of Maine people. You know, I do not believe that anyone here thinks that this is a game but it sure does feel like we're playing one. We're playing one that has dire and dreadful consequences that Maine people cannot afford. Needing to access healthcare and have healthcare facilities open is not just to serve Democrats and keep Democrats healthy. Needing property tax relief is not just for Democratic households. Needing schools to stay open and funded is not just to serve Democratic students. And critically important, not passing this budget -- not passing this budget simply kicks the can down the curb and will force our cities and town as they try to make their budgets whole and they try to make plans for the future, worse. This is not about Democrats or Republicans. This is about all Maine people. We all lose if we do not pass this budget tonight.

Let's keep Mainers safe and healthy and educated. Let's make sure that we pass this budget because without this budget, Mainers - all of Mainers - lose. Thank you, Madam President.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Bickford.

Senator **BICKFORD:** Thank you, Madam President. Madam President, a week ago, I asked a question. I asked it on three separate occasions to you and your leadership, will you commit to a two-thirds budget? I was met with silence. So, tonight, I'm going to remind you of something I learned when I was very young. Actions speak much louder than words.

**THE PRESIDENT:** The Chair would remind Members that as the Chair, in debate, the Chair can only answer questions about Parliamentary procedure. With that, the Chair would recognize the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Madam President, Ladies and Gentlemen of the Senate. I hear everybody's voice here. I came back in 2014 -- well, actually '13, I think it was, or -- 11 years ago. When I came here, when we were doing a budget, it was dealt a lot different than it is today. And when I said that, you know, there was 200 years and it was only twice that they did not do a two-thirds vote, when I came here, I could see how it worked. And what they did is they looked at what they did the previous budget and where they were now and they looked at how they could balance the budget so it wasn't going to be impacting the state to the point where it was going to cost them more money and taxes. And somewhere, they met and what they did is I can remember every -- everybody had a chalkboard and they had all the important bills listed right down through and said where can we do -- come up with a way to meet that budget? And it was like everybody worked together on both sides, trying to meet that budget. I have not seen that in the last six years. And that's what's happening. It's not -- I don't think it has to do with majority or minority, it's how our processes work as far as trying to make the budget work for the State. And that's what I think is lacking. I think if you had just taken line by line items, Madam President, that if we could just go through and say look, this is where we want to be, and then you hear it from the other side, this is where we want to be, and then try to meet halfway, I think that's how we got that two-thirds vote, just like we have for 200 years. But it hasn't happened that way, and now this is where we are. And I don't think any one of us likes to vote against each other. You know, I listen to all my friends here, that's not the case, I just think it's -- our mannerism on how we meet a balanced budget. That's all I'm saying is I think maybe we've got to look -- re-look at how we're doing it and put it on a chalkboard or something that we can just say look, this is where we're at and this is where the other group is at and let's see how we can meet that to get that balanced budget so it works for everyone. And we should've done that a long time ago, you know, earlier, and that hasn't happened. So, I'm just asking if that's something, if it's too late, maybe it isn't, but I'd like to see that happen. Thank you, Madam President.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO**: Thank you, Madam President. As my friend and colleague from Androscoggin County, Senator Timberlake, said, facts matter. And there are just a few things that I want to clear up because I would hate to have anybody listening to these proceedings tonight think that we are abandoning MaineCare in the second year of the biennium.

The State -- the baseline budget has \$1.3 billion in it for MaineCare for fiscal year '26 and fiscal year '27, \$1.3 billion for each of those years. We have a significant federal match which brings in more billions. We also have a state increase of 63 million for the Federal Medicaid Assistance Percentage, which is referred to as FMAP. So, there are billions of dollars for MaineCare in fiscal year '26 and '27 and it's just very important for me to make sure that people in nursing homes, in families where people are depending upon MaineCare, for hospitals, for providers, to know that we are not abandoning anyone with regard to MaineCare funding. We have billions in the continuing services budget and we will make sure that our responsibilities to fund MaineCare are met. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Harrington.

Senator **HARRINGTON**: Thank you, Madam President. I think it's important for the people at home to know exactly the process that this budget was crafted in. This budget was crafted in partisan-only backroom meetings and then was dropped on the laps of Republican appropriators late in the afternoon on Friday, only to immediately go in and start voting on it, and then being told - also that night, after the majority budget was passed - that they were not able to put a Minority Report on said budget unless they were prepared to do it right then, they couldn't come back the following day or have a couple of days to draft their own Minority Report. So, that's where we are, a backroom budget that was thrown onto the people of Maine and we're expected to now just vote on it.

So, I would encourage, when we go back into our backrooms to start drafting the part two budget, that I would strongly encourage that you take the zero dollars allocated for fiscal year 2027 for MaineCare, and I would add quite a bit extra so that you're not then coming back to us next year when you fail to do anything on Medicaid and you're in a bigger hole, asking us to bail you out of yet a third in a row failed budget. That would be my request. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY**: Thank you, Madam President. I know that we're getting ready to vote, but I just thought it was really important for us to focus not on perceived slights from each other, treating each other in certain ways, but really to think about what the vote we're taking - about to take - relates to. And it relates to protecting the people of Maine.

And I just want to point out from my vantage point in the Judiciary Committee what the continuing services budget will do. Here are just a couple of the things. It will keep children's advocacy centers open. So, those are the centers that enable prosecutors to achieve convictions of people who have sexually assaulted children. It funds the prosecutors who the children advocacy centers work with, who use their incredible skill and passion to achieve convictions in those cases. It also - I know this morning

we voted on a bill related to the Office of the Chief Medical Examiner, actually, two of them - it also allows the Office of the Chief Medical Examiner, which works with great compassion also, and the Attorney General's office to investigate and prosecute murder cases. Are we really not going to continue to fund those services? Do we not care that the people of Maine need that work done? I just ask us to think about the people we all represent. Thank you.

**THE PRESIDENT**: The pending question before the Senate is Acceptance of the Majority Ought to Pass as Amended Report. A roll call has been ordered. Is the Senate ready for the question?

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
