**JOINT RESOLUTION  
RECOGNIZING APRIL 2023  
AS SEXUAL ASSAULT AWARENESS MONTH**

WHEREAS, sexual assault affects all communities in Maine and people of all races, genders and economic backgrounds, and over 14,000 people in Maine are sexually assaulted each year and one in 5 Maine citizens will experience sexual violence in their lifetimes; and

WHEREAS, the effects of sexual violence have wide-ranging public health ramifications and societal costs, and survivors and their loved ones can experience consequences including mental health crises, substance use disorder, homelessness, lost wages and health care costs, among others; and

WHEREAS, sexual violence affects certain groups more often, and that disproportionate impact is related to historical experiences of marginalization and oppression, providing the evidence that sexual assault is a tool of control and power; and

WHEREAS, systems of support for survivors of sexual assault often have inadequate resources, do not provide adequate options for justice and healing and retraumatize survivors; and

WHEREAS, widespread stigma and misconceptions around sexual violence result in low rates of reporting of crimes, increased isolation and shame for victims and the continuation of cultures of violence; and

WHEREAS, raising awareness in our communities about the causes of and solutions to sexual violence can lead to long-term positive cultural and systemic changes, and building a future free from sexual violence requires us to commit to making those changes; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to recognize April 2023 as Sexual Assault Awareness Month and to express our support for and encouragement of all those affected by sexual violence; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Maine Coalition Against Sexual Assault as a token of our respect and support.

**THE PRESIDENT**: I believe because it was a House Resolution, it was presented there, so it's just on our calendar, yep. That's fine.

Senator **STEWART**: My bad. We were confused up in the corner here. That's our bad, so, sorry about that.

**THE PRESIDENT**: So, we're on 1-20, the Joint Resolution recognizing April '23 as Sexual Assault Awareness Month, and it came down from the House, and the Chair recognizes the Senator from Cumberland, Senator Duson.

Senator **DUSON**: Thank you, Mr. President, and thank you, Senator, I appreciate the - we all know I'm relatively new to this, so. I just have a few comments on the Resolution. I would like to remind that April is Sexual Assault Awareness Month. One in five Maine adults have reported they've been the victim of sexual assault or attempted sexual assault at some point in their lives. People in Maine can call or text at 1-800-871-7741 to get help or advice in the event of being aware of, being a victim of, or being aware of someone who's a victim of this kind of behavior. Nationally, the CDC reports that more than one in three women and nearly one in four men have experienced sexual violence at some point in their lives. A majority of sexual assault victims report that they knew their attacker. I wanted to rise today and ask that our - that folks join me in being that person who if you see something, you say something. If something seems out of sort, you ask someone if they're okay. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE:** Thank you, Mr. President, Men and Women of the Senate. I request to address the Senate on the record.

**THE PRESIDENT:** So moved.

Senator **LAWRENCE:** Thank you, Mr. President. And on a more somber note, I've spoken before, years ago, on this anniversary in the Senate, but I just wanted to note that this week is 60 years ago today when the USS Thresher was lost off the coast of Kittery. The USS Thresher was built - designed and built at the Portsmouth Naval Shipyard. It was a class of submarine well ahead of its class, the technology on it was far in advance. And as usual on test runs - it was three years after its christening - and as usual on test runs, it carried not only the sailors onboard, who I believe numbered 122, but it carried 13 workers from the shipyard who were going out to participate in the test, participate in the diagnostics of what was going on, and four additional people from contractors like Sperry and other companies. When it went out off the coast, it went into a deep dive and was unable to right itself and imploded under the water, losing all 129 members. So, I just add this this week that we keep them in their memory, the families in their memory, many of who still live in the town of Kittery and who lost parents. I know families who lost parents, friends of mine from high school who lost their parents in that tragedy, and I ask you to keep them in your minds this week. Thank you.
